JA confirmed if MR wanted people named, and he suggested to do as teams, so that they have a number of people to select from should they have to attend in place of PM.	
Tops – MR advised that the TM's & Coaches had been advised what will happen and the clothing will be ordered ASAP, MR confirmed that any committee member that requires clothing to make it aware and they will be added to the order. JA suggested that the committee have the same tops, with the wording " Committee" on the top, so that when they are there as a committee member and not representing their teams, then the public will know who we are, this was agreed by all that was present. Coach Co-Ordinators Role, Coach & Player development, Officer, Mental Health Officer for each team – MR confirmed that this is ongoing, once we have people in the roles, this will be one of the first things assigned to them.	
JA suggested that Hayley Owen, could take on more work, especially work that relates to a CWO/CWL i.e., all the work relating to the TM's, Coaches and Volunteers, is a CWO's job, and should be undertaken by Hayley and not PM. This will release PM to do the work that a secretary should be doing.	PM to collate all information that can be passed over to HO.
Everyone present agreed that this work should be passed to HO, MR to speak to HO, of how she can take this over going forward.	MR to speak to HO re extra work to be passed to her.
Home fixture to be changed for the 23/24 <sup>th</sup> July – PM confirmed that the U13-U15's final fixture is the week ending 17 <sup>th</sup> July, so no fixture changes required.	
Road Map for splitting Teams – MR confirmed that there are a few problems, with this splitting, this will be revisited during the season, this may now not be written into the constitution until MT & Paul Matthews have seen how it runs this season.	
First Aid Courses – MS booked course and they have been completed.	
Pre-Season and Match day tick list of what TM's should have in place ready for the start of the season and on Match days. JA advised that we looked at doing an "Idiots Guide" to starting a team.	KR to complete tick lists and post to Spond, he will also do an "Idiots Guide" for the splitting of the U7's
Vests & Bucket Hats – KR confirmed that he has not had a response back, MR asked to take over this as he will discuss with O'Neill's, as he is looking into a Winter and Summer Training bundle to come out at the right times of years.	MR to converse with O'Neill's
Advertising for Newbies and U7's – MR said that this was not required immediately, until they have a couple of games under their way.	
Auditing of Accounts and Cashbooks – JA confirmed that she has passed the spreadsheets used by her to 3 teams, and has suggested that they contact her ASAP to run through them with her. JA advised that we need to be starting to checking these ASAP. JA suggested that we run the meetings on a Monday night and each team has

	a 30 minute appointment, per team to run through them. MR suggested booking these in on the next date of the TM/Coach meeting, instead of a group meeting.	
	Cleaning up of Spond – MR confirmed that he has started to remove people, it was confirmed that this is part of a CWO/CWL role, as these people should not be on there if they are not a part of the club.	HO to remove people no longer involved with the club and edit their profiles to the correct information.
4.	NWC Meeting:	
	Discipline has been discussed with TM, along with Social Media, it has been brought to our attention, that teams should not be "Gloating" on social media if there is a large score difference, also teams U12's down, should not be putting out on Social Media, it can be used in a "Private/Closed Group" but must not be shared, if it has shared via a screen shot, then the manager of that team has to deal with it. Discipline: We have had 2 cases one for the use of foul language and one that has been classed as a brawl, which has been contested. PM has advised all TM's present at their meeting of how to deal with this

5.	Code of Conduct: PM has a code of conduct to go out, this will be added to committee page to see if any amendments are required before sending out. JA asked when would the electronic Membership forms be completed? PM said that he will get them sent out by the end of the week.	
6.	Woolston Rovers Membership and RFL Membership: PM confirmed that the RFL Invoice was a nightmare as they could not get the number of players correct, they had more players than we had. PM advised that he will follow up with the RFL to see how those parents that may not be able to pay, how they apply to be exempt. Woolston Rovers Memberships – JA confirmed all now completed, and email has been sent to Monk with the names of the players who require memberships, she is now awaiting the invoice from Monk. Outstanding Invoices – MR confirmed that he addressed in the TM/Coaches meeting, that we will not accept part payment of invoices, and they have to be paid in full and in a timely manner, i.e. by the date on the invoice.	PM to contact RFL to see how a player who cannot afford to pay, how they apply to be exempt.
7.	How to deal with players who have signed for the team,	
	and decide not to play: MR confirmed that a team had a player who has been charged the RFL membership, the child has not trained all through the winter, but the parents signed him on.	

	The team did not feel it was right to chase the parent for the payment so where do we stand as a committee, do we chase the parent, on the teams behalf, the committee agreed that it would have to be the team that contact the parents, as the committee did not take the player on, the agreement is between the team and the parent(s). Woolston Membership – MR advised that if a player signs onto TG then the player is responsible for the Woolston Membership, the teams are responsible for collecting that fee from the players when the cost is announced yearly at the AGM. MR advised any team that refuses to pay for the membership, then their fixtures will be frozen.	MR will email the parents concerned from the Chairs email address with an invoice from the team, trying to recoup the funds on the teams behalf.
8.	After Match Food – MR confirmed that all TM/Coaches have been advised that the request for food is to go through EH, by DM or email. JA asked would it be possible to raise an event on Spond that they reply on there so it can easily be found by the teams and EH, EH said she would look into this.	
9.	Use of JA's personal Credit Card PM wanted it documenting that JA has had to use her personal credit card for the purchase of the Stefan Ratchford Testimonial Tickets, as the clubs debit card had not come through. MR confirmed that he was happy with this, and he had supplied JA with an email authorising for this to be done. JA confirmed that the club card has now arrived.
