Dear Club Member

All nominations need to be submitted in writing (either via post or email) – nominations will not be accepted via SMS/text message, WhatsApp message or Facebook message. Any postal nominations should be signed by both a proposer and a seconder. Any proposals via email should come with separate emails from the person proposing and the person seconding the nomination. You can also not propose or second your own nomination for one of the above posts.

All nominations must be received no later than midnight on Wednesday 27 January 2021. Any nominations received after this time will be carried forward to the 2022 AGM.

All voting will be carried out via polls within the Zoom meeting. As normal, all senior playing members and life members are eligible to vote. There are no voting rights for 100 Club members or junior players, although they are more than welcome to contribute to the discussions at the AGM.
