### VOLUNTEERS:

We are starting to find that some volunteers are returning on a limited basis. Safe practice of work to be followed with the use of PPE if required. Social distancing and help and advice to support this will be provided.

### FACILITIES:

To remain closed until spectators are allowed to return.

A one way system with separate entrance and exit and appropriate signage planned on reopening Perspex guards on the bar to protect staff and appropriate PPE to be provided.

Seating to be arranged to allow for social distancing.

Regulate entry to avoid overcrowding risk.

Records of all staff, customers and visitors to be kept for Test & Trace.

### REFRESHMENT KIOSK

To remain closed until spectators are allowed to return.

A one way queuing system with appropriate signage to allow for social distancing.

Perspex guards on servery to protect staff and appropriate PPE to be provided.

### HOSPITALITY

To remain closed until spectators are allowed to return.

Social distancing to be maintained with appropriate setting out of tables and chairs.

Signage for guidance.

TOILETS

To remain closed until spectators are allowed to return EXCEPT for those needed for friendly games.

Signage is planned for guidance to allow for social distancing in these areas.

Additional cleaning and checks to ensure consumables are adequately stocked.

## **CLEANING**

Our regular cleaning programme will be extended to allow for extra precautions needed with the risk from the transfer of the virus.

Particular attention to be given to high contact touch points.

Cleaning materials to be monitored as more will be required during this time .

### **EMERGENCY & FIRE SAFETY**

In an emergency social distances may be compromised but expected to maintain safety.
