

# **Captain & Officials Duties**

- The Nominated point of contact for the day will be made known to both teams prior to match.
- Ensure all players are fit and free of any symptoms pre, during and post-match.
- Liaise with Groundsman (James Wade) to confirm which pitch their game is being played on.
- Ensure stumps are wiped with anti-bac wipes (provided) pre and post match.
- Direct players to safe access areas for water.
- Ensure all match day rules are enforced AT ALL TIMES.
- Playing & spectator areas are left clean and tidy, free of all rubbish.
- If moving sightscreens/covers is required, please ensure all individuals do this at a safe distance and hands are thoroughly washed with soap/anti-bac afterwards.
- Encourage spectators to observe social distancing (in line with government advice) at all times.
- Maintains overall control of the day, including player and spectator safety.
- Collect Contact Details for ALL opposition teams This information should be sent to Sean Burke (burkes131@gmail.com)
- Ensure First Aid kits including facemasks and gloves are available and a nominated first aider(s) is appointed.

## Match Day Rules (for players)

#### **OFF Field**

- The Changing Rooms will only be open for access to toilets & as a private space. 1 Person maximum at any time.
- The use of showers is **NOT ALLOWED.**
- Outside Area to be provided for Home & Away teams. This will be clearly marked & distancing must be followed
- Players must provide own refreshments.
- Drinks breaks will be taken but the players will leave the field and use their own water bottles, which are clearly labelled.
- No handshakes/physical contact before, during or post match.
- Any player/official showing any symptoms of Covid-19 48 hours before the game should immediately withdraw from the match.
- Any player/official showing any symptoms of Covid-19 during the game will be immediately withdrawn from the match.
- Players should ensure they are washing hands and equipment at regular intervals.

## **ON Field**

- Fielders must maintain a 1m distance (including keeper & slip fielders).
- Hand Sanitiser to be used at regular intervals (minimum 6 overs) **Individuals should have access to their own sanitizer.** Club will provide additional sanitizer. Players are advised to sanitize hands every time they field the hall
- Keepers & Fielders to pass the ball directly back to the bowler (where possible).
- The Wicket keeper will maintain a 1m distance from the batsman at all times.
- No player huddles in tight formation including pre match team talks and celebrations.
- Toss to be carried out in accordance with social distancing regulations.
- No saliva or sweat to be used on ball at any stage. Any player found to be doing so will receive a warning, if found to continue this action then the player shall be removed from the game.
- No sharing of equipment will be permitted during the game (no club equipment will be provided).

- The fielding team shall provide their own ball for the innings. Any lost balls will be replaced by the fielding side.

### Declaration Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. In respect of COVID-19, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself or my child(ren) (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at a SWCC event.

On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless SWCC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of SWCC and representatives, whether a COVID-19 infection occurs before, during, or after participation in any SWCC program.
