

## CLUB HAMPSHIRE RUGBYSAFE LEAD

### 1501 Purpose and Skills required

1. The purpose of the Club Hampshire RugbySafe Lead is to ensure compliance to RFU Regulation 9 (Player Safety) and all Guidance therein, promoting awareness and good practice of other player welfare initiatives.

### 1502 Composition of Committee and Frequency of Meetings

- 1 The Club Hampshire RugbySafe Lead will attend Club Hampshire meetings. These meetings can be held Virtually if holding a group meeting is not possible. (Online over a meetings platform)
- 2 The Club Hampshire RugbySafe Lead can also attend the annual Hampshire RFU end of season RugbySafe meeting to share ideas, and liaise with the County RugbySafe Lead as required.

### 1503 Accountable to

The Manager of Club Hampshire for all matters concerning RugbySafe in all Club Hampshire squads, and also to work closely with the Club Hampshire Chief Sports Medic.

### 1504 Authorised to

- 1 undertake any appropriate RFU RugbySafe courses as required.

### 1505 Tasks

1. To be an active member of the Club Hampshire committee and to offer support and guidance to squad coaching teams as required
2. To distribute literature, electronic communication and new developments with regard to RugbySafe/player welfare to the Club Hampshire squad coaching teams..

### 1506 Key Tasks as defined by the RFU

1. **First Aid / Immediate Care Pitch-side Provision:** Carry out an annual review and first aid specific risk assessment to ensure that every training session and match have the appropriate first aid (FA) and immediate care (IC) provision and is compliant the RFU's Regulation 9 (Player Safety) and provision standards. This will be in liaison with the Club Hampshire Chief Sports Medic.
2. **Training & Equipment:** In liaison with the Club Hampshire Chief Sports Medic organise training to support all Club Hampshire first aiders and immediate care practitioners are trained and up to date with an appropriate level of qualification, in line with RFU guidelines (e.g. Level 3 Emergency First Aid in Rugby Union). Have a process in place for the management of FA/IC supplies and equipment.
3. **Emergency Action Plan:** In liaison with the Chief Sports medic - ensure that for all Club Hampshire squad coaching teams to ensure there is a clear process in the event of an incident/injury.
4. **Reporting:** In liaison with the Chief Sports medic - ensure there is process within each Club Hampshire squad to keep records of player medical conditions, monitor and record injuries and report incidents/injuries at all training/match events in line with RFU and CB guidelines.
5. **RugbySafe Champion:** Utilise the RFU's RugbySafe resources and guidelines to work with other key personnel within Club Hampshire to promote best practice in all Club Hampshire squads. player welfare.
