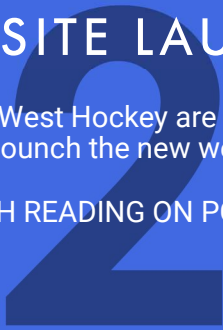

OTHER NEWS

MATCH SHEETS

Match sheets are the responsibility of the Team Captains not the Umpires. Therefore, the umpire may sensibly assume that everyone on the bench is on the Team Sheet but if concerned should raise it with the Team Captains.

Umpires can access the Match Reports of their game on the GMS system and should check the accuracy of recorded information after 8.00.pm. on the Sunday following their game. They should inform the Divisonal Secretary of any discrepancy.

Members umpiring a game at which there is no Match Official should record the Goals (For /Against) and the Card awarded and player number on a post it note, or match card supplied by their club. This should be shown to the team captain after the game for them to note or photo.

EHO KIT

EHO is currently finalising the details of the new kit for members. Items will be embellished with the Area logo on the front and the EHO logo on the sleeve. The Kit will be supplied in a "Value" and " Premium" range. It is intended that Specialist Sports will update the website on March 22nd prior to the launch on April 22nd.
