Coaches

The clubs coaching staff are all ECB qualified and are members of the ECB Coaches Association. Club coaches and team managers have completed a Criminal Record Bureau check and have attended a Good Practice and Child Protection course. All coaches have a first aid qualification.

All club members who have regular contact with children will have a CRB check. All other members of the club will be asked to complete a Self Declaration Form.

Junior Club Rules

Upton Cricket Club is fully committed to safeguarding and promoting the well being of all its members. The club believes that it is important that members, coaches, administrators and parents associated with the club should, at all times, show respect, encouragement to be open at all times and to share any concerns or complaints that they may have about any aspect of the club with the Junior Co-ordinator.

As a member of Upton Cricket Club you are expected to abide by the general rules of the club, our Code of Conduct for Cricketers and by the following junior club rules.

1. All members must play cricket within the laws and in the spirit of the game
2. Members are expected to be available to represent Upton Cricket Club in all competitions that Upton has sides entered in and for which they qualify. If a member has the opportunity to further develop their cricket by playing for another cricket club in a competition that Upton Cricket Club does not enter, then as long as both Clubs are informed and both agree to the arrangements then the member could play for both Clubs.
3. All members must respect colleagues, opponents and officials. Do not make derogatory comments or gestures about your colleagues or opponents. Never try to intimidate the opposition by threats or excessive triumphalism.
4. Be polite to umpires and respect their decisions. Do not show dissent!! Do not throw tantrums or cricket bats. Such behaviour invites sanctions from club officials.
5. Members should keep to agreed timings for practice and matches or inform their coach or team manager at the earliest opportunity if they cannot play or are going to be late.

6. All members must wear the appropriate kit – properly!! Cricket whites and suitable trainers or cricket shoes should be worn for matches but tracksuits are permitted for practice.
7. All players under the age of 18 years must wear helmets when batting and when standing up to the stumps when wicket keeping.

Code of Conduct for Parents/ Guardians

1. Encourage your child to learn the laws of the game and to play within the spirit of those laws
2. Discourage unfair play and disputes with officials/coaches.
3. Help your child to recognise good performance, not just results.
4. Never force your child to take part in any sport.
5. Set a good example by recognising fair play and by applauding the good performance of all.
6. Never punish or belittle a child for losing or making mistakes.
7. Publicly accept the judgement and help them to enjoy cricket and to develop within it.
8. Use correct and proper language at all times.
9. Do no forget, children are involved in organised sport for their enjoyment and not yours.
