In 2017, the [Open Government Partnership] Steering Committee strongly recommended that participating governments cap the number of commitments per action plan to 20, with a suggested maximum of five milestones per commitment, with the aim of incentivising more ambitious commitments". The Secretariat has also sought international examples of best practice to inform the Round Table's drafting process.

This includes TI Ireland's National Integrity Index, a series examining disclosure practices and public accountability across all sectors. Before joining TI Ireland, Catherine worked in the Irish diplomatic service and has also worked as a fraud investigator and risk analyst in the banking and technology sectors.
