Tendering Guidance

Important Notes to School's /ETB's seeking the items from this list:

- 1. Utilise existing contracts/arrangements with suppliers/service providers where available
- 2. Search <u>www.ogp.gov.ie</u> to check if there is a suitable, fit for purpose framework/contract in place for all or some of the items required.
- Seek quotations and or under a request for tender (depending on the level of spend) based on best value for money (qualitative and cost criteria). All procurement over the value of €25,000 must be advertised and published on <u>www.etenders.gov.ie</u>.
- 4. Seek quotations based on the items that can be competitively quoted from multiple suppliers based on the estimated level of spend following the procurement guidelines. For more advice on the procurement guidelines contact the Schools Procurement Unit (www.spu.ie) or Education Training Board with whom you are associated (list of ETBs on www.etbi.ie).
- 5. Suppliers may not be able to provide the full range of goods listed. In this case they should be requested to quote only for items they can supply.
- 6. The specifications outlined in this document have been reviewed to ensure products of the highest quality are supplied. Substandard equipment should not be proposed or accepted under any circumstances and suppliers should be asked to replace these to the same standard set out or higher. Schools are advised to check this as part of the assessment before finalising the overall scores. In addition to pricing each item, suppliers must also specify the warranty being offered for each item.
- 7. All quotations must be excluding VAT with the VAT highlighted separately.
- 8. Contact the School Procurement Unit or your ETB for further specific guidance.
