One of the themes in this edition of the magazine is fire safety. You can pull out and keep the advice in the middle section. Your safety is always our priority and by working together we can keep your home safe.

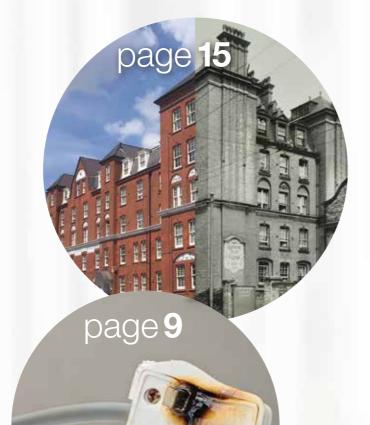

Would you like to work with other tenants to review how Guinness is doing and feedback your findings to Guinness's **Board and Service & Performance Committee? We are looking for tenants** to join a newly created Panel to influence how services are delivered and scrutinise how we are doing. You are invited to put yourself forward as a candidate.



#### What is the Tenant Scrutiny Panel?

The Tenant Scrutiny Panel is a new body we are setting up comprised of twelve tenants from across Guinness who will review a range of performance and customer feedback information. Tenants, or family members who have lived in a Guinness home for more than 12 months, are eligible to apply.

The Panel will make recommendations to the Board and the Service & Performance Committee. The Board/Committee will respond to any recommendation and will put plans in place to address issues raised by the Panel. In this way the Panel will have real influence in how Guinness provides services to its tenants.

#### How much time do members need to give?

The Panel will meet once every three months and meetings will be held in London. We are asking for the views of those who apply on what time of day would be most convenient for Panel members. There may be occasional additional meetings, or you may be asked to give us your views outside of the meeting.

#### Why should I get involved?

- Your involvement will ensure Guinness focuses on what is important to our tenants, and where we should focus improvement activity. You will be a voice for our tenants and hold us to account as vour landlord.
- Guinness will fund a Chartered Institute of Housing qualification for any Panel Member who wishes to gain this qualification. However, this is not required.
- An induction and other support and training, e.g. on how to scrutinise performance information, will be provided.

- Weigh up issues and make fair judgements.

#### Work with others

- Respect others' views and keep to the Panel's terms of reference.
- Work as part of a team and share skills with others.
- Work in partnership with Guinness, with staff and other residents.

#### Be a critical friend

- Have good listening skills.
- Challenge performance or service issues in a constructive manner.
- Able to use your experience as a resident, give your views, and help Guinness to provide good service.

# Dementia services

We want to support residents living with dementia, helping more people affected by the condition to remain independent and live in their homes for longer.

By 2050 the number of people living with dementia in the UK is projected to have risen to two million people from 850,000 today.

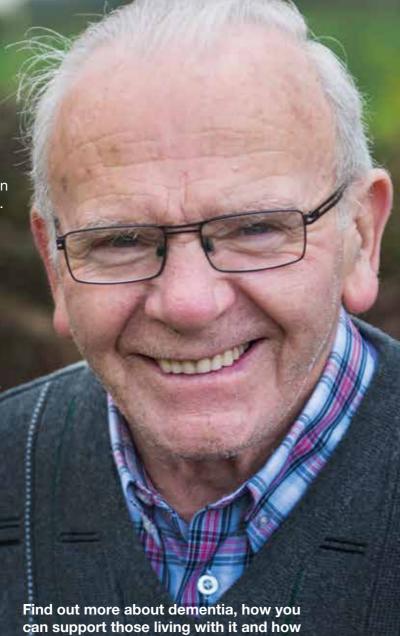
Our research indicates that there are likely to be more than 1,000 older people living with dementia in Guinness homes or receiving care services from us.

The range of homes and services we provide gives us a real opportunity to make a difference. A sensitive support offer helps enable those living with dementia to lead more independent and fulfilling lives.

In 2015, Guinness committed to becoming a dementia-friendly organisation. Since then, we have invested in training and research, and in the physical fabric of our buildings, in order to do this.

Today, we have 1,400 Guinness staff trained as Dementia Friends, to recognise and understand the needs of those living with dementia, helping them to access the services and information they need to live independently.

Our focus on becoming dementia-friendly is having a real impact on people's lives. Our customers living with dementia can be more assured we will provide support should they need it, and know that we will help them to live as they want. We are improving our knowledge of which customers are living with dementia so we can tailor our services. Because staff awareness is now so much higher, dementia-friendly thinking is a part of our day-to-day approach.

As part of our commitment to support all customers living with dementia, we've partnered with The Alzheimer's Society and the LGBT Foundation to promote the Bring Dementia Out campaign. This aims to support and encourage LGBT people living with dementia to speak out and ensure their voices are heard.

LGBT people are more at risk of suffering from feelings of isolation and experiencing discrimination, which is why we want to help build awareness and provide support.

# Moving on to **Universal Credit**

#### What is Universal Credit (UC)?

UC is a single benefit payment that replaces a number of individual benefits and tax credits you might be getting now including, Housing Benefit; Child Tax Credit; Income Support; Working Tax Credit; Income-based Jobseeker's Allowance; Income-related Employment and Support Allowance.

The Government intends to move everyone onto UC by 2024. However, if something changes in your life, the Government may move you sooner. UC works differently from previous benefits - so it's important to know the differences.

#### The biggest differences are:

- You'll usually get a single payment each month, rather than weekly or fortnightly - you'll need a bank account\* to receive the payment
- Instead of Housing Benefit being paid direct to us, you receive it as part of your UC payment. You then need to pay your rent to us from that money.

#### What to do to make your claim

You need to make your claim online\* by going to https://www.gov.uk/apply-universal-credit You will need some information readily available to make your claim, including proof of ID, your National Insurance number, email address, bank account\* details, rent details, details of savings and salaries, and details of other household members.

After you have applied it will take five weeks to get your first UC payment. Once you've applied for UC, you can request a short term advance payment to help you during this period. When applying for the advance payment make sure you plan what you need for the next five weeks, as this is a loan and you do have to pay it back. You then pay this back out of your future UC payments every month.

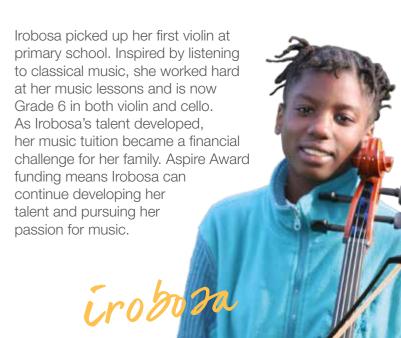


#### Your talent

Your Talent funding is available for customers with a proven talent in their field to cover the costs of training or equipment to help them achieve the highest level of success.

#### Your degree

In 2017, Georgina was a Year 1 student at Lancaster University (a top 10 law university), studying for LLB Law degree. She is the first member of her family to go to university.

I am going to university to study law to help vulnerable people, so the money will help more people than me in the long term.

Georgina was successful in her Your Degree Aspire Award application, receiving funding for her tuition fees for the second year of her course. University course fees are a financial burden for many students across the UK, leaving them in debt after university. So it comes as no surprise that this Aspire Award funding has come as huge relief to Georgina, meaning she can solely focus on her studies, making the most out of her talent and opportunity.

We were so impressed by Georgina's commitment and determination to her course, as well as her impressive results, that we extended her grant to her third academic year as well.

As part of our support for Georgina's education, we also helped her find a summer placement with Devonshires, a leading law firm. Kirsty Thompson, Employment Team Partner at Devonshires said:

"It has been a real pleasure to be able to offer a work experience placement to Georgina. She spent a week with us helping with tribunal preparation and advice work, getting a real insight into what life as a lawyer is like."

We are now welcoming applications for work placements throughout 2020. As a Guinness work placement participant, you will:

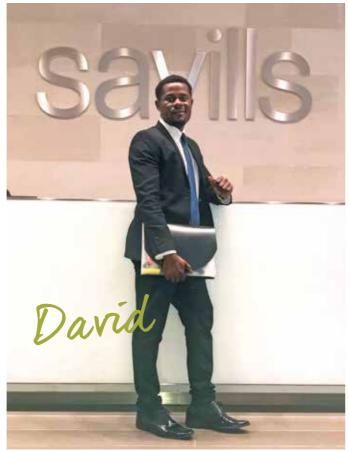
- Have the opportunity to experience working in your area of study / chosen career field

# Tire fety

Your safety is our priority. We do all that we can to make sure you are safe and that you feel safe in your home.

Throughout the year we carry out regular checks to make sure everything is working as it should be – things such as boiler inspections and fire safety inspections in common areas. We also make sure common areas have emergency lighting and fire doors, in case there is ever an emergency event.

It is important that we work together on fire safety issues. Please follow this guidance to make sure that you are helping to keep yourself, your family and your neighbours safe.

#### Smoke alarms

If you have a smoke detector in your home you should regularly check that it is working. If it is battery operated you should also change the batteries when necessary.

Vacuuming your smoke alarm will remove dust and dirt that can stop it from working. If you are concerned that your smoke alarm may not work, you need to contact us as soon as possible.

#### In the kitchen

Most fires start in kitchens, so make sure yours is safe.

- A major cause of fire is the build-up of fat and oil in pans, as it can easily ignite when heated. Clean your pans regularly.
- If a pan catches fire do not attempt to move it. Only turn off the heat if it is safe to do so.
- Never use water on an oil pan fire. Water will expand the oil and make the fire worse.
- Do not leave cooking unattended. Take pans off the heat or turn the heat down if you are called away from the cooker and turn the cooker off when you are not using it.
- Alcohol and some medicines can make you feel drowsy or impair your judgement. If you have been drinking alcohol and/or taking medicines that have this Always keep clothes, curtains and furniture effect, you should avoid using cooking appliances.

#### Preventing electrical fires

- Make sure electrical appliances have a British or European safety mark when you buy them.
- Keep to one plug per socket, especially for high-powered appliances like washing machines and freezers.
- Do not overload freezers or fridge freezers, especially older models.
- Electrical leads should not be run under carpets as damages will go unseen. Do not use damaged cables or plugs – throw them away straight away.
- Unplug appliances when you're not using them and also when you are asleep, to help reduce the risk of fire.
- Don't charge mobile phones when you're asleep, especially on your bed or under your pillow. Batteries can overheat and catch fire.
- If you have a tumble dryer, make sure to regularly remove the fluff that accumulates.
- If you use a portable heater, use an oil filled one instead of a halogen, bar or convector heater.
- well away from heaters.



# Follow this advice to help keep safe in your home

- Test all smoke alarms regularly.
- Dispose of rubbish and cigarettes properly.
- Do not store anything on balconies or in communal areas where it can provide fuel for fire, cause an obstruction or cause someone to trip.
- Do not store flammables, including BBQs, fire pits, chimineas, or gas bottles in your home or on a balcony.
- Take care when cooking and never leave cooking unattended.
- Take special care with candles and incense burners. Always use holders and keep them well away from curtains and fabric. Make sure you put them out fully before you go to sleep or leave your home.
- Make sure you know how to leave the building safely.

#### If you have a balcony

We want you to enjoy use of your balcony, but we want you to do this safely. We expect all our customers to take the following simple steps:

- Keep your balcony free of any flammable items and materials. For example, you may be surprised to hear that a kilo of plastic is equivalent to a kilo of fuel, which is why we ask you to limit the amount of storage you have there. Flammable materials include items such as large storage boxes, cushions, small balcony sheds, tins of paint, and electrical appliances such as dryers and fridges, etc.
- Never store gas cylinders on your balcony. There is a risk they may explode if they are left in the sun, even in winter.
- Never use barbecues, chimineas, fire pits or patio heaters on your balcony. Fires caused by these types of items can spread very quickly to the balcony above and below. They could also spread quickly into your property if doors or windows are
- Do not smoke on a balcony or allow guests to do so. If you do not follow this advice, then it is really important that you stub cigarettes out in a closed metal ashtray. Do not drop cigarettes on or over the side of the balcony, as this can cause a fire.
- Never use or store fireworks on your balcony (or anywhere in your home). If you have fireworks that you no longer want, some fire services will collect them free of charge and arrange to dispose of them safely.
- If the balcony is a communal balcony it may be a fire escape route and therefore should be kept clear of any items at all times so you and your neighbours can get out safely if you need to.

#### Your rubbish

Last year thousands of fires across the country were caused by rubbish. They start easily and a large number of them are deliberate. Dumped furniture, car tyres, scraps of wood, old mattresses and cardboard boxes are potential fire hazards and a target for arsonists (as well as looking bad).

- Always use the refuse bins provided on site wherever possible.
- Always keep rubbish away from buildings and doors.
- Always keep exits and escape routes clear, as rubbish may prevent your escape and stop fire fighters accessing the building.



Do not leave lit candles unattended and make sure you extinguish them before you go out, or go to sleep

#### **Smoking**

Smoking is not allowed in communal areas. Should you choose to smoke inside your own property, never throw cigarettes on the floor, out of a window or over a balcony. Make sure you put cigarettes out fully and dispose of them correctly.

#### Shared areas

We understand that you want the entrance to your home to feel welcoming, but it is really important that items are NOT stored in corridors and stairwells.

- Items left in shared areas or corridors can act as fuel for fire and obstruct escape routes. Please don't leave anything like bikes or buggies in corridors or communal areas.
- Never wedge communal doors open or shut.
- Please don't smoke in communal areas and don't let your family or any visitors to your home smoke in these areas.
- If you notice any repairs needed in communal areas, let us know as quickly as possible so we can fix these. This is even more important if you think the repair could relate to fire safety, such as a broken fire door.
- Do not tamper or interfere with any self-closing devices fitted to fire doors. These are intended to close doors in the event of a fire.

If our staff see items in shared areas that present a serious fire hazard, they may remove them without notice. If you see anything obstructing a shared area, please report it by contacting us on 0303 123 1890.

#### Fire escape plan

Being prepared for a fire can save lives. With everyone in your household:

■ Make sure you know what the fire evacuation strategy is for your building (if you live in a flat this information will be on signs in your building).

#### I Plan what to do if there was a fire in your home

- Familiarise yourself with your escape route out of the building (and an alternative route in case your first route is not accessible).
- Keep any escape routes clear of obstacles.
- Make sure you know where the keys to the front door and windows are kept.
- Learn how to navigate the stairs in darkness so you could do the same in thick smoke.
- If you envisage needing help to leave the building in the event of a fire, due to restricted mobility or a disability, or for any other reason, please inform us as soon as possible and we will put a specific plan in place for you and alert the fire service to your needs.

# What to do in event of fire

Thankfully there are relatively few fires, but when they do occur it is vital that you know what to do.

If you live in a house, you should get out of the property call the fire service, the sooner they will arrive to help. as soon as you can by the safest means possible and should not return until the fire service says you can.

If you live in a flat, follow the safety instructions on the notices displayed around your building. Your building will have either a "stay put" strategy or an "evacuation" strategy depending on its design and/or any specific arrangement that may temporarily be put in place.

It is important to remember that, regardless of the strategy for your building, if at any time you are affected by smoke or fire, feel it is unsafe to stay in your property (even if the fire is somewhere else in the building), or you are instructed to leave by the Fire and Rescue Service, you should leave the building by the nearest exit, closing any doors behind you.

If you are in a communal area and discover a fire, you should leave the building immediately – do not return

to your flat. If your building has an alarm point in the communal area, you should activate this as you leave to alert others in the building to the fire.

Call 999 as soon as it is safe to do so - the sooner you

Do not tackle a fire yourself unless you have received training in how to do this - you could be putting yourself and others in more danger.

Try to stay calm and, if you can, close all doors and windows to prevent smoke and fire spreading.

You should not use a lift in the event of a fire in case you become trapped. You should always use the emergency exit staircases and designated fire escape routes.

Once you have left your property, you should not return until the fire service says you can.

# Learn about the teams working to help solve any issues you may have in your community

#### **Customer Accounts Team**

The team supports customers that are having difficulty with their rent payments. They can offer simple budgeting information and create affordable payment plans to help stop you from falling into arrears with your Guinness account.

#### **Customer Support Team**

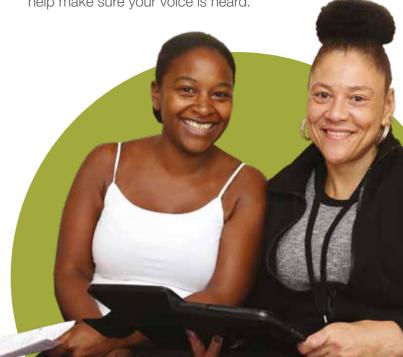
We know that not all of our customers get all the benefits or support that they are entitled too. Our Customer Support Team is here to help. They will talk through your situation and help you to get the right money and support in place to help you pay for your home and your life expenses. There is a new benefit system called Universal Credit. This is a monthly payment which can include your housing costs. We can help you claim and guide you through the Universal Credit journey.

#### **Tenancy Enforcement Team**

This team is here for you if you're experiencing anti-social behaviour. They'll help find a solution, and can arrange for disputes to be settled by offering different options, including offering a mediator to ensure a fair solution is reached and agreed to.

#### **Customer Liaison Team**

Customer Liaison Officers are the local face of Guinness in your community. They regularly check the quality of service in our buildings and our estates. If you need in-person support or advice, or want to report an issue in your home, on your estate or anything in relation to your tenancy, your Customer Liaison Officer can help make sure your voice is heard.



# Community Update

In partnership with other housing associations, Guinness has five food pantries across the country.

Food poverty is an issue for an increasing number of people. As part of our commitment to building great communities, Guinness is working with local community partners to open food pantries in areas that are in need, ensuring local experts have the support and resources they need to deliver a vital service in their neighbourhood.

Food pantries help create a sustainable and longterm solution to food poverty. The food pantry is a way to make sure that people's budgets go further. The benefits of pantries are that they offer fresh, frozen and ambient foods for households experiencing difficulties. Pantries also help customers to manage tight budgets and refer customers into local assistance projects such as Citizens Advice.

Members pay a small weekly fee, typically £3.50, for which they can choose at least ten items of food each week, along with additional opportunities of volunteering and training.

Guinness recently opened a new food pantry in Kensington, South London in partnership with Southern Housing Group and Clarion Futures.

The Kensington pantry is the fifth that Guinness is supporting, with others in Cheltenham, Oldham, Crewe and Sheffield.

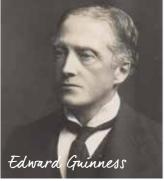

1891 Our first estate is opened at Brandon Street in Walworth, London, providing 190 homes at a rent of 2 shillings and sixpence.

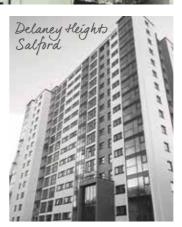




1939 Our Newhaven holiday home opens, providing a week's holiday for tenants who have paid their rent on time, but is requisitioned by the Admiralty at the start of World War Two. Newhaven reopens in 1945.

1973 Our first housing scheme outside London, is built in Gosport, Hampshire.

## Rent increase

Each year we notify you of changes to your weekly rent that take effect from the start of April (for most households). This year when we send you that letter we will be notifying you of a rent increase.

The way rents are set and the annual changes to rents, reflects regulation / legislation. Rent increases are limited to CPI +1% and so your rent increase will Any and all increases in rents (and service charges not exceed this.

The increase will take effect from April and applies only to your rent. If you pay a service charge this is calculated separately and added to give you your overall charge. You will be notified of this at the same time as your rent.

We will be writing to you to let you know what your new charges will be. If you have a direct debit in place, your charges will be amended automatically.

For other payment types, including Housing Benefit, you will need to make arrangements to change your payment amount.

If you are in receipt of Universal Credit you will need to update your online payment journal with the amount of your new rent. This must be done after 1 April 2020.
