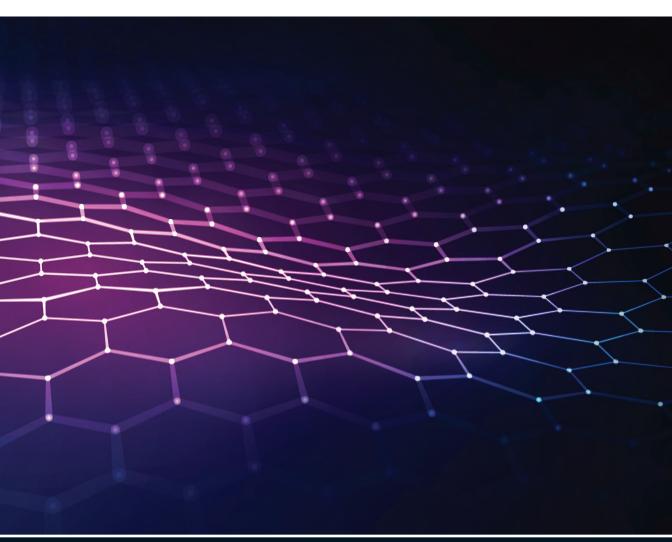

# A What's New in C CPI 15?

Like SAP technology and software, SAP certifications are always evolving to keep pace with the latest industry changes. SAP has launched an updated version of the SAP Certified Development Associate - SAP Integration Suite certification exam (C\_CPI\_15) and deprecated the previous version (C\_CPI\_14).

Although this book was written before the publication of the C\_CPI\_15 exam, there is very little change between this exam and the previous exam. This certification guide will help you thoroughly prepare for the C\_CPI\_15 exam. In this chapter, we will give you an idea of what's new in the current exam, and review the few topics that haven't already been covered in the main book. We'll begin by discussing the exam structure changes in Section A.1. Then we'll discuss what you need to know about the integration platform as a service, including SAP's integration approach and SAP's Integration Solution Advisory Methodology (ISA-M) in Section A.2. Section A.3 will cover API architecture operating modes, Section A.4 will explore REST and RESTful APIs, and Section A.5 will discuss Graph. We'll provide a list of important terms in Section A.6 and then close this chapter with practice questions and answers related to these new C\_CPI\_15 topics.

#### A.1 Exam Structure

The current SAP Integration Suite certification exam ( $C_CPI_15$ ) is structured a little differently than its previous version. There are fewer questions in the latest exam and the passing score is higher. You also have less time for the  $C_CPI_15$  exam. Here is the exam structure in more detail:

#### Exam type

The certification exam for SAP Integration Suite at the associate level is conducted in a multiple-choice format, where you're presented with a set of answer options and you must choose the most appropriate one(s) based on your knowledge and understanding of the subject matter.

#### Number of questions

The exam consists of a total of 60 questions covering a wide range of topics related to SAP Integration Suite (down from the previous 80 questions). These questions assess your knowledge, comprehension, and ability to apply concepts and principles in practical scenarios.

#### Cut score

To pass the certification exam and achieve the associate-level certification for SAP Integration Suite, you must attain a minimum score of 75% (this is up from the previous 68%). The cut-off score is the benchmark set by SAP to determine the level of proficiency required to qualify for the certification.

#### Duration

You're allotted a total of 120 minutes (2 hours) to complete the exam (this is down from the 180 minutes/3 hours allowed for the previous exam). This duration is ample time to carefully read and analyze each question, consider the answer options, and select the most appropriate choice based on your understanding of the subject matter.

# A.2 Integration Platform as a Service

Beginning in this section, we will cover topics that are new to the C\_CPI\_15 exam and that have not been covered previously in this book. We'll begin by discussing the integration platform as a service (iPaaS).

iPaaS is a cloud-based service that gives businesses the ability to link and combine various software programs, hardware devices, and data sources. iPaaS solutions give businesses a platform for creating, deploying, maintaining, and keeping track of their integrations, making it simpler for them to streamline operations and ensuring that all of their software products can communicate with one another without any issues. As a result, productivity across the board is increased within an organization.

# A.2.1 SAP's Integration Approach

SAP's integration strategy for intelligent enterprises is designed to deliver a seamless and unified experience across its range of applications, as well as with partner and third-party solutions. This is accomplished using a variety of technologies. Figure A.1 illustrates SAP's integration approach for the intelligent enterprise.

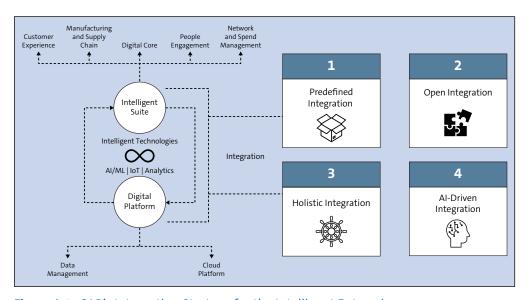


Figure A.1 SAP's Integration Strategy for the Intelligent Enterprise

SAP's integration strategy is based on four principles:

#### Predefined integration

Prebuilt integrations are available for a variety of processes. This simplifies the integration of the intelligent suite's end-to-end processes (SAP systems to SAP systems, as well as SAP systems to non-SAP systems).

#### Open integration

In addition to integrations between SAP products and between SAP products and partner products, SAP enables third-party integrations as well as bespoke extensions that make use of open APIs. For more than 170 third-party applications, SAP offers feature-rich, prebuilt connectors through the open connectors feature of the SAP Integration Suite.

#### Holistic integration

The majority of the types of integration needed in cloud and hybrid landscapes are covered by SAP's comprehensive integration technology portfolio. SAP supports a range of integration use cases, from process, data, user, and "thing" integration to analytics-focused integration, all of which are based on the SAP Integration Suite.

#### AI-driven integration

SAP uses AI to streamline the creation of integration scenarios in addition to integrating intelligence into fundamental business processes. SAP Integration Suite's Integration Advisor feature is one example of AI-driven integration.

Integration is central to SAP's overall strategy. It is a key pillar of the SAP Business Technology Platform, as shown in Figure A.2.

Through integration, software applications, processes, and people can be securely connected whether on-premise, in the cloud, or in a hybrid architecture.

Overall, SAP supports integration in the following ways:

- By enabling the integration of SAP and other systems, including integration of third-party software, API management, B2B/B2G support, data integration, event-based integration, Internet of Things (IoT) support, and process integration.
- By supporting integration content that has already been developed, such as connectors, business events, integration packs, and APIs.
- By making best practices accessible through prepackaged SAP business content.
- By creating an AI-powered content advisor to speed up the creation of integrations and cut down on ongoing maintenance expenses.

# A.2.2 Integration Solution Advisory Methodology (ISA-M)

In this section, we delve into several key topics in relation to ISA-M. We begin by explaining what ISA-M is and illuminating its significant. Then we'll examine the ISA-M cycle more closely, breaking down its elements and features. Finally, we'll discuss how ISA-M is used, particularly for integration assessment, emphasizing its usefulness in various integration scenarios.

ISA-M is a comprehensive framework that assists organizations in defining, documenting, and implementing an enterprise integration strategy. It is founded on SAP's industry-leading techniques and expertise in assisting clients with the integration of their applications, data, and procedures. With the help of this methodology, integration requirements can be identified and mapped to particular services, and current integration solutions can be documented and defined. ISA-M offers a selection of common integration styles and patterns, assigns integration services in accordance with the context of the customer, and provides architectural solutions for integration that take decision-making into account. Roles and duties within integration scenarios are also defined with the aid of ISA-M.

In addition to these fundamental characteristics, ISA-M has the following benefits:

- Openness to SAP and third-party integration technologies
   ISA-M can be utilized with SAP or third-party solutions because it is not dependent on any one integration technology.
- Use by target groups such as corporate architects and integration architects
   The target audiences for ISA-M include corporate architects, integration architects, and other
   IT specialists working on integration initiatives.

- Use as a template for defining custom integration policies
   ISA-M can be used as a model to create unique integration policies, such as security, routing, and transformation policies.
- Reusability inside organizations, projects, or services
  ISA-M can be used again and again within organizations, projects, or services. This implies that businesses can utilize ISA-M to create a uniform integration approach that can be applied to several projects or services.

SAP provides customers and partners with a PowerPoint template for ISA-M. This template has been built for integration architects, using SAP's integration expertise, and offers a starting point for enterprise integration. Additionally, in SAP Integration Suite, an integration assessment tool was introduced in May 2022, which you can find as the capability of SAP Integration Suite, as shown in Figure A.3.

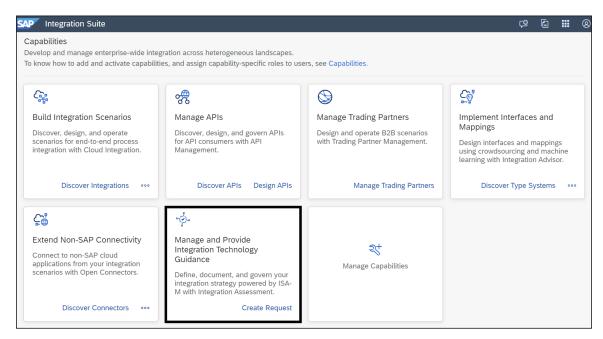


Figure A.3 Integration Assessment in SAP Integration Suite

This tool, powered by ISA-M, offers integration patterns, architecture blueprints, and best practices, much like the ISA-M template. It is a tool-based approach to the methodology, to help integration experts define, document, and execute an integration strategy and assess current integration implementation.

#### **ISA-M Cycle**

The ISA-M template arranges concepts within a four-staged cycle, in accordance with how SAP customers and partners are implementing the methodology. Figure A.4 shows the systematic approach of the methodology, with all four steps.

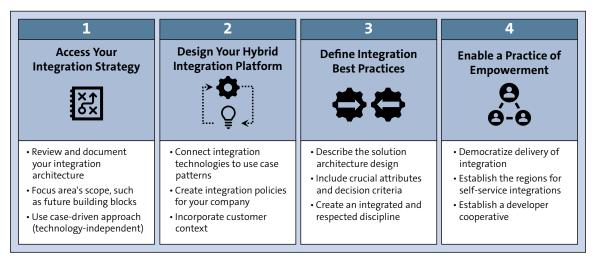


Figure A.4 Systematic Approach to Integration in ISA-M

The various use cases for this methodology are described in this cycle:

#### Stage 1: Access your integration strategy

Customers and partners can evaluate their organization's existing integration plan using ISA-M's step-by-step methodology. The scoping of integration styles and related use case patterns is done after a high-level scoping on the level of integration domains. Enterprise architects can choose templates from SAP that are appropriate for their organization now and/or in the medium term.

#### Stage 2: Design your hybrid integration platform

The set of pertinent integration domains and use case patterns from stage one are mapped to integration technology and service categories to shape an organization's hybrid integration platform. The client context, including previous investments, business considerations, and more, has a significant impact on this mapping. A single integration platform may not always meet integration requirements. Therefore, to create a hybrid integration platform for an organization, enterprise architects may need to combine several technologies, such as an iPaaS and an IoT Platform.

#### Stage 3: Define integration best practices

After the hybrid integration platform's architecture is ready, best practices for integration are established to protect the execution of integration scenarios. This makes it possible to transfer integration requirements to internal or external integration developers properly and can

establish the parameters for the quality control of completed integration scenarios. Enterprise architects can produce architecture blueprints for the hybrid integration platform that address the pertinent integration use case patterns (including integration domains) for this purpose. These designs outline and detail the relationship between integration technology and business applications.

#### Stage 4: Enable a practice of empowerment

Once the best practices for integration have been established, they can be implemented internally and externally (toward integration developers). Based on the established integration approach, project teams can then be given the freedom to design interfaces in an agile manner. This stage offers a feedback mechanism for adopting the integration strategy's lessons learned. This use case covers organizational aspects and procedures, such as creating an integration competency center. Additionally, this contributes to the recognition of integration as a profession inside an organization, supporting and facilitating projects related to digital transformation. Finally, this methodology allows for the scaling up of integration knowledge across the organization: Introducing self-service integration areas, for instance, with business persona implementation.

# A.3 API Architecture Operating Modes

In this section, we will explain the different operating modes of API architectures.

# A.3.1 Request-Driven Architecture

Request-driven architecture is a software architecture in which incoming requests from users or customers serve as the main source of the system's flow. In this architecture, clients send requests to the system, generally through a network (such as HTTP requests in online applications), to start interactions with it. Then, in response to these requests, the system's components or services carry out the required logic to process and perform the desired actions.

Figure A.5 shows how a service provider and service consumer can communicate directly in a request-driven architecture. This is synchronous communication.

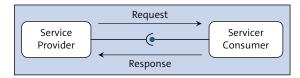


Figure A.5 Request-Driven Architecture

#### A.3.2 Event-Driven Architecture

To understand event-driven architecture, we must first define events. An *event* is a brief communication that informs of a commercial occurrence. For instance, an event could be an order created in a SAP S/4HANA system. Push-based messaging (asynchronous communication) is used to fire the event to a broker. Events act as start-ups for certain responses or alerts within a system, enabling asynchronous communication between various parts or services. They convey crucial information about the event, letting event participants respond and take predetermined actions in response to the event's content. Events allow for responsive and decoupled communication between services and components.

Figure A.6 shows the architectural diagram of events produced from the producer passed through the event broker and consumed by the consumer.

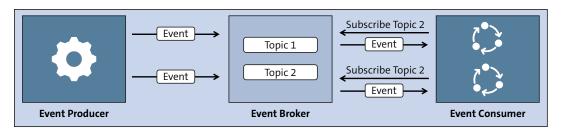


Figure A.6 Events

A software architectural design pattern called event-driven architecture places events such as user activities, system events, or communications from other components at the center of the system's operation. Components or services inside a system communicate by producing or receiving events in an event-driven architecture. These occasions set off particular processes or actions and enable loosely connected and asynchronous interactions.

#### **Pull Variant**

A *pull variant* refers to a specific approach to event consumption where event consumers actively request or "pull" events from a source when they are ready to process them. Figure A.7 shows the pull variant of event-driven architecture.

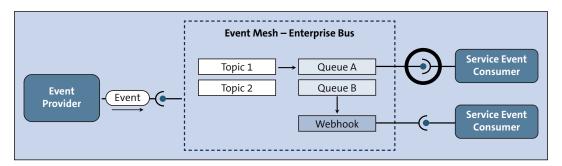


Figure A.7 Pull Variant in Event-Driven Architecture

The event provider starts the transmission of an event with a label, such as "topic". This topic might have the name "OrderStatus\_Update." This form of communication runs in an asynchronous manner. A queue that subscribes to the designated topic actively monitors it. The queue is referred to as **Queue A** in this instance. Using the event mesh's given API, the event consumer can obtain the message. A request to the queue prompts the event consumer to start the interaction. The pattern of communication in this encounter is synchronous.

Overall, the event push to topic message is asynchronous whereas the pull from queue is a form of synchronous communication.

#### **Push Variant**

The *push variant* of event communication in event-driven architectures actively sends events to event consumers as soon as event producers or a central event broker generates them. This implies that whenever a certain event takes place, it is instantly pushed or supplied to all interested customers without their actively asking for it. Figure A.8 shows the push variant in event-driven architecture.

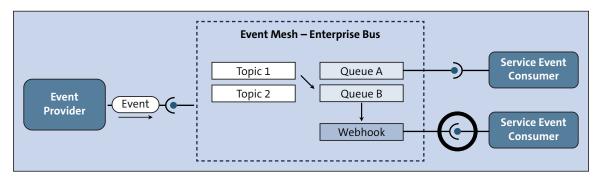


Figure A.8 Push Variant in Event-Driven Architecture

The event provider starts the event transmission with a label called "topic." Such a topic might have the heading "CustomerInfo\_Updated." The exchange of information happens asynchronously. **Queue B** has a webhook attached to it and is subscribed to the selected topic. The webhook is activated, and the event is sent immediately to the event consumer when an event with a matched topic enters the relevant queue. The event mesh facilitates this communication and incoming events start it, upholding an asynchronous communication architecture.

#### Webhooks

A webhook is a tool for automating internet-based communication between several software programs. It performs as an HTTP callback and is often prompted by particular occurrences or adjustments within a single program. The receiving application can receive and process the data or take actions in real time when the webhook sends an HTTP POST request to a predetermined URL in response to the occurrence of such an event. Webhooks provide seamless

and quick information sharing between platforms, services, and systems. They are frequently used for notifications, data synchronization, and workflow automation.

#### A.3.3 Combining Event-Driven Architecture and Request-Driven Architecture

A useful strategy for creating intricate and responsive systems that can effectively manage both user-initiated actions and asynchronous events involves mixing request-driven and event-driven architectures. In order to make use of the benefits of each paradigm, this hybrid architecture combines elements from both. Figure A.9 shows the combined event-driven and request-driven architecture.

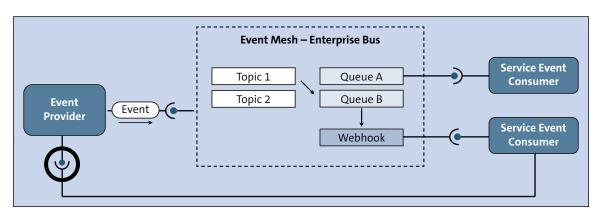


Figure A.9 Combined Event-Driven and Request-Driven Architecture

The entire structure is same as the push variant, in which the event is triggered from the producer with the label "topic" and the information is exchanged asynchronously. **Queue B** has a webhook attached to it and is subscribed to the selected subject. The webhook is activated, and the event is sent immediately to the event consumer when an event with a matched topic enters the relevant queue. The event mesh facilitates this communication and incoming events start it, upholding an asynchronous communication architecture. The service event consumer submits the request to the event producer for instance, to read the recently modified product data. The data set can then be processed by the event consumer.

#### A.4 REST

Representational state transfer or *REST* typically refers to a machine-to-machine interaction. REST, which is frequently referred to as *dynamic content*, enables content to be rendered when it is requested in web development. RESTful dynamic content creates a web page using server-side rendering and sends it to the user's web browser, which interprets the server's code and renders the page.

The REST architectural style exerts a profound influence on critical architectural properties:

#### Performance

The statelessness and cacheability of REST improves component interactions, maximizing both network and user-perceived performance. Latency is reduced with cached answers.

#### Scalability

REST's statelessness and layered architecture enhance scalability by making it easier to manage many components and their interactions, which is essential for systems that are subject to high loads.

#### Simplicity

Simplicity is promoted through REST's standard interface, which provides consistent norms for resource manipulation and separates the client from the server.

#### Modifiability

REST's decoupled architecture enables components to adjust flexibly to changing demands. Resources can change on their own, even while running.

#### Visibility

REST makes communication between components transparent by using accepted HTTP methods and URIs, allowing service agents to monitor and control interactions efficiently.

#### Portability

REST's reliance improves portability on common protocols and representations. Deployment across many contexts is made easier by the ability of components to travel along with program code and data.

#### Reliability

The statelessness of REST and its layered design help to ensure system-level reliability by ensuring robustness against failures in individual components, connectors, or data sources.

The REST style also has some architectural constraints:

#### Client-server architecture

REST separates client concerns (user interface) from server duties (processing) in a client-server architecture. Scalability and independence are promoted by this.

#### Statelessness

Every customer request must include all pertinent information. The lack of server retention of client state between requests makes scaling possible and simplifies implementation.

#### Cache-ability

Responses can be classified as cacheable or non-cacheable, which improves speed by using client-side caching.

#### Layered system

REST maintains a flexible, scalable framework while accommodating intermediary layers like proxies and gateways.

#### Code-on-demand (optional)

Although it's rarely used in practice, this constraint enables servers to send clients executable code.

#### Uniform interface

A standardized, uniform interface with HTTP methods and status codes makes it easier to communicate with resources, which enhances interoperability and clarity.

#### **Restful API**

Representational state transfer application programming interface, also known as a RESTful API, is a web service interface that adheres to the rules and guidelines of the REST architectural style. These APIs are made to be easy to use, stateless, and scalable. These APIs were created with the following features:

#### Base URL

The base URL for resource access in a RESTful API is something like http://api.example.com/.

#### HTTP methods

Common HTTP actions on resources are carried out using the GET, POST, PUT, and DELETE methods. Data is retrieved using GET, resources are added or updated using POST, deleted using DELETE.

#### Media type

To specify the format of data transmitted between clients and servers, RESTful APIs use media types. Atom, microformats, or specialized media types like *application/vnd.collection+json* could all fit this bill. The media type defines the request structure that clients should use to move between application states and transitions.

# A.5 Graph API for SAP

*Graph* is an API for SAP that makes use of current open standards such as OData v4. With the help of Graph, all business data can be accessed through a single, semantically integrated business data graph.

In order to provide a standardized method of accessing and altering data, Graph makes use of the strong foundation of OData v4. Its adaptability is shown in how easily it connects to different SAP backends, enabling any of them to act as a data source. There is a repository of pre-existing, fully functional APIs available for use at <a href="https://api.sap.com/graph">https://api.sap.com/graph</a> for those who are keen to get started. The adaptability of Graph also includes the ability to create customized

APIs, giving developers the option to create APIs that are adapted to their particular needs utilizing different processes. With its flexibility and wealth of resources, Graph is a handy tool for data integration and application development.

The business data graph is a tool that enables diverse data exploration through queries that delve into both data and their interrelated relationships. Entities, or data items, are represented as nodes in this data graph and each one has a home within a certain namespace. These entities have properties that correspond to their various fields. Edges, which represent semantic links, are crucial for navigating the complexities of data interactions. A dynamic method for understanding and utilizing complicated data structures is provided by Graph in the business data graph, which may be used to connect independent nodes through associations or connect a root node with its child nodes in a composition.

In the SAP Integration Suite, Graph is available as an extension of the API Management capability, as shown in Figure A.10. By extending conventional API management, Graph gives you the ability to access all of your company's data in the form of a semantically connected data graph using a single, robust API.

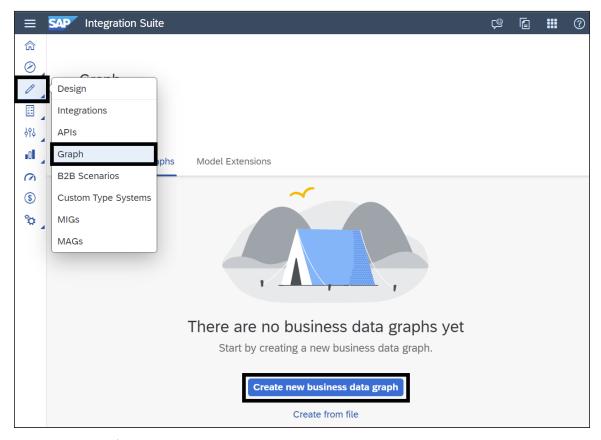


Figure A.10 Graph in SAP Integration Suite

# A.6 Important Terminology

### Integration platform as a service (iPaaS)

iPaaS is a cloud-based platform that facilitates the integration of applications and data across different systems, providing a unified environment for seamless communication.

#### Integration Solution Advisory Methodology (ISA-M)

RESTful refers to an architectural style for designing networked applications, often using HTTP, with a focus on simplicity and scalability in communication between systems.

#### Graph

Graph is an SAP technology that enables the integration and access of business data from SAP systems, based on the OData v4 standard, providing a standardized and adaptable approach to data integration.

# A.8 Practice Answers and Explanations

#### 1. Correct answer: A

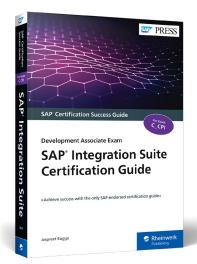
