Also played intercountry hurling with Dublin at youth, U21 and Intermediate as well as a number of years senior hurling with Ballinteer St. Johns.

At 45 am still very active in sport playing Hurling (still with BSJ), soccer, skiing and swimming. Also recently took up Karate as a sport I had always wanted to do as a child – was inspired by my 8 year old to do this and am finding it a great way to support and share in his journey.

Gymnastics is a fantastic sport and imho is a foundation for many other sports. With a 7 year old daughter fanatical about her gymnastics I've had opportunity to see the benefits of the sport and also experience the great work being done to develop the sport and the organization. There is great potential to build on the foundations which have been laid across performance, diversity and inclusivity.
