## NOTE:

These courses are ILEP approved courses of 25 weeks classes. All students on these courses must take an approved end of course examination. Medical Insurance is an immigration registration requirement. Students attending these courses will receive a stamp 2 permission to work in Ireland. Partner Agencies have the option of providing the required medical insurance directly to their clients. However the medical insurance policy must be provided by an insurance company that is approved by the central bank of Ireland.

#### **EXAM CENTRE OF EXCELLENCE FOR 26 YEARS:**

The Horner School of English have provided exam registration / preparation for international exams including IELTS & Cambridge FCE / CAE for 26 years. Students attending an Academic Year Course must take an approved examination towards the end of their course. The approved examinations for visa purposes include: TIE ( Test of Interactive English ), IELTS, Cambridge FCE & Cambridge CAE.

Students can select which exam they would like to take and the Horner team will provide a full exam registration service.

## **MEDICAL INSURANCE:**

Medical insurance is an immigration requirement. All students from outside the EEA must have evidence of medical insurance when arriving at Dublin Airport & registering with Irish Immigration (GNIB). This 8 month insurance policy covers students for medical costs in Irish hospitals and also medical repatriation back to their home country if necessary. Students are issued with a policy document with all the relevant contact details, on arrival in Ireland (by our school). The policy is valid in Ireland and also covers the student for up to 14 days travel to any country within **Europe** or the **EEA.** (€110).

#### **ACCOMMODATION EXTRA COST:**

Host family accommodation can be arranged on a part board basis i.e. breakfast and evening dinner, Monday to Friday and all meals at the weekends. From January to June & October to December single room host family will cost € 193.00 per week. For the months of July, August & September 2019 single room will cost €205.00 per week. We also offer accommodation in our city residences and apartments.

#### ACADEMIC YEAR COURSES & THE RIGHT TO WORK IN IREAND:

Academic Year Students are permitted to work part time 20 hours per week during the full 35 week period and full time 40 hours per week during certain defined dates: **Summer:** June to September Winter: 15th December – 15th January.

Attendance Records: (School attendance policy http://www.hornerschool.com/important-information-for-non-eea-students/) Garda National Immigration Bureau (GNIB) must be informed when students are absent for prolonged periods or if the attendance register shows that a student has less than 85% attendance on the course at any time. Attendance on the course is mandatory.

## Taking holidays during the school term:

Up to ten weeks holiday time is permitted. Holidays must be requested in advance at the beginning of the course. All holidays must be taken over the period of a full calendar week, Monday to Friday. The school will normally close for 2 weeks Christmas holiday, this time must be considered as part of the allowed holiday period. Holiday periods cannot exceed 1/3 of the already completed studied weeks. No unscheduled breaks are permitted.

### INIS (Irish Naturalisation And Immigration Service) in Dublin City

Students must register with INIS within 4 weeks of arrival in Ireland. The GNIB registration fee is currently  $\in$ 300. Horner School will assist your students to open an Irish bank account and obtain a PPS Tax Number to enable them work in Ireland. Students should bring their passport & Identity Card (these documents are necessary for opening an Irish bank account).
