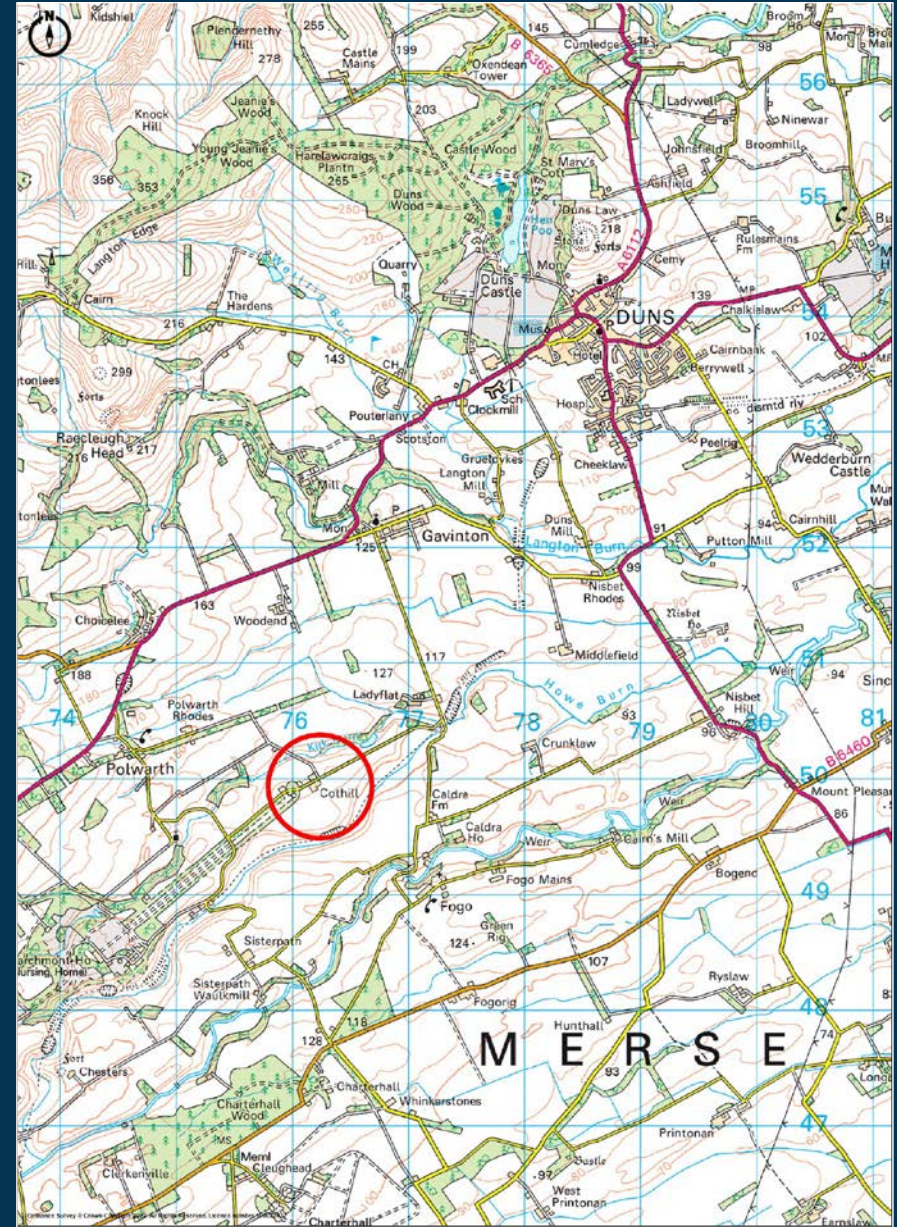

SITUATION

Cothill is a small settlement to the south west of Duns in the heart of Berwickshire. This peaceful rural setting has the most wonderful views across rolling farmland and woodlands of the Blackadder Valley. Duns is the county town of Berwickshire and has a good range of shops and local services, both primary and secondary schooling and a sports centre. Berwick upon Tweed, Kelso and Melrose with the Borders Railway link are all within 30 minutes' drive whilst Reston train station is also due to open once again in the near future.

The Scottish Borders is an excellent place to live if you enjoy the outdoor life. The region is Scotland's leading cycling destination, has excellent walks including the Southern Upland Way and Berwickshire Coastal Path. Some of the best golf courses in Scotland, a national hunt race track at Kelso, world class fishing on the River Tweed and endless opportunities for Pheasant and Grouse shooting and horse riding.

The area is also steeped in history with attractions including Kelso Abbey, Melrose Abbey, Thirlestane Castle, Mellerstain House, Floors Castle, Bowhill (the family home of the Duke of Buccleuch), and Manderston House.

DIRECTIONS

From Edinburgh, head south on the A68, turning off at Carfraemill onto the A697 to Greenlaw. In Greenlaw turn left onto the A6105 towards Duns. After about 4 miles turn right following the signposting to Polwarth and continue on this road over the bridge. Turn left at the top of the hill onto the lane heading east. The plots are located on the left upon the site of a former sheep shed.

DESCRIPTION

The plots are located to the north east of an existing small settlement. The site currently accommodates a former sheep shed which will be removed by the Vendor within 3 months of completion of sale. The surrounding dwellings are all highly aesthetic and individually designed which could provide scope for greater flexibility in the detailed plans for the subject house plots.

The plots benefit from wonderful outlooks over the surrounding countryside and are both of a generous size:

Plot 1 (outlined blue on plan) – 0.15 ha (0.37 acres)

Plot 2 (outlined red on plan) – 0.19 ha (0.46 acres)

PLANNING

Each plot has planning permission in principle for a single dwelling house with associated works and landscaping. Further details on the planning permission can be seen on Scottish Borders Council's planning website. The planning reference is 19/01522/PPP.

LOCAL CONTRIBUTIONS

Planning permission has been granted subject to a Section 75 Agreement which provides that the developer will pay to Scottish Borders Council the sum of £19,282 in respect of the local contributions for the two plots. It is a condition of sale that the successful purchaser(s) will be liable for these costs. A copy of the Section 75 Agreement can be obtained using the online planning portal quoting the planning reference or via the Selling Agents.

SERVICES

There are power and water connections located adjacent to the site. A private sewage treatment package will be required, and the Purchaser of each plot will be responsible for the cost of installing all services.

BOUNDARIES

The purchaser of each plot will be responsible for 100% of the cost of erecting and maintaining boundary fences excepting their mutual boundary fence whereby the cost will be split equally.

ACCESS

The site is currently accessed directly from the public road. The purchaser of each site will be responsible for 50% of the cost of any necessary upgrade works in connection with development of the site.

METHOD OF SALE

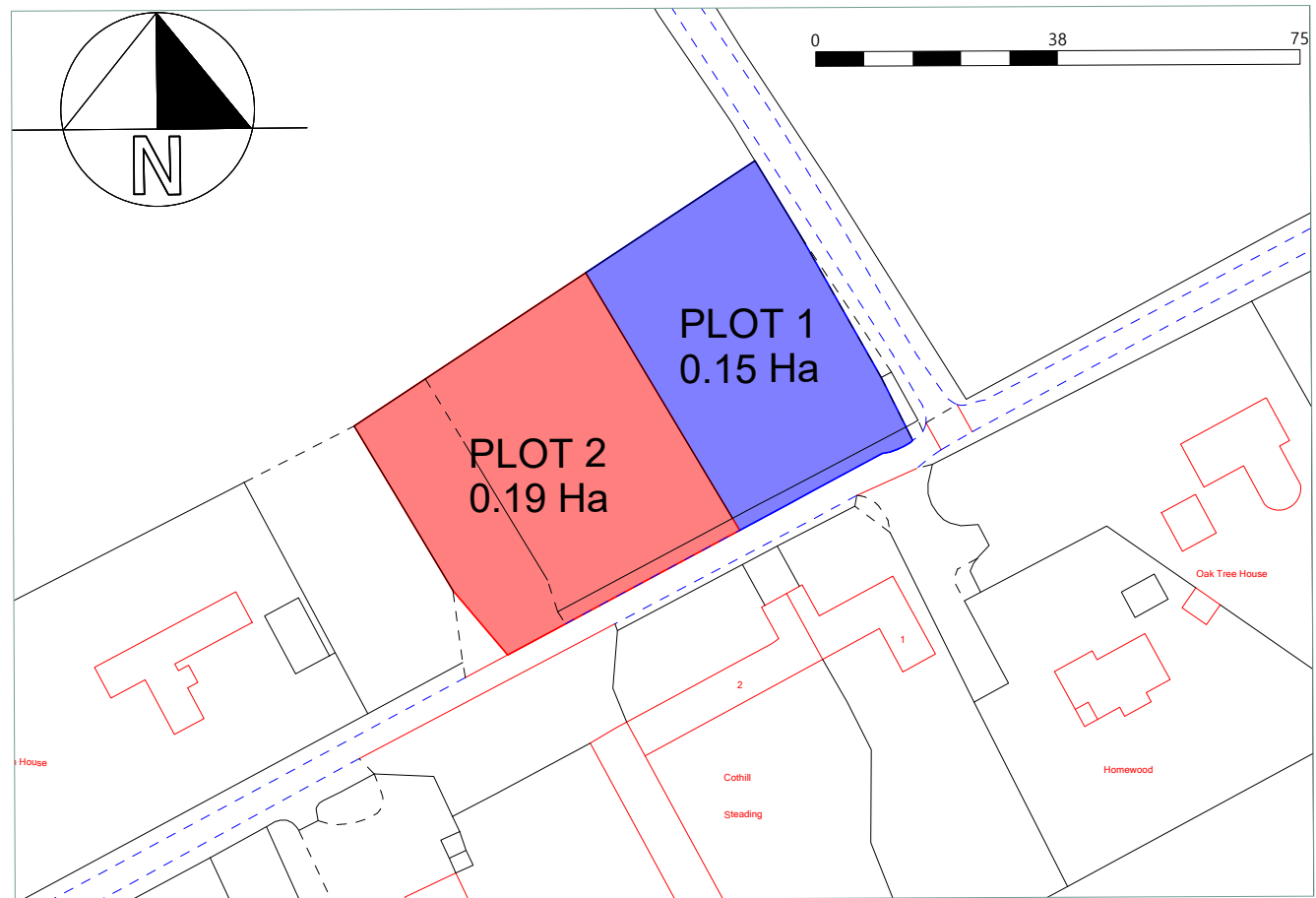
