House

Glan Awel is a semi-detached bungalow of stone and brick construction. It has been rendered and pebble dashed and has a natural slate roof. It was renovated and extended in the mid 1970's and was modernised and extended further around 2010. The property benefits from UPVC windows and doors throughout. There is also an adjoining garage of brick construction.

The property boasts outstanding views.

Services

We are informed by the seller that this property benefits from a mains supply of electricity and water, and a septic tank drainage system.

Heating

The land amounts to approximately 0.32 acres being predominantly good pasture. There is no supply of water to the land although there is access to mains water in the garden. 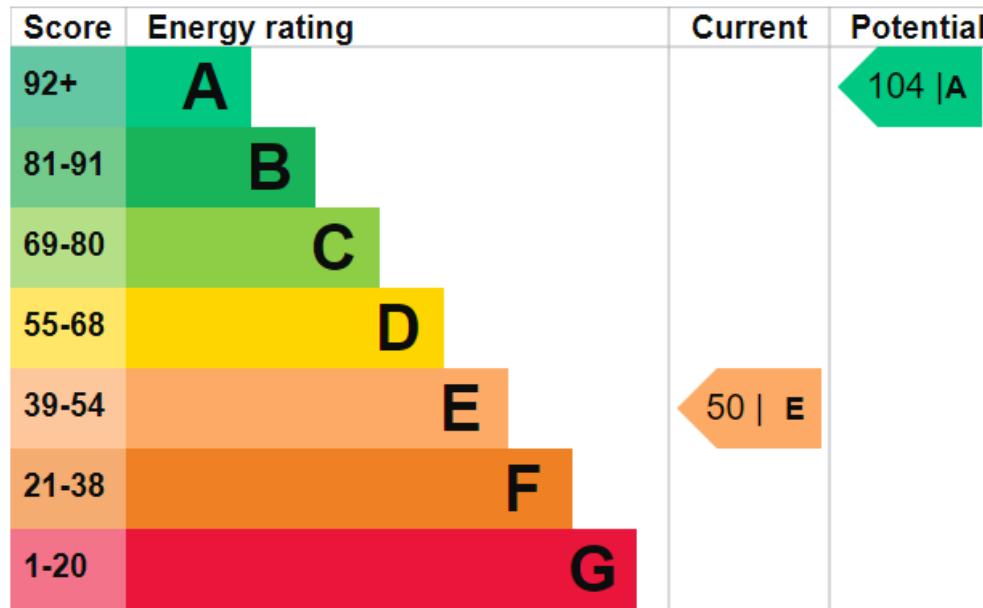

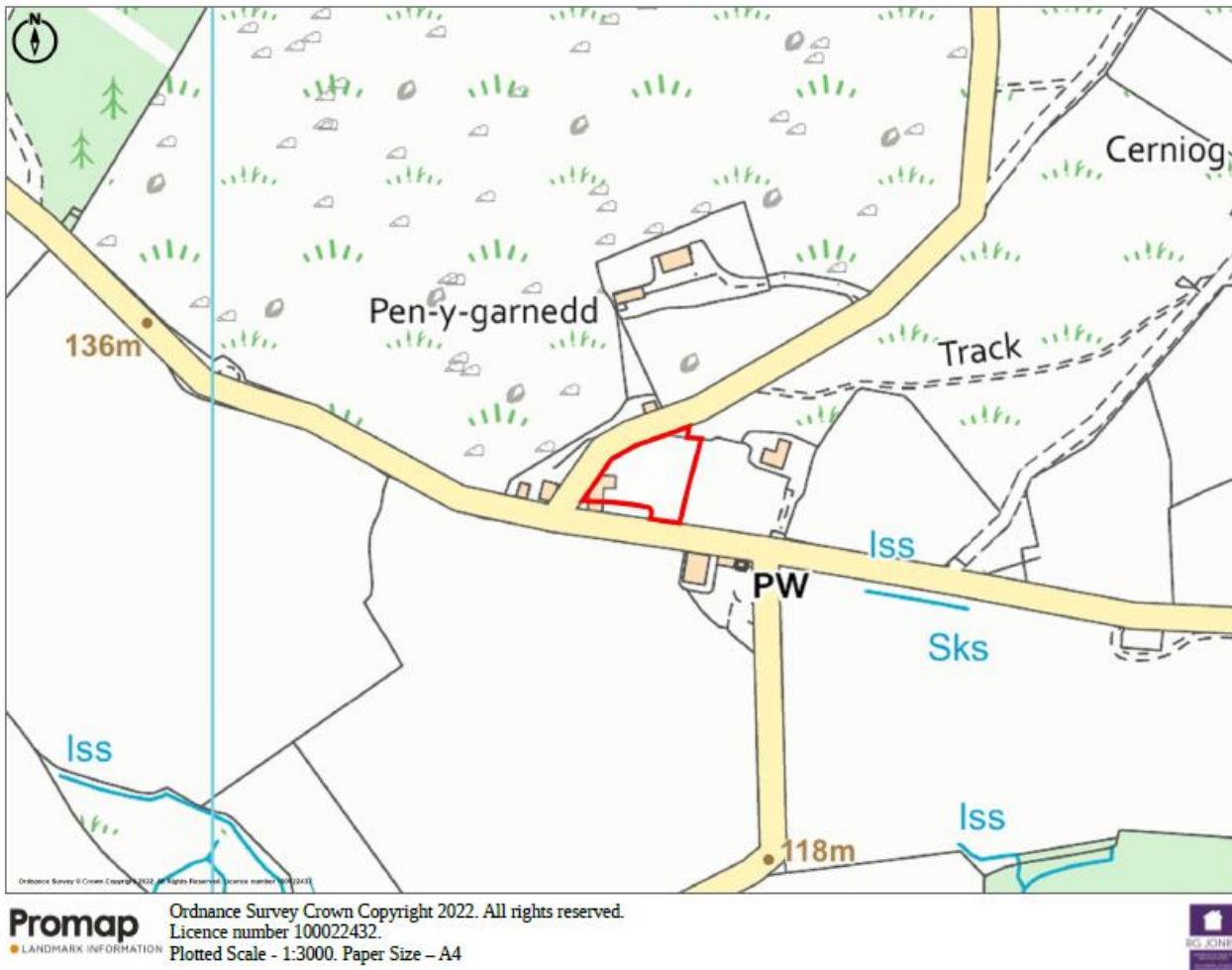
