SITUATION

Barn Hey Farm is situated between Liverpool and Widnes with excellent access to the motorway network.

DESCRIPTION

The farmhouse offers the potential for renovation and modernisation incorporating beams and other original features to form an attractive family home with an extensive garden.

The brick buildings and the block built building of more recent construction offer the potential for conversion to residential or commercial use, subject to planning permission.

Additional steel framed buildings.

A 40 berth caravan storage site with planning permission.

A total of 77 acres of productive arable land with access from Netherley Road.

LOT 1

Farmhouse, buildings, yard and a total of 5.46 acres of land





Forming part of the farm yard complex the house offers the potential for renovation to an attractive family home incorporating original features, with an extensive garden and orchard to the East. The accommodation is as shown on the floor plan.

THE BUILDINGS

The brick and slate buildings and the block building (formerly the cowshed, dairy and parlour) were the subject of pre application advice from Knowsley Council under reference 19/00020/PREAPP. This is available together with advice from a highways consultant, on our website and the OnTheMarket website.













The attached floor plans indicate the floorspace of each building

In addition there are two steel framed Implement Sheds (one with a timber lean-to), a timber framed barn and a block wall midden.





The purchaser of Lot 1 will be responsible for erecting a stockproof fence along the Southern boundary of the Lot within one month of completion.

The Caravan Storage Site has planning permission for a capacity of 40 berths granted by Knowsley Council under reference APP/94/00348 which is also available on the websites. The Rateable Value is assessed as at 1st April 2017 to present at £6,400. Annual income from this use is in the region of £19,200p.a. which will be apportioned on the completion date.

LOTS 2 AND 3

A total of 72.84 acres classified as Grade 2 on DEFRA's Land Classification Map, which is apportioned between two lots as shown on the plan both with separate direct access from Netherley Road.



Netherley Road Total Approx. Floor Area 2222 Sq.ft. (206.5 Sq.M.)







Netherley Road Total Approx. Floor Area 4998 Sq.ft. (464.3 Sq.M.)
