DESCRIPTION

A rare opportunity to purchase two blocks of agricultural land adjacent to the village of Long Preston. Lot 1 totals circa 6.32 acres (2.55 ha) and is an area of productive meadow land that is securely bounded and benefits from spring water supplies. Lot 2 totals circa 0.53 acres (0.21 ha) of land that is suitable for a number of uses including agricultural, equestrian, recreational or garden use subject to any necessary consents. With good access off the A65 the land is easily accessible and enjoys far reaching views over the valley towards Wigglesworth and beyond.

LOCATION

Access is directly off the A65 via Litter Lane which is located immediately at the edge of the village of Long Preston when travelling West towards Settle.

TENURE

We understand the property is held freehold and vacant possession will be granted upon completion.

WAYLEAVES, EASEMENTS AND RIGHTS OF WAY

The land is sold subject to all wayleaves, easements and rights of way whether mentioned in these particulars or not. A public footpath runs down Litter Lane and under the railway line and this is the shared access to both lots. Interested parties should familiarise themselves with the access and the location of the public footpath.

OVERAGE CLAUSE

Lot 2 is offered for sale subject to an overage clause. Should the purchasers or their successors in title obtain planning consent for development of the land within 20 years of the purchase, the Vendors, or their successors in title, will receive 50% of the uplift in value resulting from the grant of planning permission.

SERVICES

Water is provided to the land via Spring supplies. They are not tested and the Vendor provides no guarantee as to their reliability.

BASIC PAYMENT SCHEME

The land is registered with the Rural Payments Agency under the Basic Payment Scheme but no entitlements are included with the sale.

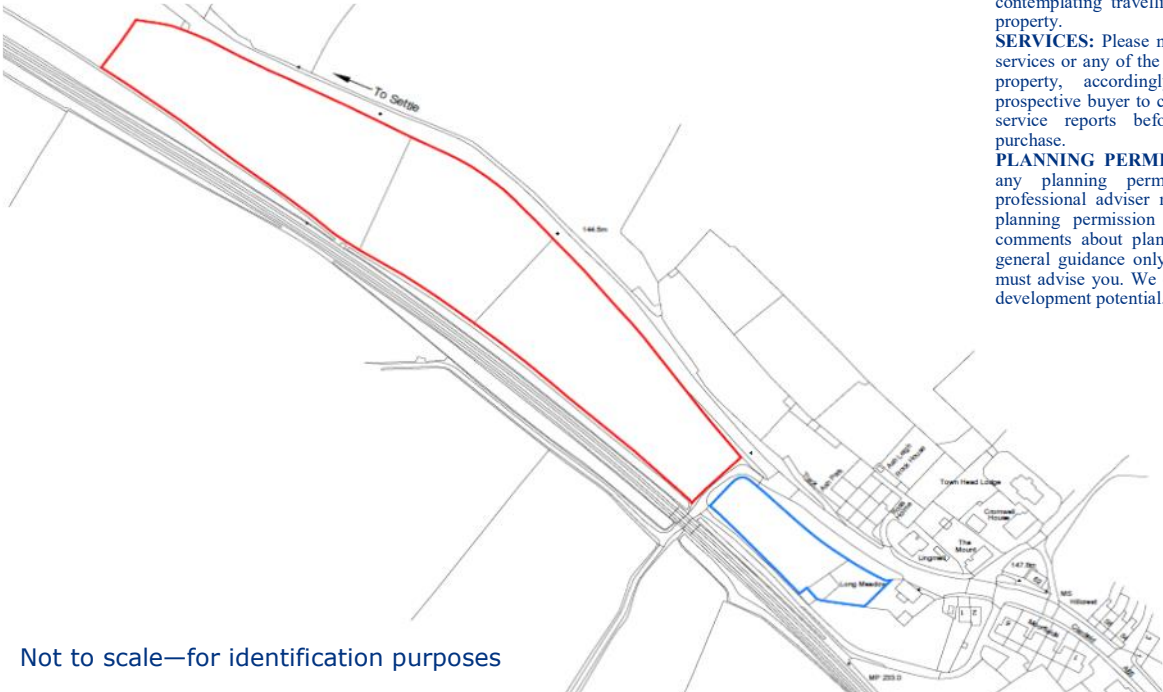
