A freehold investment for sale being part vacant and part let in the historic Market Town of Faringdon in the county of Oxfordshire.

Comprising one A3 takeaway unit and one A1 retail unit with office space above.

Location

Faringdon lies in the south west corner of the county and is 18 miles from the city of Oxford and 12 miles from Swindon.

The town has a population approaching 9,000 and in addition services a large rural area. A substantial house building scheme is currently underway which will increase the town's population to over 10,000.

On the ground floor there are two shops with offices on two storeys above. The offices are accessed from a side alley and courtyard with additional rear emergency access for one of the shops.

Description
A mainly rendered building with tile and slate roof dating from the early to mid 19th Century.

The property has a prominent position in the Market Place.



12 Market Place has recently become vacant and is currently being actively marketed by Marriotts Property LLP at a rental guide price of £13,000.
