Caledonian Optical Recycling Initiative - Terms & Conditions

1. Ordering and Fulfilment

- 1.1. Boxes are issued via the marketing team upon receipt of the recycling form.
- 1.2. One box will be sent at a time. Replacement or additional boxes are subject to spend review.
- 1.3. Damaged boxes may be replaced upon return of the damaged box; otherwise, additional fees will apply.

2. Participation Eligibility

- 2.1. The initiative is open only to Caledonian Optical customers with a **minimum** monthly spending commitment of £500, exclusive of VAT.
- 2.2. Requests for recycling boxes from non-customers or customers below the minimum spend will **not be fulfilled**.

3. Box Use and Return

- 3.1. Fill boxes strictly with **used spectacles and eyewear frames**, not unrelated waste.
- 3.2. Once full, return via the Caledonian Optical Royal Mail Returns portal.
- 3.3. Spectacles and frames should be returned in a standard box and not sent inside the recycling box itself.

4. Monthly Spend Monitoring

- 4.1. Caledonian Optical reserves the right to monitor customer monthly spend that qualifies against the recycling initiative.
- 4.2. Should a customer's spend fall below £500 in any calendar month, Caledonian Optical may:
 - a) Revoke box issuance
 - b) Charge a handling fee before issuing future boxes

5. Recycling Process

- 5.1. All returned spectacles are forwarded to the Lions Club, graded, and then:
- Reused where suitable;
- Materials such as plastic or lens fragments are recycled to support eye-care projects.
- 5.2. Caledonian Optical will provide **yearly reports** detailing the volume of spectacles recycled and landfill diverted.

6. Rewards and Recognition

- 6.1. Customers meeting or exceeding recycling targets may be eligible for reward programs.
- 6.2. Details and eligibility criteria for rewards will be communicated by your Account Manager.

7. Intellectual Property

- 7.1. Caledonian Optical retains all rights in the "Caledonian Optical" brand and recycling box design.
- 7.2. Customers may only use branding in approved marketing materials (e.g., "part of the Caledonian Optical Recycling Initiative").

8. Termination

- 8.1. Caledonian Optical may terminate participation with immediate effect if a customer:
- Drops below minimum spend for consecutive months,
- Misuses boxes (e.g., contamination), or
- Breaches any other term herein.
- 8.2. Participants can exit the program at any time by returning all issued boxes in good condition.

9. Changes & Notices

- 9.1. Caledonian Optical reserves the right to amend these terms with **30 days'** written notice.
- 9.2. Any changes take effect at the end of the current calendar quarter unless otherwise stated.
