1. INTRODUCTION

2. THE PROMOTION OF ACCESS TO INFORMATION ACT NO. 2 OF 2000 (THE ACT)

The objectives of PAIA are thus:

- 2.1. to give effect to the constitutional right of access to any information held by the State;
- 2.2. to set out justifiable limitations on the right of access to information aimed at protecting people's privacy, confidential commercial information and ensuring effective, efficient and good governance;
- 2.3. to balance the right of access to information with all the other rights in the constitution;
- 2.4. to promote a culture of human rights and social justice;
- 2.5. to establish mechanisms and procedures to enable persons to obtain access to records as swiftly, inexpensively and effortlessly as is reasonably possible;
- 2.6. to promote transparency, accountability and effective governance;
- 2.7. to empower and educate everyone to:
 - 2.7.1. understand their rights in terms of the Act;
 - 2.7.2. understand the functions and operation of public bodies; and
 - 2.7.3. effectively scrutinize and participate in decision-making by public bodies that affects their rights.

7. RECORDS AUTOMATICALLY AVAILABLE TO THE PUBLIC - SECTION 51(1)(c)

The Act provides for the automatic disclosure of certain records. Should records be automatically disclosed, you will not have to formally request these records in terms of the Act.

In terms of the Act, this automatic disclosure by private companies is voluntary. This means that a private company is not obliged to make such disclosure. If a private company chooses to make such voluntary disclosure, it may do so by giving notice thereof in terms of Section 52(2) of the Act.

9. PROCEDURE FOR REQUESTING ACCESS TO INFORMATION - SECTION 51(1)(e)

If you wish to request access to any of the above categories of information, you are required to complete a request form as set out in Form C hereto.

9.1. These forms are available from:

- The IDC Information Officer (whose contact details are in section 1 of this manual);
- The SAHRC website (www.sahrc.org.za)
- The Department of Justice and Constitutional Development website (www.doj.gov.za).

9.2. The requester must use the prescribed form to make the request for access to a record.

9.3. This must be made to the appointed designated person.

9.4. This request must be made to the address, fax number or electronic mail address of the body concerned.

9.5. Request for access to records of private body – Form A has been appended to the manual.

9.6. The requester must provide sufficient detail on the request form to enable the head of the private body to identify the record and the requester. The requester should also indicate which form of access is required. The requester should also indicate if any other manner is to be used to inform the requester and state the necessary particulars to be so informed.

9.7. The requester must identify the right that is sought to be exercised or to be protected and provide an explanation of why the requested record is required for the exercise or protection of that right.

9.8. Take care to adequately describe the right which you are seeking to protect or enforce by means of the records requested. Please note that the courts have indicated that access to the records must be “ necessary “ for the exercise or protection of the right so stated.

9.9. If a request is made on behalf of another person, the requester must then submit proof of the capacity in which the requester is making the request to the satisfaction of the designated person of the private body.

9.10.A public body may make a request for access to a record of a private body for the exercise or protection of any rights other than its rights, only if it is acting in the public interest.

10. REMEDIES FOR NON-COMPLIANCE WITH THE ACT

Any requester dissatisfied with any decision in respect of a request for access to a record can either lodge an internal appeal to the relevant authority or approach the High Court or another court of similar status to seek redress.

If the requester wants to lodge an internal appeal, it must be done within 60 days after receiving the notice that his/her request was not approved or within 30 days if notice to a third party is required.

An internal appeal must be lodged in the prescribed Form B .

11.GROUNDS FOR REFUSAL OF ACCESS TO RECORDS

The main grounds for refusal of a request for information are :

11.1. Mandatory protection of the privacy of a third party who is a natural person, which would involve the unreasonable disclosure of personal information of that natural person;

11.2. Mandatory protection of the commercial information of a third party, if the record contains :

- Trade secrets of that party;
- Financial, commercial, scientific or technical information which disclosure could likely cause harm to the financial or commercial interests of that party;
- Information disclosed in confidence by a third party to **BM VAN ZYL TRADING AS RETHA VAN ZYL REAL ESTATE** if the disclosure could put that third party to a disadvantage in negotiations or commercial competition.

- 11.3. Mandatory protection of confidential information of third parties if it is protected in terms of any agreement;
- 11.4. Mandatory protection of the safety of individuals and the protection of property;

12. FEES PAYABLE AS PRESCRIBED BY THE ACT - SECTION 51(1)(e)

- 12.1. A requester who seeks access to a record containing personal information about that requester is not required to pay the request fee. Every other requester, who is not a personal requester, must pay the required request fee.
- 12.2. The appointed designated person of the private body must notify the requester (other than a personal requester) by notice, requiring the requester to pay the prescribed fee (if any) before further processing the request.
- 12.3. The fee that the requester must pay to a private body is R50 exclusive of value added tax. The requester may lodge an application to the court against the tender or payment of the request fee.
- 12.4. After the designated person of the private body has made a decision on the request, the requester must be notified in the required form.
- 12.5. If the request is granted then a further access fee must be paid for the search, reproduction, preparation and for any time that has exceeded the prescribed hours to search and prepare the record for disclosure.
- 12.6. The prescribed fees relating to a request to access information are as per includes Section 54(7), Section 54(2) and Section 54(7) of Regulation 11(3).

15. LODGING PAIA REQUESTS

15.1. Form A:

15.1.1. The form below needs to be completed when a request for information is made to a public body.

15.1.2. Please note that these forms must be made available from the public body in question and that the personnel tasked with processing/receiving requests for information MUST assist in completing the form if you require assistance.

15.1.3. Certain public bodies will accept electronic submissions of forms.

15.1.4. Please also note that if you earn below R14 712 a year or you and your partners combined income is less than R27 192 per year, you will not have to pay a request fee with your application.

15.1.5. You will also not have to pay a request fee if your request for information is a request for your personal information.

15.1.6. In all other instances a fee of R35.00 needs to accompany your request.

15.2. Form B:

15.2.1. The form below needs to be completed when a request for information to a public body has been refused or the public body has provided no response to your request 30 working days after the request was submitted.

15.2.2. The Form B is the form to be used when you wish the decision of the public body not to grant access to information to be reconsidered.

15.2.3. Appeals can only be lodged with certain public bodies defined as category A public bodies in the PAIA legislation.

15.2.4. These are all national, provincial and local government public bodies.

15.3. Form C:

15.3.1. The form below needs to be completed when a request for information is made to a private body (business). Please note that these forms must be made available from the private body in question and that the personnel tasked with processing/receiving requests for information MUST assist you complete the form if you require assistance. Certain private bodies will accept electronic submissions of forms.

15.3.2. In requesting information from a private body the form must indicate what specific interest or right the information which is requested will assist you in asserting.

15.3.3. Please also note that if you earn below R14 712 a year or you and your partners combined income is less than R27 192 per year, you will not have to pay a request fee with your application.

15.3.4. You will also not have to pay a request fee if your request for information is a request for your personal information.

15.3.5. In all other instances a fee of R50.00 needs to accompany your request.
