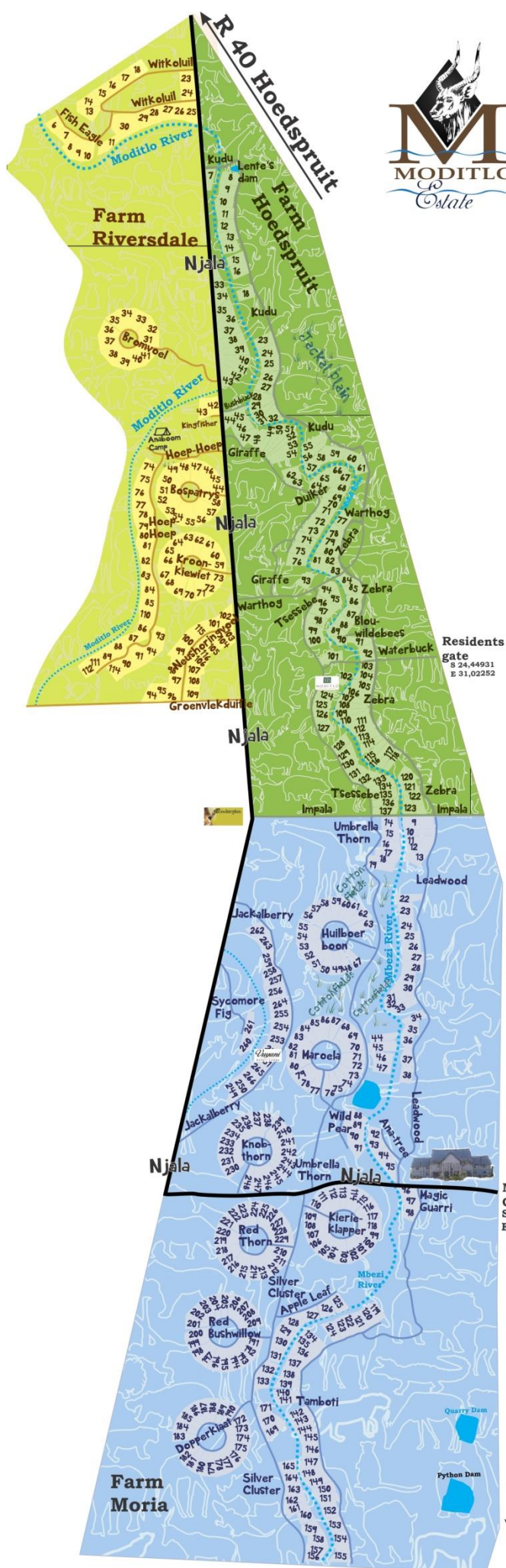

Moditlo Estate Homeowners Association welcomes you to Moditlo Estate and Game reserve

The Board of Directors wish to highlight the following:

1. The speed limit is **30 km/h**.
2. No quad bikes or motorbikes are permitted on the Reserve.
3. Animals shall at all times have right of way.
4. Moditlo Estate is part of the Blue Canyon Conservancy, which includes lion and elephant. Please take the necessary precautions around dangerous animal.
5. Every member, resident, guest, invitee, contractor or employee shall:
 - Not feed, chase, hunt, shoot, trap, capture, fish, molest or in anyway interfere with the indigenous wildlife of the Reserve.
 - Not make any fires on any portion of the Reserve, other than in areas specifically designated and protected (fire pits, braai areas).
 - Not drive in riverbeds, other than at designated river crossings.
 - Not collect or take anything from the Reserve including, wood, stones, flora, fauna or the remains of fauna.
 - Not litter
6. Drive only on clearly defined roads within the Reserve.
7. Under no circumstances may any instruction be given to security personnel. Only the Directors of the Security company may issue instructions and directives to security personnel.
8. The Association has appointed an Estate Manager and the directors have delegated some of their obligations concerning the management, security, enforcement of Rules and Regulations, including the Architectural Design Guidelines, to the Estate Manager.
