Sought after cul-de-sac within popular village. Well proportioned family home enjoying extensive rear garden bordering attractive woodland. Available with no onward chain.

Conveniently situated just above the Wye Valley on the Gloucestershire border, providing easy access for those enthusiastically seeking to appreciate the beautiful surrounding countryside. The Staunton community offers a good village Pub and Church, with schooling in Monmouth and Coleford along with Primary school in nearby Redbrook and Berry Hill.

Internally the accommodation comprises; Reception Hall, Cloakroom/WC. Impressive dual aspect Sitting Room with feature fireplace. Dining Room, Kitchen fitted with a range of base and wall mounted units, including cooker and fridge. Utility Room with washing machine, wall mounted oil-fired boiler, built-in storage and a door to outside. A particular feature of the property is the extensive rear lawned garden, which borders woodland. The garden provides much interest, with planted beds and a variety of shrubs. 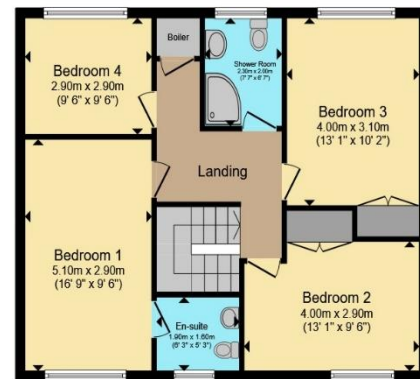
