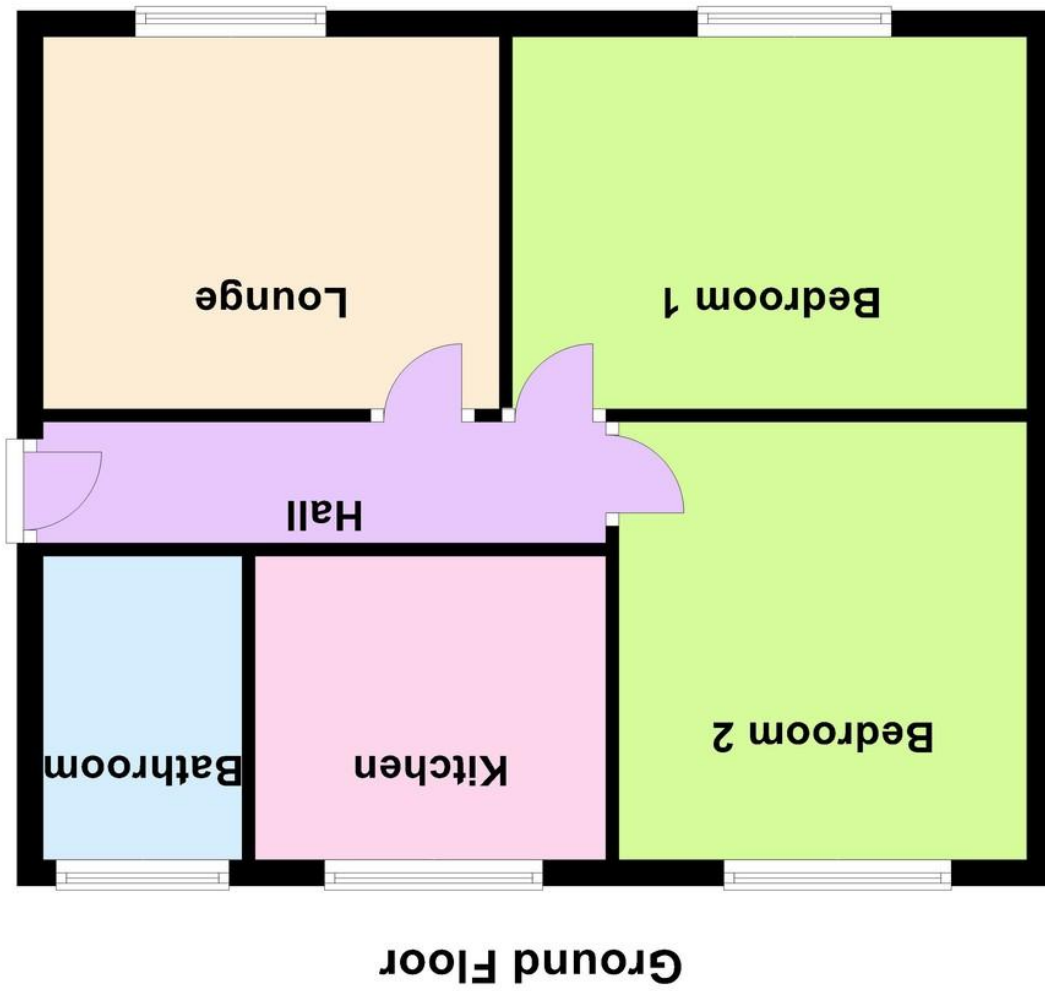
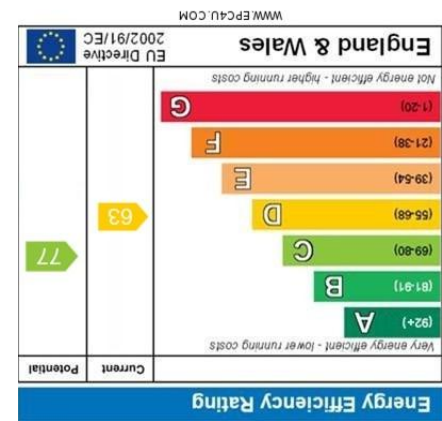


NOT TO SCALE: THIS IS AN APPROXIMATE GUIDE TO THE RELATIONSHIP BETWEEN ROOMS

HALLWAY Doors off to bathroom.

BATHROOM With low level wc, pedestal wash hand basin, bath, double glazed windows to rear.
