

This statement has been published in accordance with the Modern Slavery Act 2015. It set out the steps taken by Inca Digital Printers Limited ("INCA") during the year ending 2 April 2016 to prevent modern slavery and human trafficking in its business and supply chains.

### Introduction

Modern slavery encompasses slavery, servitude, human trafficking and forced labour. INCA has a zero tolerance approach to any form of modern slavery. We are committed to acting ethically and with integrity and transparency in all business dealings and to putting effective systems and controls in place to safeguard against any form of modern slavery taking place within the business or our supply chain.

### Our Business

INCA is a member of the 'SCREEN' group of companies and is an industry leader in the design, development and manufacture of inkjet printers for the print industry. Our business extends globally, both in terms of clients and supply base.

### Our High Risk Areas

INCA uses smaller businesses in its supply chain that are not required in law to make formal declarations relating to the Modern Slavery Act 2015. INCA recognises that these suppliers, along with those outside the borders of the United Kingdom present the highest risk to its business in relation to the Act.

### Policies and Contractual Obligations

INCA operates a number of internal policies to ensure that we are conducting business in an ethical and transparent manner. These include:

- ✓ Recruitment policy. We operate a robust recruitment policy, including conducting eligibility to work in the UK checks for all employees to safeguard against human trafficking or individuals being forced to work against their will.
- ✓ Whistleblowing policy. Where an individual discovers information which they believe shows serious malpractice or wrongdoing within the Company, the individual is able to disclose this information without fear of reprisal.
- ✓ SCREEN group code of conduct. This code explains the manner in which we behave as an organisation and sets out how SCREEN Group expects our directors, officers and employees to act, including a statement that we will not utilise or tolerate the use of child labour, workers under the minimum employment age, or any form of forced or compulsory labour.

### Our Suppliers

INCA operates a supplier policy and maintains an approved supplier list.

**All suppliers are required to comply with the SCREEN Supplier Code of Conduct. This code establishes standards to ensure that suppliers:**

- Provide workers with good working conditions, fair treatment and reasonable rates of pay;
- Respect the human rights of workers, and treat them with dignity and respect as understood by the international community.

**The SCREEN Supplier Code of Conduct also provides that:**

- All forms of forced, bonded (including debt bondage) or indentured labour, involuntary prison labour, slavery or trafficking of persons are prohibited;
- All work must be voluntary and workers shall be free to leave work at any time or terminate their employment;

- o No reports are received from employees, the public, or law enforcement agencies to indicate that modern slavery practices have been identified.
- o No reports are received from within our supply chain to indicate that modern slavery practices have been identified.
