Sub: Annual Escalation factor for ARR computation and computation of indexed SOR by Major Port Trusts under Tariff Policy, 2018 – Reg.

Ref: (1)No.TAMP/12/2009-Misc dt.09-04-2020..
(2)FA&CAO letter No.FA/Cost/Indexation/2020-21/654 dt.22-4-2020.

It has been notified by TAMP vide letter 1st cited that the annual escalation factor for the year 2020-21 for indexation of SOR is 1.88% [as per clause 2.3 of the Tariff Policy 2019]. **The indexed SOR shall be effective from 1st May'2020 and will be valid till 30.04.2021.** However the indexation is not applicable for the Tariff covered under Scale of Rates clause No.7.7 pertaining to the Schedule of charge for operation of Mobile X-Ray Container Scanning at VPT for which indexation to the extent of 60% of the variation in the WPI is applicable i.e. @ 1.13%.

In terms of the said order, the escalation @1.88 % will be applicable on all Vessel Related services, Cargo related services and Miscellaneous services related to Vessel and Cargo [except Wharfage of cargo Coking Coal (Conv),Fertilizer(Mech) , Rock phosphate(Mech)].

As stated, the said indexation will remain in force till 30th April '2021, accordingly, all stakeholders are requested to take note comply with the same.
