In this manuscript, we report practical, robust, and efficient conditions to synthesize a variety of unsymmetrical sulfamides via Sulfur(VI) Fluoride Exchange (SuFEx) click chemistry. This SuFEx strategy was subsequently harnessed to prepare a broad array of polysulfamides through polycondensation. The generality of the conditions allowed the synthesis of polymers with diverse architectures.

Synthesis of Unsymmetrical Sulfamides and Polysulfamides Via SuFEx Click Chemistry

ABSTRACT: As hydrogen-bond donors and acceptors, *N,N'*-disubstituted sulfamides have been used in a range of applications from medicinal chemistry to anion-binding catalysis. However, compared to ureas or thioureas, the utilization of this unique moiety remains marginal, in part because of a lack of general synthetic methods to access unsymmetrical sulfamides. Specifically, polysulfamides are a virtually unknown type of polymers despite their potential utility in non-covalent dynamic networks, an intense area of research in materials science. We report herein a practical and efficient process to prepare unsymmetrical sulfamides via Sulfur(VI)-Fluoride Exchange (SuFEx) click chemistry. This process was then applied to synthesize polysulfamides. Thermal analysis showed that this family of polymers possess high thermal stability and tunable glass transition temperatures. Finally, hydrolysis studies indicated that aromatic polysulfamides could be recycled back to their constituting monomers at the end of their life cycle.

Condensation polymerization is at the core of many industrial processes producing high-commodity polymers, such as polyesters, polyamides, polycarbonates, and polyurethanes. The syntheses of these polymers largely rely on robust and high-yielding condensation reactions at activated carbonyl groups and have been optimized over decades of chemical research. The recent development of the Sulfur(VI)-Fluoride Exchange (SuFEx) click chemistry¹⁻³ has enabled the synthesis of unique classes of polymers wherein the conventional carbonyl group is replaced by the more esoteric -SO₂- linker. For example, polysulfates⁴⁻⁷ and polysulfonates⁸⁻⁹ have been accessed and their properties compared to the analogous polycarbonates and polyesters. Among the family of hexavalent sulfur moieties, sulfamides are especially intriguing. As an SO₂ analog of ureas, sulfamides can engage in hydrogen bonding as hydrogen-bond donors and acceptors, 10,11 a powerful feature for materials science and organic chemistry alike. For example, aliphatic N,N'-disubstituted sulfamides have been used as gelators to trigger the assembly of 3D networks and vesicles. 12-14 In a medicinal chemistry setting, sulfamides can be used as bioisosteres for amides, ureas, and carbamates, and have become more common in the medicinal chemist's arsenal.¹⁵ For example, the broad-spectrum antibiotic doripenem contains a monosubstituted sulfamide pharmacophore. 16 Hydrogen-bonding organocatalysis could become a natural avenue of research for these compounds, but only a handful of useful transformations have been reported with sulfamides thus far. 17-21 A lack of attention towards this family of molecules stems from the challenging preparation of unsymmetrical sulfamides. Similarly, while polyureas are used as a commodity polymer (e.g., spandex), only a few syntheses of polysulfamides have been reported, rendering their properties underexplored.²² Early work in the 1960s demonstrated that condensation between aliphatic bis(amine) 1a and sulfamide (2a) at high temperatures produced insoluble macromolecules that were not fully characterized (Figure 1a). $^{23-25}$ More recently, Rudkevich and coworkers synthesized oligomer **3b** ($M_0 = 1.7$ kg/mol) using 1,4phenylenediamine (1b) in combination with SO₂, I₂, and pyridine or triethylamine (Figure 1a).²² The authors postulated the generation of a variety of hexavalent species including SO₂I₂.²⁶ Considering the Carothers equation,27 we hypothesized that in order to obtain polysulfamides with higher degrees of polymerization (DP), we should identify conditions that 1) afford control over the stoichiometry of AA/BB type monomers, and 2) avoid potential deleterious oxidative side-reactions that diminish the overall yield. We report herein the development of conditions based on SuFEx click chemistry for the high-yielding preparation of isolable sulfamoyl fluorides, unsymmetrical sulfamides, and polysulfamides (Figure 1b).

While several methods producing sulfamides have been reported, they generally suffer from narrow substrate scope and variable yields.²⁸⁻³⁷ Moreover, the iterative addition of two different amines to an electrophilic sulfur(VI) reagent is often complicated by either the high instability of the intermediate or, on the contrary, insufficient reactivity of this species. SuFEx is attractive due to its mildness, efficiency, atomeconomy, and stability of the fluoride-containing intermediate. For example, Sharpless disclosed an efficient synthesis of an unsymmetrical tetraalkylated sulfamide using SO₂F₂ and two secondary amines. Importantly, the sulfamoyl fluoride intermediate could be isolated and purified.³⁸ However, these conditions are known to be unsuitable for primary amines. 1,39 Indeed, treating benzylamine (4a) with SO₂F₂ (commercial or ex-situ generated)⁴⁰ led to the formation of undesired symmetrical sulfamide 7a as the major product, likely through the generation of azasulfene 6a (Figures 2a and S1,2).41 We instead turned our attention to SO₂F₂ alternatives. Sulfamides have been synthesized using thionyl tetrafluoride (SOF₄), but this gas is not commercially available and its preparation is hazardous.⁴² Dong and Sharpless demonstrated that imidazolium derivative 8, a shelf-stable crystalline solid analog of SO₂F₂, allows for the preparation of monosubstituted sulfamoyl fluoride in high yield (Figure 2b).⁴³ We were pleased to find that this reagent afforded a variety of bis(sulfamoyl fluoride) monomers (2b-e) when used in combination with simple primary bis(amine)s in DCM (Figure 2c). Notably, no precautions were taken to remove water and oxygen from the reaction, and both alkyl and aryl monomers can be synthesized in good yields. These monomers are shelf-stable for several days, but should be stored at 0 °C for extended periods of time to prevent slow decomposition. While decomposition is rapid in basic media, these monomers, apart from 2b, exhibit high tolerance to acidic conditions and can be purified through column chromatography. Yet, most impurities can be removed through aqueous workup, which is a testament to the practicality of the sulfamoylation protocol. Finally, it was found that [4-(acetylamino)phenyl]imidodisulfuryl difluoride (AISF, 9),44 another crystalline solid analog of SO₂F₂, can also be used to functionalize primary alkyl amines (Figure 2b). Yields were found to be lower and these conditions are not applicable to aromatic amines, but SO₂F₂ is not required for the preparation of AISF—by contrast to that of 8—which can be advantageous for laboratories not equipped with this reagent.

With sulfamoyl fluoride monomers in hand, we focused on the optimization of the second step of the SuFEx coupling. Treatment of 5a with benzylamine (4a) in MeCN afforded dibenzylsulfamide (7a) in 70% yield after 2 h at 80 °C (Table 1, entry 1). Addition of a catalytic amount of DBU increased the yield to 78%, while with a stoichiometric amount of DBU, the yield improved to 97% (entries 2-3). Using a less basic aromatic amine as the coupling partner resulted in lower yield in the absence of additional base (Tables S1,2). With our goal of developing a robust and universal protocol independent of the innate basicity of the amine partner, the amount of added base was kept to at least one equivalent, which also allows for trapping the resulting fluoride as a base-H+-F- salt. Triethylamine and potassium carbonate were found to afford similar yields to DBU (entries 4 and 5). Pyridine (entry 6) did not provide a noticeable improvement as compared to entry 1 but was found to perform best for aryl sulfamoyl fluorides (Figure 3). A variety of solvents were screened as well (Table S1). Interestingly, a nonpolar aromatic solvent such as PhMe delivered 7a in a similar yield as with MeCN, while DMF showed a decrease in yield (entries 7-8). Finally, quantitative yield could be achieved by running the reaction in MeCN at 50 °C for 4 h (entry 9).45 Again, all reactions were performed without removal of water or oxygen, which renders the overall SuFEx process operationally very simple. The optimized conditions were then used to synthesize a variety of sulfamides (Figure 3). Monosubstituted alkyl sulfamoyl fluoride 5a was coupled with benzylamine (4a) and aniline (4b) in high yields (products 7a,c) using DBU. Monosubstituted aryl sulfamovI fluoride **5b** afforded similar yields with the same coupling partners (products **7b.c**) using pyridine instead. Secondary amines such as N-benzylmethylamine (4c) can also be used in the second step to deliver trisubstituted sulfamides 7d and 7e. The lack of reactivity of dialkylated sulfamoyl fluoride such as **S4** (Figure S3), as well as ¹⁹F NMR analysis of a solution of **5a** and base (Figure S4), strongly suggest the generation of azasulfene intermediates in this process.⁴¹

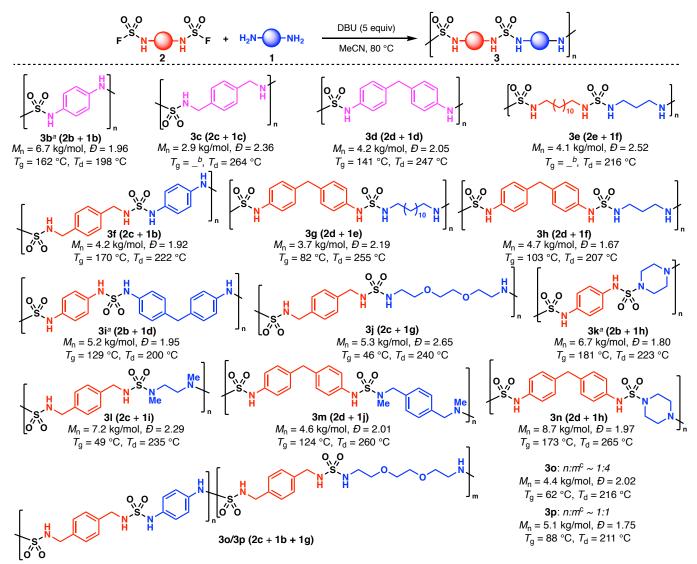
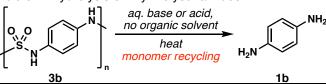


Figure 4. Synthesized polysulfamides via SuFEx chemistry. M_n 's and \mathcal{D} 's were determined by SEC (DMAc + 5% LiCl) using poly(methyl methacrylate) standards. $T_d = 5\%$ weight loss temperature. ^aPyridine was used instead of DBU. ^b No clear T_g was observed by DSC. ^c Determined by ¹H NMR.

These reaction conditions were then applied to the synthesis of polysulfamides using bis(sulfamoyl fluoride) monomers **2** and commercially available bis(amine)s **1** (Figure 4). Although premature precipitation of the growing polymers in MeCN was observed initially, this was overcome by increasing the temperature of the reaction to 80 °C and adding an excess of DBU (5 equiv). A

broad array of polymers was obtained with diverse architectures and M_0 's between 3 and 9 kg/mol. Notably, polymer **3b** showed a DP of 39 ($M_n = 6.69 \text{ kg/mol}$) using this protocol, which compares favorably to the prior synthesis of **3b** (DP = 10, $M_n = 1.70$ kg/mol, Figure 1a).²² Attempts to directly polymerize bis(amine) monomer 1b with SO₂F₂ failed. Additionally, aryl and alkyl sulfamides can be incorporated in the polymer backbone with similar ease. All synthesized polymers were soluble in DMSO and most in DMAc or DMF, which allowed for full characterization using NMR and sizeexclusion chromatography (SEC) (Supporting Information). Thermal properties of this family of polymers were explored via thermogravimetric analysis (TGA) and differential scanning calorimetry (DSC). All polymers exhibited high thermal stability with decomposition temperatures ranging from 198 °C for **3b** to 265 °C for **3n**. Although polymers **3b-n** all contain hydrogen-bond donors and acceptors in their repeating units, an impressive range of glass-transition temperatures were measured. Tg's as low as 46 °C and 49 °C were determined for 3j and 3l with aliphatic segments in the backbone, while T_g 's above 170 °C were observed for **3f**, **3k**, and **3n**, all three polymers characterized by stiffer aromatic and cyclic repeating motifs. Copolymers 3o and 3p were synthesized using bis(sulfamoyl fluoride) **2c** and bis(amine)s **1b** and **1g** in different ratios. The T_g 's of 3o and 3p, 62 °C and 88 °C respectively, are in between that of homopolymers 3j (46 °C) and **3f** (170 °C). Overall, T_g increases with an increasing amount of monomer **1b**, which highlights the facile tunability of T_g as a function of the molecular structure of the monomers. Strikingly, DSC analysis revealed an absence of crystallization and melting temperatures for all these materials. This thermal response contrasts with the melting temperatures measured in low-molecular-weight sulfamide films¹³ and the high-crystallinity observed with these small molecules.^{10–14} Powder X-ray diffraction performed on polysulfamides 3b-3n provided a more precise depiction of their structural order (Supporting Information). Polysulfamides exhibited varying degrees of crystallinity, from amorphous for 3i, 3k, 3m, and 3n to semicrystalline for 3c, 3e, 3f, 3j, and 3l. This behavior is reminiscent of work by Aida and coworkers, 46 which demonstrated that low M_n polythioureas may be amorphous due to a zig-zag arrangement of the hydrogen-bond network. As a result, these polythioureas can be processed into materials mechanically robust and self-healable. Polyureas, on the other hand, are generally characterized by a linear array of hydrogen-bond networks, 47,48 rendering them semicrystalline and brittle. IR spectroscopy was used to probe the hydrogen-bond interactions in **3b–3n** in the solid state. Strong \tilde{v}_{NH} peaks at approximately 3290 cm⁻¹ were found in both 3c and N, N'-dibenzylsulfamide (7a) (Figure S6) and are consistent with N-H bonds engaged in hydrogen-bonding based on prior studies. 12-14 By contrast, the IR spectrum of **3b** displayed much broader \tilde{v}_{NH} peaks, suggesting that the structure of the backbone strongly affects the hydrogen bonding ability of the repeating sulfamide groups. In-depth characterization of the hydrogenbonding architecture in various polysulfamides will therefore be necessary to shed light on their specific thermal and mechanical properties.

The synthesized polysulfamides showcased high thermal stability, a desirable feature for many applications. However, the global accumulation of plastic waste has created a dire environmental crisis that must be addressed by the development of recyclable polymers. Knowing the hydrolytic stability of polyureas,⁴⁹ the depolymerization of the synthesized polysulfamides was investigated. While alkyl polysulfamide **3I** displayed remarkable stability in acidic or basic media at elevated temperatures (Supporting Information), aryl polysulfamide **3b** could be hydrolyzed in a variety of aqueous conditions.^{50,51} **3b** was typically suspended in an aqueous solution and heated for 40 h. The resulting aqueous solution was then extracted at pH~14 with EtOAc and the amount of bis(amine) monomer **1b** was quantified (Table 2). After treatment with a basic solution containing NaOH or NH₄OH for 40 h at 80 °C or 125 °C, up to 53% of pure **1b** was isolated, while in HCl at 125 °C for the same amount of time, the recovery was improved to 74%. This initial study will serve as a blueprint to investigate the recyclability potential of aromatic polysulfamides.

In summary, we have developed an efficient, practical, and general synthesis of sulfamides and polysulfamides based on SuFEx click chemistry. We anticipate that this robust and mild method will impact the fields of medicinal chemistry and hydrogen-bond catalysis, areas in which sulfamides have demonstrated exciting promise. This process was adapted to produce and evaluate polysulfamides, a virtually unknown class of polymers. Characterization of these polymers revealed a high thermal stability as well as modular T_a 's depending on the monomer structure. IR spectroscopy and power X-ray diffraction revealed that hydrogen-bonding interactions and the degree of crystallinity are strongly influenced by the structure of the polymer backbone. Finally, aromatic polysulfamide 3b was depolymerized upon heating in basic or acidic aqueous solution, which suggests that these materials could be efficiently recycled after use.

General Reagent Information

All reactions were carried out under ambient atmosphere unless otherwise stated. Reagents were purchased at the highest commercial quality and used without further purification, unless otherwise stated. 1,8-Diazabicyclo(5.4.0)undec-7-ene (DBU) was purified by vacuum distillation with Potassium hydroxide (KOH) and stored over activated 4 Å molecular sieves under nitrogen atmosphere. Yields refer to chromatographically and spectroscopically (¹H NMR) homogeneous material, unless otherwise stated. Reactions were monitored by thin layer chromatography (TLC) carried out on 250 μm SiliCycle SiliaPlateTM silica plates (F254), using UV light as the visualizing agent and an acidic solution of *p*-anisaldehyde and heat, ceric ammonium molybdate and heat, or KMnO₄ and heat, or ninhydrin and heat as developing agents. Flash silica gel chromatography was performed using SiliCycle SiliaFlash[®] Irregular Silica Gel (60 Å, particle size 40–063 μm). Polymers were isolated after precipitation using an Eppendorf Model 5804 centrifuge, and dried using a VWR Model 1410 vacuum oven.

General Analytical Information

SEC of polymer samples was performed using two systems: Viscotek TDA302 and GPCmax with RI, dual-angle LS with two columns, I-MBHMW and I-MBLMW, in series at a flow rate of 0.5 mL/min and a EcoSEC Elite® HLC-8420GPC with RI and column TSKgel® SuperAWM-H at a flow rate of 0.2 mL/min. N,N-Dimethylacetamide (DMAc) with 0.5% LiCl was used as the eluent in both SEC systems. Number-average molecular weight (M_n) , weight-average molecular weights $(M_{\rm w})$ and dispersities (D) were calculated from refractive index chromatograms against poly(methyl methacrylate) standards. ¹H Nuclear magnetic resonance (NMR) spectra were recorded on two Bruker Avance NEO 400 MHz and a Bruker Avance 500 MHz; ¹³C spectra were recorded on a Bruker Avance 500 MHz and a VNMRS 500MHz; ¹⁹F spectra were recorded using a Varian Inova 500 MHz instrument and calibrated by a solution of CFCl₃ in CDCl₃ (@ 0.65 ppm ¹⁹F NMR). All ¹H and ¹³C spectra were calibrated using residual deuterated solvent as an internal reference (CDCl₃ @ 7.26 ppm ¹H NMR, 77.16 ppm ¹³C NMR; d₃-MeCN @ 1.94 ppm ¹H NMR, 1.32 and 118.26 ppm 13 C NMR; d_6 -DMSO @ 2.50 ppm 1 H NMR, 39.52 ppm 13 C NMR). The following abbreviations were used to explain NMR peak multiplicities: s = singlet, d = doublet, t = triplet, q = quartet, m = multiplet, br = broad. High-resolution mass spectra (HRMS) were recorded on an Agilent LC/MSD TOF mass spectrometer by electrospray ionization time-of-flight (ESI-TOF) reflection experiments. Melting points were recorded on a Fisher-Johns 13-144 melting point apparatus and are uncorrected. Thermogravimetric analysis (TGA) was performed on a TA Instruments TGA 5500 Thermogravimetric Analyzer or an Instruments Q500 Analyzer. Typically, samples were heated at 10 °C/min to 600 °C under nitrogen. Data were processed using Universal Analysis 2000 for windows software. Differential scanning calorimetry (DSC) was performed using a TA instrument DSC 2500. Samples were prepared in aluminum pans and were analyzed using the following heating program: -50 °C to 5 °C below decomposition temperature at 10 °C/min, cooling to -50 °C at 10 °C/min, and heating again from -50 °C to 5 °C below decomposition temperature at 10 °C/min. The data were processed using TA Instruments TRIOS for Windows software. All reported $T_{\rm g}$'s were taken from the second heating cycle. FT-IR spectra were acquired using an Agilent Cary 630 FT-IR in the ATR mode. All plots and spectra (SEC, DSC, TGA, XRD, and FT-IR) were produced using raw instrumental data and Wolfram Mathematica version 12.1, unless otherwise noted.

Experimental procedure

Synthesis of 1-(fluorosulfonyl)-2,3-dimethyl-1H-imidazol-3-ium triflate (8)

Caution: sulfuryl fluoride is a highly toxic gas. As such, all reactions using sulfuryl fluoride should be carried out in a well-ventilated fume hood to avoid exposure and inhalation.

Compound 8 was prepared following a previously reported procedure (Angew. Chem. Int. Ed. 2018, 57, 2605) with some slight modifications. In a flame-dried flask containing a suspension of 2-methylimidazole (S1) (4.93 g, 60.0 mmol, 1.0 equiv) and sodium carbonate (15.9 g, 150 mmol, 2.5 equiv) in anhydrous DCM (60 mL) the pressure was reduced using a Schlenck line until the DCM began boiling, and a balloon containing sulfuryl fluoride gas (approx. 1.5 L) was introduced. The mixture was stirred until full conversion of the imidazole was confirmed by NMR. If full conversion was not reached after 18 hours, a second balloon of sulfuryl fluoride was added. Solid residues were removed by filtration over a silica plug eluted with DCM. The filtrate was washed with distilled water (3 x 50 mL). The aqueous fractions were then combined and extracted with DCM (50 mL). The organic fractions were combined and washed with brine (50 mL) before drying over MgSO₄. The solvent was evaporated in vacuo using a 20 °C bath and a pressure of 200 mbar to avoid distilling away volatile sulfamoyl fluoride S2. When a volume of roughly 60 mL of solution was reached, the solution was cooled to 0 °C. Methyl trifluoromethanesulfonate (9.85 g, 60 mmol, 1.0 equiv) was then added to the mixture over 15 min using a syringe pump with vigorous stirring. The mixture was then warmed to room temperature and allowed to stir for 2 h, during which time the product precipitated from the solution. 8 was collected by vacuum filtration as a white solid (15.7 g, 79% over 2 steps) and washed thoroughly with methyl tert-butyl ether (MTBE). Note: Likely due to the presence of residual methyl trifluoromethylsulfonate, the product sometimes collects as a dense brown oil rather than a white solid. Here, the DCM can be removed first in vacuo, then upon addition of MTBE (50 mL) and stirring the mixture vigorously at 0 °C, the desired solid precipitates.

Synthesis of [4-(acetylamino)phenyl]imidodisulfuryl difluoride (AISF, 9):

AISF (9) was prepared following a previously reported procedure (*Org. Lett.* 2018, **20**, 812) with slight modifications. A solution of (diacetoxyiodo)benzene (8.24 g, 25.6 mmol, 1.5 equiv) and lithium bis(fluorosulfonyl)imide (6.38 g, 34.1 mmol, 2.0 equiv) in DCE (30 mL) was stirred at 100 °C in a flame-dried 3-necked round bottom flask adapted with a condenser. A solution of acetanilide (**S3**) (2.31 g, 17.1 mmol, 1.0 equiv) in DCE (35 mL) was slowly added to the refluxing mixture over 25 min. After stirring for an additional 15 min, the mixture was cooled to room temperature and activated carbon (4 g) was added. The mixture was stirred for 18 h at room temperature, then filtered through a short silica plug and washed with EtOAc. The filtrate was concentrated *in vacuo*. Column chromatography (SiO₂, 10:90 to 30:70 EtOAc:hexanes) allowed to remove most of the impurities. Recrystallization of the resulting brown solid with the minimum of EtOAc and slow addition of hexanes afforded **9** as crystalline white needles (3.42 g, 65%).

General Procedure for the Synthesis of Bis(sulfamoyl fluoride) Monomers 2 (Using 2c as an Example)

Reagent 8 (2.41 g, 7.33 mmol, 2.0 equiv) was added to a mixture of bis(amine) 1c (500 mg, 3.67 mmol, 1.0 equiv) in MeCN (15 mL) at 0 °C. The mixture was brought to room temperature and stirred for 2 h, subsequently diluted with ethyl acetate (10 mL), and washed with HCl (0.1 M, 2 x 10 mL) and brine (10 mL). The organic phase was dried over MgSO₄ and concentrated *in vacuo* to yield the crude product. When required, the product was then purified through column chromatography.

General Procedure for the Synthesis of Sulfamoyl Fluorides 5 (Using 5b as an Example)

To aniline (4b) (900 mg, 9.66 mmol, 1.0 equiv) in dry DCM (30 mL) stirring in an ice-bath Compound 8 (3.18 g, 9.66 mmol, 1.0 equiv) was added. The reaction was brought to room temperature and stirred for 2–4 h, until the starting amine was seen to be fully consumed by TLC.

After completion, the resulting mixture was diluted with DCM (10 mL) and washed with 0.1M HCl (3 x 15 mL) and brine (20 mL). The organic layer was dried over MgSO₄ and concentrated *in vacuo* to afford the product as an orange oil (1.42 g, 84%) without further purification.

Sulfamoyl Fluoride 5a was prepared following the general procedure. Starting with benzylamine (**4a**) (0.11 mL, 0.107 g, 1.0 mmol) to afford the product as a yellow oil (0.173 g, 91%).

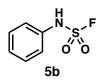
Alternatively, **5a** can be prepared using AISF **9** as the fluorosulfonation reagent. To a solution of benzylamine (**4a**) (107 mg, 1.0 mmol, 1.0 equiv) and AISF **9** (377 mg, 1.2 mmol, 1.2 equiv) in acetonitrile (3.5 mL), DBU (335 mg, 0.33 mL, 2.2 mmol, 2.2 equiv) was added dropwise at room temperature. The mixture was stirred and monitored by TLC until benzylamine (**4a**) was fully a consumed (about 3 h). The mixture was diluted with EtOAc (5 mL) and washed with HCl (0.5 M, 10 mL x 2) and brine (10 mL), dried over MgSO₄, and concentrated *in vacuo*. General Procedure for the Synthesis of Sulfamides 7 (Using 7b as an Example)

To the sulfamoyl fluoride **5b** (100 mg, 570 μmol, 1.0 equiv) in acetonitrile (5 mL) the amine **4b** (62 mg, 570 μmol, 1.0 equiv) and pyridine (45 mg, 570 μmol, 1.0 equiv; DBU for compound **5a**, pyridine for compound **5b**) were added. The reaction mixture was heated to 50 °C and stirred for 4–5 h, until none of the sulfamoyl fluoride could be observed by TLC. After all the sulfamoyl fluoride was consumed, 1M HCl (10 mL) was added into residue to stop the reaction. The mixture was extracted with ethyl acetate (3 x 5 mL). The organic fractions were combined, dried over MgSO₄ and concentrated *in vacuo* to yield product **7b** as a white crystalline solid (128 mg, 91%).

Sulfamide 7a was prepared by starting with sulfamoyl fluoride **5a** (102.7 mg, 0.543 mmol), coupling with benzylamine (**4a**) and following the general procedure to afford a white solid (144.3 mg, 96%), without further purification.

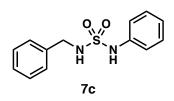

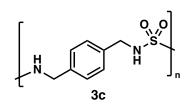
To a 0.5M solution of bis(sulfamoyl fluoride) **2c** (150 mg, 0.500 mmol, 1.0 equiv) in MeCN (1.0 mL), DBU (380 mg, 2.50 mmol, 5.0 equiv) and bis(amine) **1b** (54 mg, 0.500 mmol, 1.0 equiv) were added. 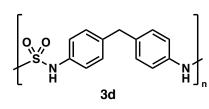

S6 was prepared according to a literature procedure (*Org. Lett.* 2017, **19**, 5244). In a flame-dried flask under nitrogen, imidazole (**S5**) (5.00 g, 73 mmol, 4.6 equiv) was suspended in anhydrous DCM (30 mL) and cooled to 0 °C. A solution of sulfuryl chloride (2.15 g, 16 mmol, 1.0 equiv) in DCM (6 mL) was added dropwise over 15 min. The reaction mixture was allowed to warm to room temperature and stirred for 18 h. The resulting heterogenous mixture was filtered using a fritted funnel, and the remaining solid was washed several times with DCM. The filtrate was concentrated *in vacuo* to yield a bright yellow solid. The solid was recrystallized in boiling isopropanol, isolated via vacuum filtration, and washed with cold isopropanol to obtain the title compound as a white crystalline solid (2.25 g, 71%).

SO₂F₂ was generated *ex situ* according to a literature procedure (*Org. Lett.* 2017, **19**, 5244). To one chamber of a small two-chamber reactor (Figure S1) benzylamine (**4a**) (107 mg, 1.0 mmol, 1.0 equiv) and triethylamine (204 mg, 2.0 mmol, 2.0 equiv) were dissolved in DCM (4 mL). In the second chamber, **S6** (279 mg, 1.5 mmol, 1.5 equiv) and potassium fluoride (232 mg, 4.0 mmol, 4.0 equiv) were combined. A stir bar was added to each chamber, and the reactor was sealed with

phenolic caps fitted with PTFE septa. To the second chamber, trifluoroacetic acid (1 mL, excess) was added via syringe. The contents of each chamber were stirred at room temperature for 18 h. The contents of the first chamber were transferred to a separatory funnel and diluted with EtOAc (4 mL). The organic layer was washed with HCl (0.1 M, 2 x 5 mL) and brine (5 mL), then dried over MgSO₄ and concentrated *in vacuo*. ¹H NMR analysis of the crude product revealed a 2.5:1 ratio in favor to 7a compared to the desired 5a (Figure S2).

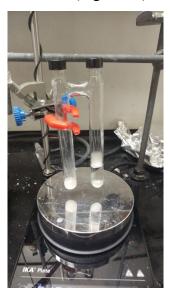


Figure S1. Two-chamber reactor for ex situ generation of SO₂F₂.

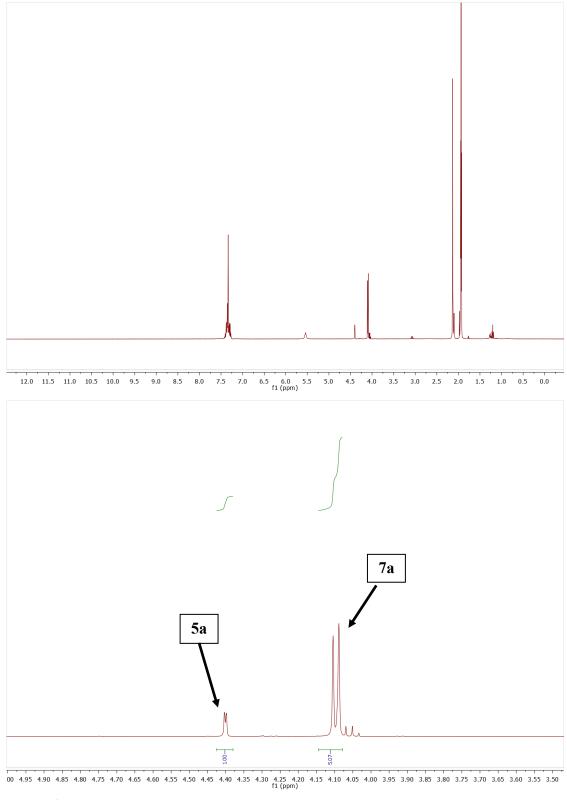

Attempt to Couple a Secondary Sulfamoyl Fluoride with a Primary Amine

To a solution of compound **S4** (7.0 mg, 34 μmol, 1.0 equiv) in 1,2-dichloroethane (0.4 mL), DBU (8 mg, 52 μmol, 1.5 equiv) and benzylamine (**4a**) (5.5 mg, 52 μmol, 1.5 equiv) were added. The mixture was stirred at 100 °C for 18 h. The mixture was diluted with 1 mL EtOAc and washed with HCl (0.1 M, 1 mL) followed by brine (1 mL). The organic layer was dried over MgSO₄ and concentrated *in vacuo*. ¹H NMR analysis of the crude product showed no trace of **7d**, but only unreacted **S4**.

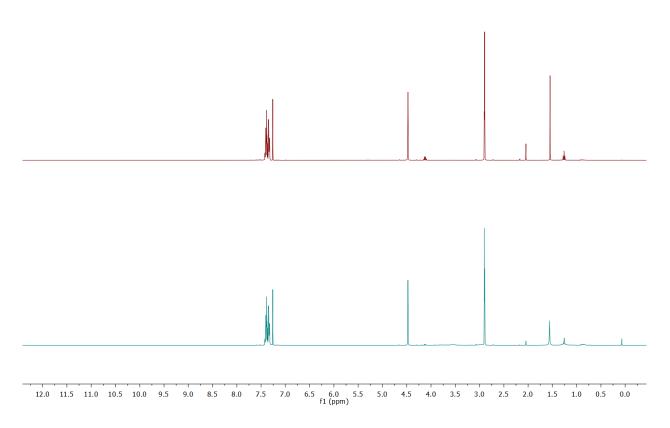

Monitoring the Sulfamide Synthesis

To a flame-dried vial under a nitrogen atmosphere, sulfamoyl fluoride **5a** (38 mg, 0.20 mmol, 1.0 equiv) was dissolved in anhydrous MeCN (2 mL). Amine **4** (0.20 mmol, 1.0 equiv) and DBU (30 mg, 0.20 mmol, 1.0 equiv) were added. The mixture was stirred at the indicated temperature for 24 h. For each time point, an aliquot of the reaction mixture (0.25 mL) was collected with a syringe. Each aliquot was immediately quenched with HCl (1 M, 1 mL). The aqueous mixture was then extracted with EtOAc (2 x 1 mL). The organic fractions were combined, dried over MgSO₄, and concentrated *in vacuo*. The progress of the reaction was determined by ¹H NMR using 1,3,5-trimethoxybenzene (4.2 mg, 25 μmol, 0.125 equiv) as an internal standard.

Investigation of the Generation of Azasulfene Intermediate 6a:

In order to avoid any potential reaction between azasulfene **6a** and trace of water, CD₃CN dried with activated 4 Å molecular sieves and anhydrous Et₃N were used. Anhydrous Et₃N (1.0 equiv) was added to a solution of sulfmaoyl fluoride **5a** in anhydrous CD₃CN. The resulting mixture was quickly transferred to a J. Young NMR tube under a stream of nitrogen. After heating at 80 °C for 30 min, a ¹⁹F NMR spectrum was collected, which revealed the full consumption of sulfamoyl fluoride **5a**. The new peak in the ¹⁹F NMR spectrum is consistent with the formation of Et₃N•HF according to literature precedent (*J. Am. Chem. Soc.* 2016, **138**, 11360)

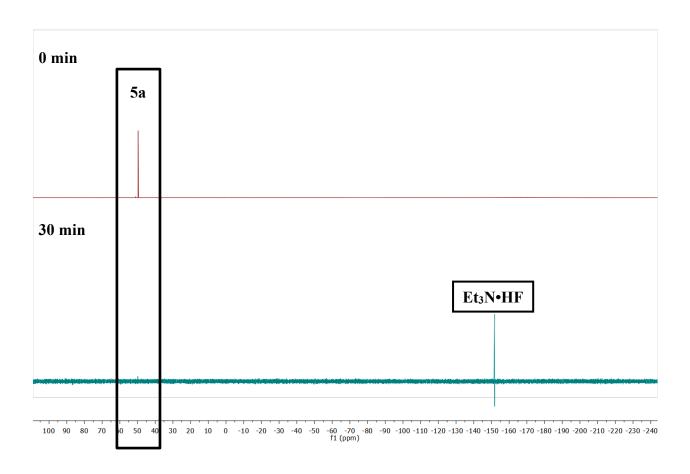

Hydrolysis Study of Polysulfamides

To a vial containing polymer **3b** (15 mg, 88 μmol, based on monomer unit C₆H₆N₂O₂S), 2 mL (excess in all cases) of the respective aqueous base or acid solution was added. The mixture was stirred at the indicated temperature for 40 h. If the aqueous solution was acidic, the solution was placed in an ice bath and solid sodium hydroxide was added to the mixture until a pH of 14 was reached. The aqueous mixture was extracted with EtOAc (3 x 1 mL). The organic fractions were combined, dried over MgSO₄, and concentrated *in vacuo*. Yields were determined based on the mass of product obtained.

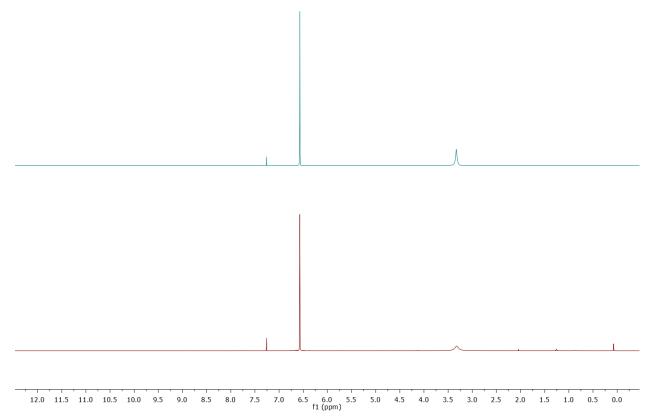

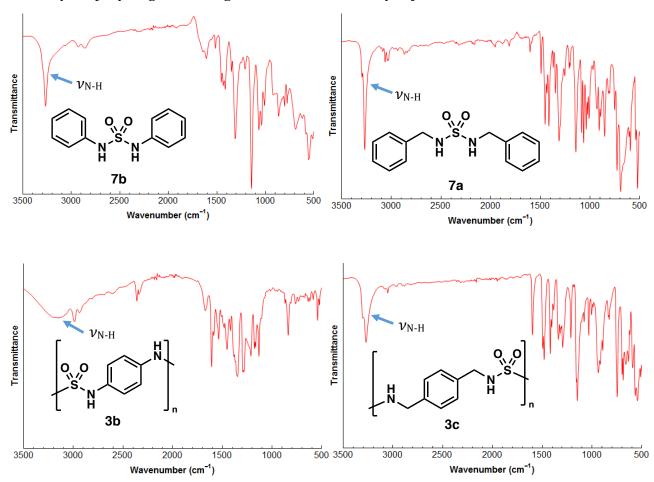
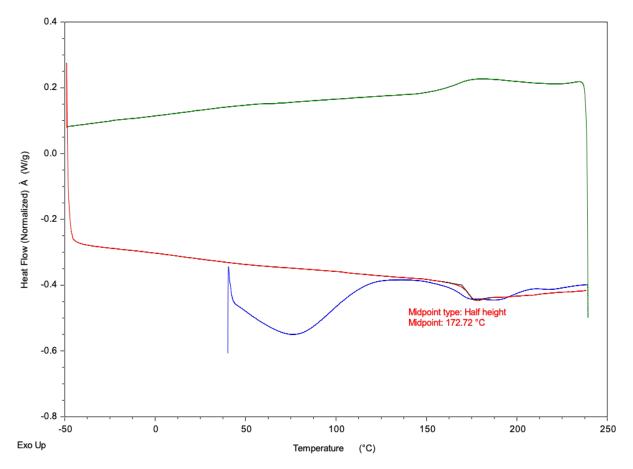

(d) Powder XRD patterns, (e) FT-IR (ATR) spectrum.





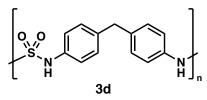
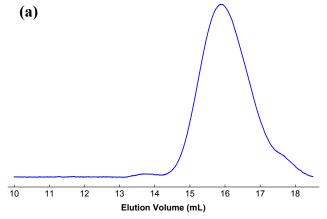
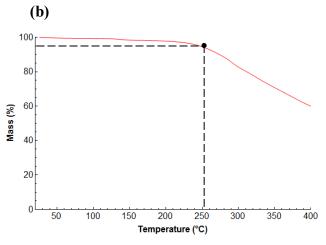


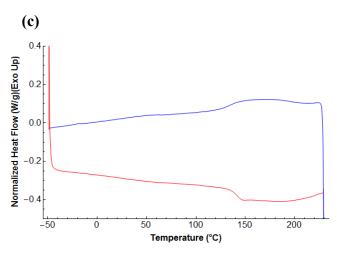

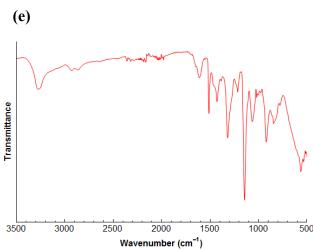
- (a) SEC trace; (b) TGA curve; (c) DSC curve;

- (d) Powder XRD patterns; (e) FT-IR (ATR) spectrum.



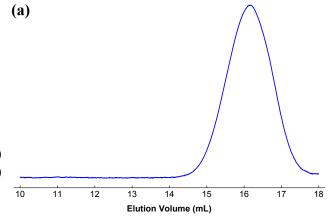


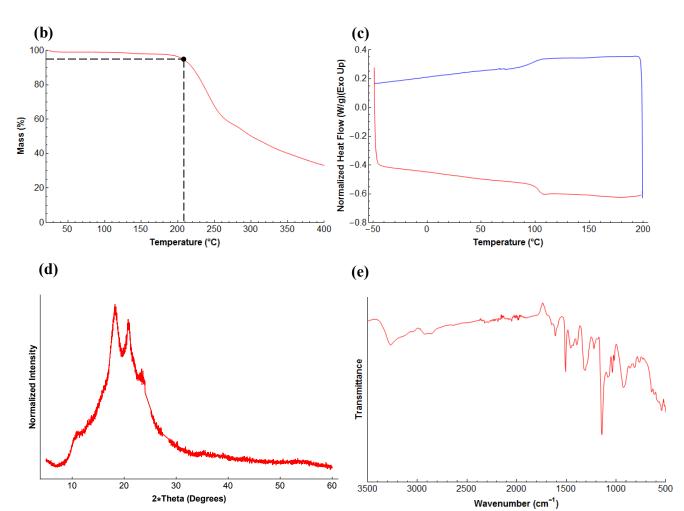

(a) SEC trace; (b) TGA curve; (c) DSC curve; (c) Powder XRD, (e) FT-IR (ATR) spectrum.





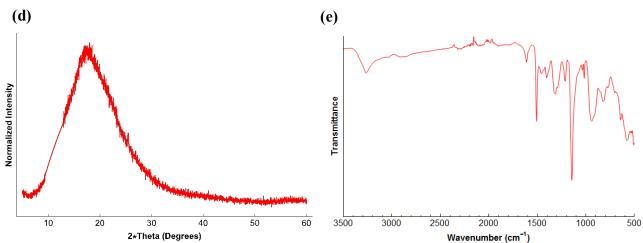
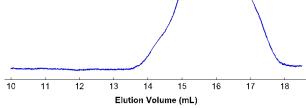
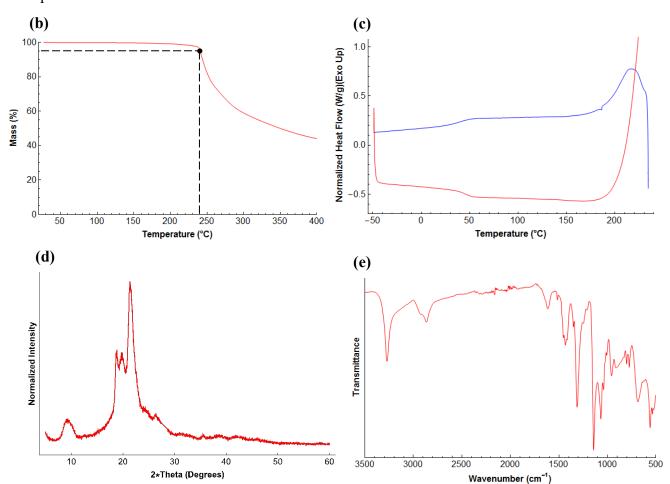

- (d) Powder XRD patterns; (e) FT-IR (ATR) spectrum.





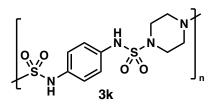
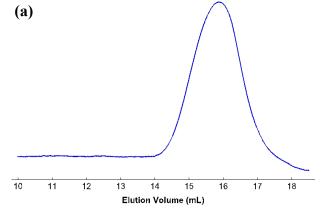
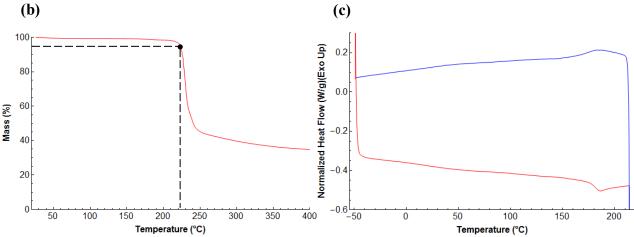


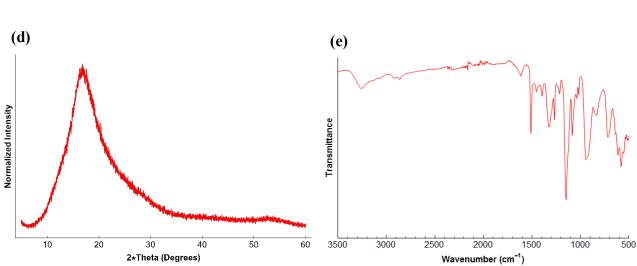

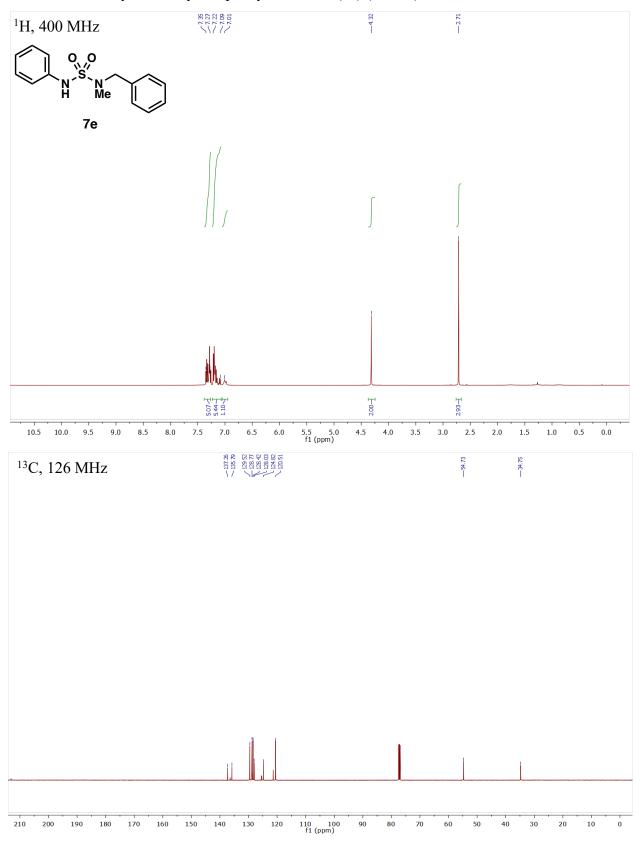
Characterization of Polysulfamide 3p(a) SEC trace; (b) TGA curve; (c) DSC curve.



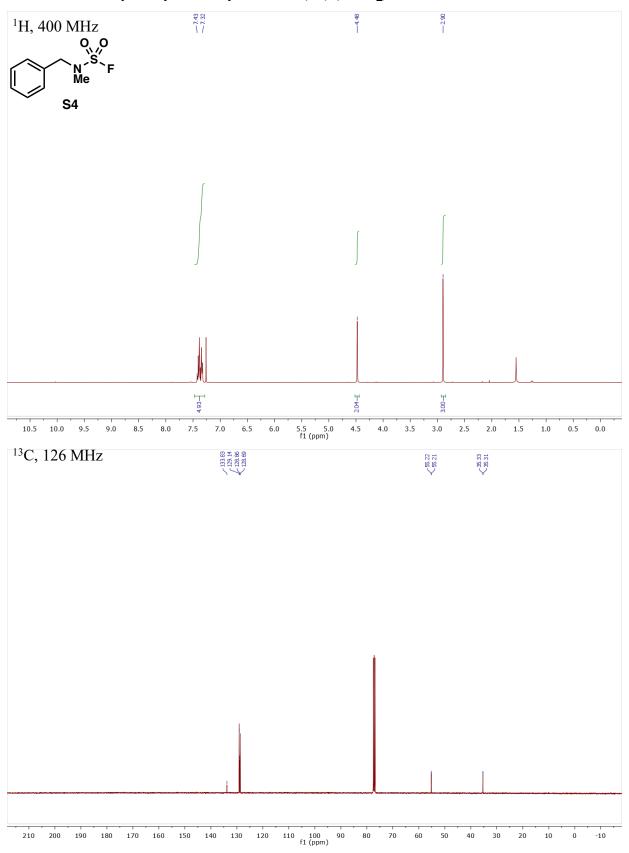
