Cleavage of a C–C bond is a diversifying process in the biogenesis of seco-terpenoids that has produced fascinating molecular structures. Leonuketal is an 8,9-seco-labdane terpenoid with a unique tetracyclic structure, owing to a C–C bond cleavage event in its biosynthesis. We report the first total synthesis of leonuketal, featuring an unusual Shapiro-type reaction as part of an enabling auxiliary ring strategy, and a novel Au-catalysed spirocyclization of a b-keto(enol)lactone.

# **Total Synthesis of (±)-Leonuketal**

ABSTRACT: Cleavage of a C-C bond is a diversifying process in the biogenesis of seco-terpenoids that has produced fascinating molecular structures. Leonuketal is an 8,9-seco-labdane terpenoid with a unique tetracyclic structure, owing to a C–C bond cleavage event in its biosynthesis. We report the first total synthesis of leonuketal, featuring an unusual Shapiro-type reaction as part of an enabling auxiliary ring strategy, and a novel Au-catalysed spirocyclisation of a β-keto(enol)lactone.

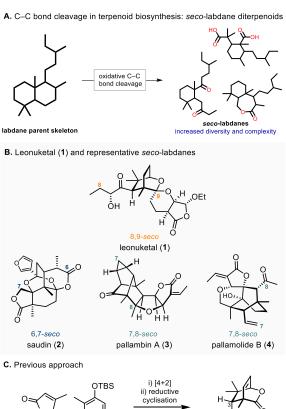


Figure 1. Background and retrosynthetic analysis; NB: numbering in 1B based on parent labdane skeleton.

Cyclization and oxidation processes are recognized as the principal drivers of complexity generation in the biosynthesis of terpenoid natural products. 1-9 However, a third mode of complexity generation involving the cleavage of a C-C bond is operative in the biogenesis of seco-terpenoids (Figure 1A). Such processes lead to increased chemical diversity in a cluster of related secondary metabolites by alteration of the parent carbon skeleton. Moreover, C-C bond cleavage is typically oxidative, and reactions facilitated by the increase in oxidation state such as ketalisation or aldol processes—lead to further skeletal rearrangement.

Leonuketal (1) is a tetracyclic 8,9-seco-labdane terpenoid marked by high stereochemical and architectural complexity chiefly owing to a C–C bond cleavage event in its biosynthesis (Figure 1B). 10 Peng and co-workers isolated 1 from Chinese liverwort (Leonurus japonicus) in 2015 and reported significant vasorelaxant activity (EC<sub>50</sub> = 2.32 mM) against KCl-induced contraction of rat aorta. 10 Leonuketal (1), and other seco-labdanes such as saudin (2), pallambin A (3), and pallamolide B (4), exemplify the structural complexity enabled by biosynthetic C-C bond cleavage (Figure 1B). 11,12 This characteristic alongside important bioactivities—has rendered seco-labdanes attractive synthetic targets and formidable testing grounds for new methodology. 13-21 We were prompted to investigate the total synthesis of leonuketal (1), a previously unmet goal, because of the challenge presented by its daunting molecular structure.

Previously, we reported the synthesis of the bridged oxabicyclic core of leonuketal (1), as lactone 5, by an efficient Diels-Alder reductive-cyclisation sequence (Figure 1C).<sup>22</sup> This strategy relied on a proposed epimerization of the C3 carbon for advancement of 5 to 1, however, a comprehensive screen of bases failed to identify conditions for the planned transformation.

Our revised retrosynthetic strategy was targeted towards late stage spiroketal 7, which we recognized would provide access to 1 by incorporation of the C3 hydroxybutanone chain and elaboration of the lactone moiety (Figure 1D). We planned to assemble the spirocyclic core of 7 by Au-mediated cyclisation of alkyne 8, which could be accessed from halide 9 through appendage of the lactone moiety by alkylation.<sup>23</sup>

#### Scheme 1. Total synthesis of $(\pm)$ -leonuketal

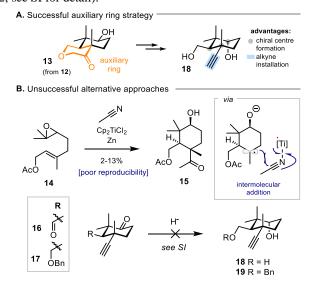
*Reagents and conditions:* a) Cp<sub>2</sub>TiCl<sub>2</sub> (2.2 eq), Zn (4.6 eq), THF, 60 °C, 1 h *then* aq. Efficient synthesis of the alkyne-substituted cyclohexanol ring of **9** posed a challenge. While related cyclohexanols have been assembled from geraniol derivatives, we sought an efficient method to incorporate the requisite alkynyl moiety. <sup>24–32</sup> To this end, we developed an auxiliary ring strategy wherein *bicyclic* ketone **11** was used as a synthetic linchpin for the construction of *monocyclic* alkyne **9** (Figure 1D and Figure 2A). Bicyclic ketone **11** could, in turn, be disconnected to epoxide **12**, a derivative of geraniol, by a Ti(III)-mediated radical cyclisation.

Our synthesis thus began with treatment of epoxide 12 with *in situ* generated Cp<sub>2</sub>TiCl, efficiently affording bicyclic ketone 13 after acidic hydrolysis (Scheme 1).<sup>33–37</sup> This transformation, while proceeding in modest yield (32%), was found to scale up easily (6.5 g), and afforded reliable access to diastereomerically-pure ketone 13.<sup>38</sup> Preliminary investigations revealed that the complementary cyclization employing epoxide 14—terminating with *intermolecular* addition to acetonitrile—was found to be capricious and low yielding (Figure 2B).<sup>39</sup>

Next, epimerization of the C7 alcohol of 13 was achieved by an oxidation-reduction sequence, first requiring protection of the C4 ketone. Following ketal protection, the C7 alcohol was oxidized with DMP, then reduced with L-selectride®—affording desired epimer 11 after ketal deprotection. Attempts to effect alcohol epimerization on more advanced intermediates 16 and 17 in exploratory studies, which would have circumvented

the necessary ketone protection-deprotection steps, returned either unreacted starting material or the undesired epimer (Figure 2; see SI for detail).

Such substrates lacked the rigidifying auxiliary pyran ring of 13, and as a result, exhibited more conformational freedom. Indeed, the diastereoselectivity observed for formation of 11 may have been enhanced by the rigidity imposed by the auxiliary ring, encouraging equatorial approach of L-selectride® and preventing ring-flipping of the ketone.

With alcohol **11** in hand, attention was turned to cleavage of the auxiliary pyran ring and formation of the requisite alkyne motif. Both transformations were simultaneously achieved by exploitation of an unusual Shapiro-type fragmentation reaction. <sup>40</sup> To this end, **11** was converted to an intermediate tosyl hydrazone, which was subsequently treated with methyl lithium, resulting in formation of alkyne **18** in 89% yield over two steps. <sup>41</sup> This process likely proceeded *via* generation of vinyl lithium **20**, which subsequently underwent  $\beta$ -elimination. This sequence enabled the synthesis of **18** in 7 steps on gram-scale. Our auxiliary ring strategy parallels the synthesis of *seco*-terpenoids in general, wherein ring-deconstruction is leveraged as an enabling (bio)synthetic tool.

With scalable access to alkyne **18** secured, focus was placed on construction of the caged spiroketal core of leonuketal (**1**). To this end, the iodide derived from **21** was synthesized over 3 steps by hydroxymethylation of **18**, followed by mesylation and iodination. The subsequent alkylation of the iodide required some investigation. Initially, we examined the Frater-Seebach alkylation with  $\beta$ -hydroxyesters, which generally resulted in decomposition of the nucleophile, returning starting material. Acceptable P-ketoester nucleophiles. Interestingly, cyclic  $\beta$ -ketoesters afforded exclusively *O*-alkylation products, however, acyclic  $\beta$ -ketoesters, such as **10**, proved to be competent *C*-nucleophiles. Accordingly, known  $\beta$ -ketoester **10** was treated with sodium hydride and the iodide derived from **21**, smoothly affording alkyne **22** in 85% yield.

At this juncture, we identified two possible avenues for construction of the spiroketal and the C7, C10, and C11 stereocentres of leonuketal (1). Typically, dihydroxy alkynes are employed in Au-catalysed spiroketalizations. However, 22 was a mixture of C10 epimers and reduction of the C11 ketone would likely have afforded four diastereomers. Instead, we elected to explore the Au-catalysed spiroketalization of  $\beta$ -ketoester 22 without first reducing the C11 ketone. This transformation of  $\beta$ -ketoesters had not, to the best of our knowledge, been reported previously.

Initial investigations yielded the desired spiroketal product upon treatment of 22 with Au(I)-complexes, however, these results had poor reproducibility and often resulted in decomposition of the substrate. We therefore sought an alternative spiroketal precursor.

TBS deprotection and lactonisation of **22** afforded cyclic  $\beta$ -keto(enol)lactone **8**, as an alternative spiroketalization substrate. To our delight, treatment of **8** with AuCl·DMS and PPTS reliably delivered spiroketal **7** in 65% yield and 9:1 dr, thereby demonstrating this previously unexplored class of substrates to be viable Au-catalyzed spiroketalization precursors.

Investigation of  $\bf 8$  as a spiroketalization substrate was prompted by considering the loss of entropy incurred by formation of the rigid caged spirocycle. Straight-chain  $\beta$ -ketoester  $\bf 22$  had greater conformational freedom than the cyclic congener  $\bf 8$ . Hence, the loss of entropy upon forming  $\bf 7$  from  $\bf 8$ , particularly in preventing rotation of the C10-11 bond, would have

been less than for the spiroketalization of straight-chain substrate 22. This substrate modification proved instrumental to the reliable formation of the caged spiroketal of 1.

The next challenge in our total synthesis was the diastereose-lective reduction of the enol ether of **7**. We posited that hydrogenation at the  $\alpha$ -face could be achieved if a haptophilic effect of the posterior spiroketal oxygen (Scheme 1, *green*) directed adsorption of **7** at this face of the molecule.<sup>44</sup> Rhodium on alumina proved to be a competent catalyst for hydrogenation of **7** at elevated pressure (65 psi), however, no diastereoselectivity was observed regardless of solvent choice.<sup>45,46</sup> Hence, the desired  $\alpha$ -face addition product **23** and diastereomer **24** were obtained as a 1:1.2 mixture, which unfortunately could not be separated. Interestingly, undesired diastereomer **24** corresponds to  $\beta$ -face hydrogenation followed by epimerization of the spiroketal (C7). This result indicated an interplay between the C7, C10, and C11 stereocentres in which the more stable spiroketal epimer was influenced by the C10-11 configuration.

The diastereomeric mixture 23-24 was then advanced to the fully elaborated ketal- $\gamma$ -lactone portion of leonuketal (1). This was achieved by lactone hydrolysis, oxidation of the liberated alcohol, and acid-mediated acetalization to afford 25 as a single C12 epimer in 84% yield over three steps. At this point, the desired diastereomer 25 could be separated from the product derived from 24 (not shown). The securing of 25 completed the unique tetracyclic core of leonuketal (1) and all but one chiral centre for the total synthesis. An *X*-ray structure of 25 allowed us to confirm the stereochemical configuration matched that of leonuketal (1).

With 25 in hand, the endgame of our total synthesis could be investigated. Deprotection of 25 proceeded smoothly at slightly elevated temperature, and the free alcohol was oxidized with DMP immediately to prevent possible transketalization. The aldehyde was treated with propylmagnesium bromide, then oxidized directly to afford deoxyleonuketal (26) in 57% yield over 4 steps. α-Hydroxylation of the newly formed ketone **26** was the final step in completion of the total synthesis and required some investigation (see Table S4 and S5, SI). Deprotonation of **26** with LiHMDS followed by treatment with (1S)-(+)-(10-camphorsulfonyl)oxaziridine effected the desired oxidation, but favoured the formation of 15-epi-leonuketal (epi-1) with a 9:1 dr. Surprisingly, the use of Davis' oxaziridine under analogous conditions delivered no detectable amount of 1 or epi-1 at either full or partial completion of the reaction. Fortunately, bubbling molecular oxygen through a solution of deprotonated 26 delivered leonuketal (1), alongside 15-epi-leonuketal (epi-1), in 48% yield (60% brsm) and 1:1 dr after reductive workup. Leonuketal (1) was separated from epi-1 by reverse phase HPLC, and to our delight, the NMR data were in good agreement with the isolation report (Table S6 and S7, SI).

In summary, we report the first total synthesis of complex seco-labdane leonuketal (1) over 23 steps from 12. Our strategy featured an unusual Shapiro-type fragmentation as part of an enabling auxiliary ring strategy, as well as a novel Au-catalysed spirocyclization of a  $\beta$ -keto(enol)lactone. This work highlights the role of C–C bond cleavage in the biogenesis of complex terpenoids and demonstrates that the total synthesis of these molecules remains an exciting challenge.

### 1. Intermolecular nitrile termination: cyclisation of 14 to afford 15

The Ti(III)-mediated cyclization to afford of **14** to afford **15**, proceeding with intermolecular addition to acetonitrile, was investigated in early studies.

Initially, a solution of Cp<sub>2</sub>TiCl in tetrahydrofuran was added to a solution of epoxide **14** and acetonitrile (10 eq) in tetrahydrofuran at rt, resulting in a complex mixture of products with incomplete conversion (Table S1, entry 1). Dropwise addition of the Cp<sub>2</sub>TiCl solution over 10 minutes under otherwise identical conditions also resulted in a complex mixture (entry 2). Decreasing the temperature of the reaction to 0 °C stifled reactivity completely, returning starting material **14** after 6 hours (entry 3). Dropwise addition of the Cp<sub>2</sub>TiCl solution over 1 hour lead to the formation of a discernible amount of desired product **15** (13%) after acidic work up with aqueous potassium phosphate, however, conversion was incomplete (entry 4). To increase the conversion and yield of the reaction, both increased equivalents of acetonitrile (50 eq) and Cp<sub>2</sub>TiCl (3.3 eq) were trialled, leading unfortunately to decreased yield of the desired product in both cases (5% and 2% respectively, entries 5 & 6). At this juncture, the best conditions (entry 4) were repeated to establish the reproducibility of the results. Unfortunately, the initially observed 13% yield of ketone **15** was not reproduced, and the product was isolated in 2% and 7% yield on first and second repeats with identical scale (0.5 mmol, entries 7 & 8).

Given the low and irreproducible yields of ketone **15** afforded by treatment of epoxide **14** with Cp<sub>2</sub>TiCl in presence of acetonitrile, this approach was abandoned.

#### 4. General Methods

Commercially available reagents were used throughout without purification unless otherwise stated. Anhydrous solvents were used as supplied. Diethyl ether, tetrahydrofuran, dichloromethane, acetonitrile, 1,4-dioxane, dimethylformamide and toluene were dried using an LC Technology Solutions Inc. SP-1 solvent purification system under an atmosphere of dry nitrogen. All reactions were routinely carried out in oven-dried glassware under a nitrogen atmosphere unless otherwise stated. Analytical thin layer chromatography was performed using silica plates and compounds were visualised at 254 and/or 360 nm ultraviolet irradiation followed by staining with either alkaline permanganate or ethanolic vanillin solution. Infrared spectra were obtained using a Perkin Elmer spectrum One Fourier Transform Infrared spectrometer. Absorption maxima are expressed in wavenumbers (cm<sup>-1</sup>). Melting points were recorded on an Electrothermal melting point apparatus and are uncorrected. NMR spectra were recorded as indicated on an NMR spectrometer operating at 500, 400 and 300 MHz for <sup>1</sup>H nuclei and 125, 101 and 75 MHz for <sup>13</sup>C nuclei. Chemical shifts are reported in parts per million (ppm) relative to the tetramethylsilane peak recorded as δ 0.00 ppm in CDCl<sub>3</sub>/TMS solvent, or the residual, chloroform (δ 7.26 ppm), or DMSO (δ 2.50 ppm) peaks. The <sup>13</sup>C NMR values were referenced to the residual acetone, chloroform (δ 77.16 ppm) or DMSO (δ 39.52 ppm) peaks. <sup>13</sup>C NMR values are reported as chemical shift δ and assignment. <sup>1</sup>H NMR shift values are reported as chemical shift  $\delta$ , relative integral, multiplicity (s, singlet; d, doublet; t, triplet; q, quartet; m, multiplet), coupling constant (*J* in Hz) and assignment. Assignments are made with the aid of COSY, NOESY, HSQC, and HMBC experiments. All experiments were conducted at 298 K. Conventional NMR tubes (5 mm diameter, Norell) using a sample volume of 500 µL were used. High resolution mass spectra were obtained by electrospray ionisation in positive ion mode at a nominal accelerating voltage of 70 eV on a microTOF mass spectrometer.

#### 5. Experimental Procedures: Total synthesis of leonuketal

#### Nitrile S6



To a stirred suspension of NaH (9.66 g, 60% dispersion in mineral oil, 242 mmol) in THF (200 mL) at rt was added geraniol (23.3 mL, 134 mmol) dropwise. The resulting solution was heated to reflux for 2.5 h, then allowed to cool to rt, and bromoacetonitrile (15.0 mL, 215 mmol) was added by syringe pump over 2.5 h. After stirring at rt for 48 h, NaH (4.50 g, dispersion in mineral oil, 113 mmol) was added and the resulting mixture was stirred for a further 1 h at rt before addition of more bromoacetonitrile (2.67 mL, 38.3 mmol) by syringe pump over 2.5 h. The reaction mixture was allowed to stir for a further 24 h before quenching with MeOH (5 mL). The reaction mixture was filtered through silica. The silica was washed with 1:1 EtOAc-pet. ether (250 mL, v/v) then the filtrate was concentrated in vacuo. The resultant crude oil was purified by short path distillation (1 mbar, 80–110 °C) to give nitrile **S6** (21.9 g, 84%) as a yellow oil.

To a stirred solution of nitrile **S6** (9.80 g, 50.7 mmol) in THF-H<sub>2</sub>O (2.0 L, 2:1 v/v) at 0 °C was added NBS (11.4 g, 65.9 mmol) as a solution in THF-H<sub>2</sub>O (115 mL, 2:1 v/v) dropwise over 1 h. The reaction mixture was stirred at 0 °C for 1 h before the addition of sat. aq. Na<sub>2</sub>S<sub>2</sub>O<sub>3</sub> (130 mL). K<sub>2</sub>CO<sub>3</sub> (35.3 g, 254 mmol) and MeOH (265 mL) were then added and the resulting mixture was allowed to warm to rt and stir overnight. The majority of organic solvent was removed under reduced pressure and the residue was extracted with EtOAc (3 × 200 mL). The combined organic phases were washed with brine (80 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and concentrated in vacuo. The crude oil was then purified by flash chromatography (15-45% EtOAc in pet. ether) to afford the epoxide **12** as a clear oil (7.71 g, 73%).

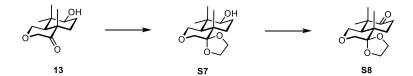


A mixture of Cp<sub>2</sub>TiCl<sub>2</sub> (17.8 g, 71.4 mmol) and Zn dust (9.34 g, 142 mmol) in rigorously deoxygenated THF (100 mL) was stirred at rt for 15 min.<sup>2</sup> The resulting green solution was then added dropwise over 1 h *via* syringe pump to a stirred solution of epoxide **12** (6.50 g, 31.1 mmol) in deoxygenated<sup>2</sup> THF (1.1 L) at 60 °C. After 1 hour, sat. aq. KH<sub>2</sub>PO<sub>4</sub> (200 mL) was added and the resulting mixture was stirred at rt for 30 mins. The biphasic mixture was filtered over Celite® and the filtrate was washed with EtOAc (2 × 100 mL). The aqueous phase of the filtered mixture was separated and extracted with Et<sub>2</sub>O (2 × 200 mL). The combined organic phases were washed with sat. aq. NaHCO<sub>3</sub> (200 mL), brine (200 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and concentrated in vacuo. The crude mixture was purified by flash chromatography (20-50% EtOAc in pet. ether) to give the product as a clear oil (2.11 g, 32%).

A stirred solution of ketone **13** (3.40 g, 16.0 mmol), p-TsOH·H<sub>2</sub>O (138 mg, 0.80 mmol) and ethylene glycol (13.4 mL, 240 mmol) in benzene (40 mL) was refluxed with a Dean-Stark apparatus for 4 h, then allowed to cool to rt. A solution of sat. aq. NaHCO<sub>3</sub> (50 mL) was added to the reaction mixture, the organic phase was separated, and aqueous phase was extracted with EtOAc (3 × 50 mL). The combined organic phases were washed with brine (50 mL), dried over MgSO<sub>4</sub>, and concentrated in vacuo.

The crude oil of **\$7** was dissolved in  $CH_2Cl_2$  (50 mL), then pyridine (3.21 mL, 39.8 mmol) and DMP (8.44 g, 19.9 mmol) were added sequentially. Resulting mixture was allowed to stir at rt for 1 h then sat. aq.  $NaS_2O_3$  (50 mL) was added. The organic phase was separated, and the aqueous phase was extracted with  $CH_2Cl_2$  (3 × 50 mL). The combined organic phases were washed with sat. aq.  $CuSO_4$  (50 mL), 0.1 M EDTA (50 mL), 1 M NaOH (50 mL) then finally brine (50 mL). The organic phases were then dried over  $Na_2SO_4$  and concentrated in vacuo. The crude oil was then purified by flash chromatography (50% EtOAc in pet. ether) to give ketone **\$8** (2.59 g, 77% over two steps) as a clear oil.

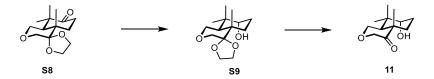

To a stirred solution of ketone **S8** (4.36 g, 17.1 mmol) in THF (120 mL) at –78 °C was added L-Selectride<sup>®</sup> (37.7 mL, 37.7 mmol, 1.0 M in THF) dropwise. The resulting solution was stirred at this temperature for 1 h before allowing to warm to rt and stir for a further 45 min. Sat. aq. NH<sub>4</sub>Cl (80 mL) was then added slowly and the aqueous phase of the resulting mixture was extracted with EtOAc (2 × 100 mL). The combined organic phases were then washed with brine (100 mL) and concentrated in vacuo.

The crude oil of **S9** was then dissolved in 3 M HCI-THF (150 mL, 3:1, v/v) and the resulting mixture was heated to 40 °C and stirred 16 h, before being allowed to cool to rt. EtOAc (150 mL) was added to the reaction mixture and the organic phase was collected. The aqueous phase was then extracted with EtOAc (2 × 80 mL) and the combined organic phases were washed with brine (100 mL), dried over NaSO<sub>4</sub>, and concentrated in vacuo. 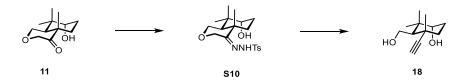

To a stirred suspension of NaH (876 mg, 21.9 mmol, 60% dispersion in mineral oil) in THF (20 mL) at 0 °C was added BnBr (1.14 mL, 11.0 mmol) dropwise. To alcohol **21** (298 mg, 0.77 mmol) and Et<sub>3</sub>N (171  $\mu$ L, 1.23 mmol) in CH<sub>2</sub>Cl<sub>2</sub> (11 mL) at 0 °C was added a solution of MsCl (65  $\mu$ L, 0.84 mmol) in CH<sub>2</sub>Cl<sub>2</sub> (1.3 mL) dropwise over 10 min. The reaction mixture was allowed to stir at 0 °C for 30 min, then H<sub>2</sub>O (15 mL) was added. The organic phase was then separated, and the aqueous phase was extracted with CH<sub>2</sub>Cl<sub>2</sub> (2 × 15 mL). The combined organic phases were then dried over Na<sub>2</sub>SO<sub>4</sub> and concentrated in vacuo.

The crude oil was then dissolved in acetone (11 mL) and NaI (230 mg, 1.53 mmol) was added. The resultant mixture was protected from light and stirred at rt for 16 h. The reaction mixture was then filtered over Celite<sup>®</sup> and the solid residue was washed with Et<sub>2</sub>O (2 × 10 mL). To TBS ether **22** (190 mg, 0.30 mmol) in MeOH (8 mL) at rt was added TsOH·H<sub>2</sub>O (5 mg, 0.03 mmol) as a solution in MeOH (200  $\mu$ L). The reaction mixture was stirred at rt for 16 h, then K<sub>2</sub>CO<sub>3</sub> (126 mg, 0.91 mmol) was added, and the resultant mixture was stirred at rt for a further 4 h. The reaction mixture was diluted with EtOAc (40 mL) and washed with sat. aq. NH<sub>4</sub>Cl (20 mL). 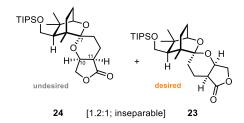
#### Spiroketal 7

To a solution of AuCI-DMS (10 mg, 0.035 mmol) and PPTS (0.9 mg, 0.0035 mmol) in degassed MeOH (18 mL) at rt was added enol **7** (220 mg, 0.35 mmol) as a solution in degassed MeOH (4.5 mL) over 1 h. The resulting mixture was stirred at rt for 60 h, then quenched by addition of Et<sub>3</sub>N (0.1 mL), then concentrated in vacuo. The residue was purified by flash chromatography (5% Et<sub>2</sub>O in pet. ether) to afford an inseparable mixture of the spiroketal **7** and spiroketal *epi-***7** (143 mg, *dr* 9:1 **7** to *epi-***7**, 65% combined yield) as a clear oil.

A suspension of **7** (157 mg, 0.022 mmol, mixture of C7 epimers 9:1) and 5% Rh-Al<sub>2</sub>O<sub>3</sub> (53 mg, 0.04 mmol, *w/w*) in MeOH (45 mL) was stirred at rt under an atmosphere of H<sub>2</sub> (65 psi, Parr hydrogenator) for 60 h. The suspension was then filtered and concentrated in vacuo to afford a mixture of spiroketal **23** and spiroketal **24** (154 mg, 1:1.2 **23-24**, 98% combined yield) as a clear oil.

#### Spiroketal 25; spiroketal S5

A solution of **23-24** mixture (96 mg, 0.094 mmol **23**; 0.11 mmol **24**) in 1 M LiOH-THF (1:3, v/v, 10 mL) was stirred at rt for 16 h, then diluted with 1 M HCl (10 mL) and extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 15 mL). The combined organic phases were dried over Na<sub>2</sub>SO<sub>4</sub> and concentrated in vacuo.

The crude oil was dissolved in  $CH_2Cl_2$  (2 mL), DMP was added (174 mg, 0.41 mmol), and the resulting mixture was stirred at rt. After 30 min 5 %  $Na_2S_2O_3$  (5 mL, w/v) was added, and the reaction mixture was extracted with  $CH_2Cl_2$  (3 × 10 mL). The combined organic phases were dried over  $Na_2SO_4$  and concentrated in vacuo.

The crude oil was dissolved in EtOH (15 mL) and PPTS (51 mg, 0.20 mmol) was added. The resulting solution was stirred for 24 h at 45 °C. Sat. aq. NaHCO<sub>3</sub> was then added (40 mL) and the reaction mixture was extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 50 mL). The combined organic phases were dried over Na<sub>2</sub>SO<sub>4</sub>, concentrated in vacuo, and purified by flash chromatography (5-35% Et<sub>2</sub>O in pet ether) to afford spiroketal **25** (40 mg, 84% over four steps) and spiroketal **S5** (14 mg, 24% over four steps) as clear oils.

### Deoxyleonuketal (26)

To TIPS ether **26** (38.5 mg, 0.075 mmol) in THF (2 mL) at rt was added TBAF (0.38 mL, 0.38 mmol, 1.0 M in THF). The resulting mixture was heated to 40 °C and stirred for 2 hours, before cooling to rt. Sat. aq. NaHCO<sub>3</sub> (10 mL) was then added, and the resulting mixture was extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 10 mL). The combined organic phases were washed with brine (10 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and concentrated in vacuo to give the putative alcohol **S19** as a crude oil.

The crude material of **S19** was immediately dissolved in CH<sub>2</sub>Cl<sub>2</sub> (2 mL) then K<sub>2</sub>CO<sub>3</sub> (72 mg, 0.53 mmol) and DMP (128 mg, 0.30 mmol) were added. The resulting mixture was stirred at rt for 30 min, then quenched by addition of 5% aq. sodium thiosulfate (5 mL, w/w). The resulting mixture was then extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 10 mL). The combined organic phases were washed with brine (10 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and concentrated in vacuo. The resulting oil was filtered through a short plug of silica eluting with 40% Et<sub>2</sub>O in pet. ether, delivering putative aldehyde **S20** (~18 mg, ~0.05 mmol) which was used in the following step immediately.

To the aldehyde **S20** (~18 mg, ~0.05 mmol) in THF (1 mL) at 0 °C was added propylmagnesium bromide (74  $\mu$ L, 0.093 mmol, 1.25 M in diethyl ether). The resulting solution was stirred for 1 h at 0 °C, then quenched by addition of H<sub>2</sub>O (3 mL). The mixture was extracted with Et<sub>2</sub>O (3 × 5 mL) and the combined organic phases were dried over Na<sub>2</sub>SO<sub>4</sub>, then concentrated in vacuo to afford the crude putative alcohol **S21**.

The crude material of **S21** was immediately dissolved in CH<sub>2</sub>Cl<sub>2</sub> (1 mL), then K<sub>2</sub>CO<sub>3</sub> (50 mg, 0.36 mmol) and DMP (88 mg, 0.21 mmol) were added. The resulting mixture was stirred at rt for 30 min, then quenched by addition of 5% aq. sodium thiosulfate (5 mL, w/w). The resulting mixture was then extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 5 mL). The combined organic phases were washed with brine (10 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and concentrated in vacuo. The crude residue was purified by flash chromatography (20% Et<sub>2</sub>O in pet ether) to afford deoxyleonuketal (**26**) (15.4 mg, 57% over four steps) as a clear oil.

#### Leonuketal (1)

To a stirred solution of deoxyleonuketal (26) (2.0 mg, 0.0051 mmol) in THF (0.6 mL) at -78 °C under argon was added LiHMDS (23 µL, 0.020 mmol, 0.9 M in THF). The resulting solution was stirred for 10 min at -78 °C, then oxygen was bubbled through the solution for 30 min at -78 °C. The reaction vessel headspace was then flushed with argon for 10 min, then another portion of LiHMDS (56 μL, 0.051 mmol, 0.9 M in THF) was added. The resulting solution was stirred for 10 min at -78 °C, then oxygen was bubbled through the solution for 1 h at -78 °C. The reaction vessel headspace was then flushed again with argon for 10 min, and a final portion of LiHMDS (113 μL, 0.101 mmol, 0.9 M in THF) was added. The resulting solution was stirred for 10 min at -78 °C, then oxygen was bubbled through the solution for 1 h at -78 °C. P(OEt)<sub>3</sub> (5 μL, 0.030 mmol) was then added and the reaction was stirred for 30 min at -78 °C, before being quenched by addition of sat. aq. NH<sub>4</sub>Cl (2 mL). The organic phase was separated, and the aqueous phase was extracted with Et<sub>2</sub>O (3 × 4 mL). The combined organic phases were dried over MgSO<sub>4</sub> and concentrated in vacuo. The crude mixture was then purified by flash chromatography (30% Et<sub>2</sub>O in pet. ether) to give recovered deoxyleonuketal (26) (0.4 mg), and a mixture of leonuketal 1 and 14-epi-leonuketal (epi-1) (1.0 mg, 48% combined, 60% brsm, 1:1 dr). An analytical sample of leonuketal (1) was purified by RP-HPLC (Phenomenex Gemini® C18 column, 5 μm, 110 Å, 250 x10 mm) using a gradient of H<sub>2</sub>O:MeOH (40 - 100% B over 80 min, 3 mL/min) detecting at 210 nm ( $t_R = 34.4 \text{ min}$ ).

NB: While the dr of the reaction was typically 1:1, we observed a 2:1 dr in favour of leonuketal (1) at low conversion.

#### 6. Experimental Procedures: Additional compounds

### Epoxide 14

To a stirred solution of geranyl acetate (9.80 g, 50.1 mmol) in  $CH_2Cl_2$  (100 mL) at 0 °C was added m-CPBA (11.3 g, 50.3 mmol, 77% w/w). After 1 h, the solution was allowed to warm to rt and 3 M NaOH (25 mL) was added. The organic phase was separated, and the aqueous phase was extracted with  $CH_2Cl_2$  (3 × 25 mL). The combined organic phases were then washed with brine (2 × 30 mL), dried over MgSO<sub>4</sub>, and concentrated in vacuo. The crude oil was purified by flash chromatography (15% EtOAc in pet. ether) to afford the epoxide **14** (7.25 g, 68%) as a clear oil.

Spectroscopic data were in good agreement with those previously reported.8

#### Ketone 15

A mixture of Cp<sub>2</sub>TiCl<sub>2</sub> (272 mg, 1.1 mmol, 2.2 equiv) and Zn dust (215 mg, 3.3 mmol, 6.6 equiv) in deoxygenated<sup>9</sup> THF (5 mL) was stirred at rt for 15 min. The resulting green solution was then added dropwise over 1 h *via* syringe pump to a stirred solution of epoxide **14** (110 mg, 0.50 mmol) in deoxygenated THF (5 mL) at rt. After 6 h, the reaction mixture was quenched with sat. aq. KH<sub>2</sub>PO<sub>4</sub> solution (10 mL). The mixture was stirred for an additional 30 min then filtered over Celite<sup>®</sup> to remove insoluble titanium salts. The filtrate was then washed with EtOAc (2 × 20 mL) and the combined

organic phases were washed with sat. aq. NaHCO<sub>3</sub> (10 mL), brine (10 mL), dried over MgSO<sub>4</sub>, and concentrated *in vacuo*. The crude oil was purified by flash chromatography (50% EtOAc in pet. ether) to give ketone **15** as an oil (16 mg, 13%).

### Tosyl hydrazone **S22**

To ketone **13** (345 mg, 1.63 mmol) and *p*-toluenesulfonyl hydrazide (303 mg, 1.63 mmol) in THF (3 mL) at rt was added PPTS (2 mg, 0.08 mmol). The resulting solution was allowed to stir at rt for 16 h. The mixture was then diluted in EtOAc (100 mL) and washed with H<sub>2</sub>O (10 mL), then brine (10 mL), dried over MgSO<sub>4</sub>, and concentrated in vacuo to give tosyl hydrazone **S22** as a white powder (583 mg, 94%).

A solution of MeLi (2.09 mL, 4.18 mmol, 2.0 M in dimethoxyethane) was added to Et<sub>2</sub>O (5 mL) at 0 °C. To the resulting stirred solution was added dropwise a suspension of *p*-toluenesulfonyl hydrazone **S22** (256 mg, 0.70 mmol) in THF (5 mL) over 10 min. The resulting mixture was stirred at 0 °C for a further 1.5 h before the addition of H<sub>2</sub>O (15 mL). The mixture was then extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 30 mL) and the combined organic phases were washed with brine (40 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and then concentrated in vacuo. The crude oil was then purified by flash chromatography (40% EtOAc in pet. ether) to give alcohol **S1** (128 mg, 94%) as a clear oil.

To a solution of alcohol **S1** (85 mg, 0.43 mmol) in  $CH_2Cl_2$  (2.5 mL) at rt was added  $K_2CO_3$  (479 mg, 3.46 mmol) and DMP (643 mg, 1.52 mmol). The reaction mixture was stirred for 1 h before addition of sat. aq.  $Na_2S_2O_3$  (5 mL) and extraction with EtOAc (3 × 5 mL). The combined organic phases were then washed with brine, dried over  $Na_2SO_4$  and concentrated in vacuo. #### Benzyl ether \$3 and \$23

To a solution of alcohol **S1** (20 mg, 0.10 mmol) and TBAI (cat.) in THF (1 mL) at rt was added NaH (8 mg, 60% dispersion in mineral oil, 0.20 mmol) and benzyl bromide (13  $\mu$ L, 0.11 mmol). The reaction mixture was stirred for 16 h before addition of sat. NH<sub>4</sub>Cl (10 mL) and extraction with EtOAc (3 × 10 mL). To a solution of alcohol **S3** (10 mg, 0.05 mmol) in CH<sub>2</sub>Cl<sub>2</sub> (1 mL) at rt was added K<sub>2</sub>CO<sub>3</sub> (56 mg, 0.41 mmol) and DMP (76 mg, 0.18 mmol). The reaction mixture was stirred for 1 h before addition of sat. aq. Na<sub>2</sub>S<sub>2</sub>O<sub>3</sub> (2 mL) and extraction with EtOAc (3  $\times$  3 mL). #### Spiroketal **S4**

To TIPS ether **\$5** (42 mg, 0.082 mmol) in THF (4 mL) at rt was added TBAF (0.41 mL, 0.41 mmol, 1.0 M in THF). The resulting mixture was heated to 40 °C and stirred for 2 hours, before cooling to rt. Sat. aq. NaHCO<sub>3</sub> (10 mL) was then added, and the resulting mixture was extracted with  $CH_2Cl_2$  (3 × 10 mL). The combined organic phases were washed with brine (10 mL), dried over  $Na_2SO_4$ , and concentrated in vacuo to give the alcohol as a crude oil.

The crude material was immediately dissolved in CH<sub>2</sub>Cl<sub>2</sub> (2 mL) then K<sub>2</sub>CO<sub>3</sub> (72 mg, 0.53 mmol) and DMP (140 mg, 0.33 mmol) were added. The resulting mixture was stirred at rt for 30 min, then quenched by addition of 5% aq. sodium thiosulfate (5 mL, w/w). The resulting mixture was then extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 × 10 mL). The combined organic phases were washed with brine (10 mL), dried over Na<sub>2</sub>SO<sub>4</sub>, and concentrated in vacuo. The resulting oil was filtered through a short plug of silica eluting with 40% Et<sub>2</sub>O in pet. ether, delivering putative aldehyde **S24** (~16 mg) which was used in the following step immediately.

To the aldehyde **S24** (~16 mg) in THF (1 mL) at 0 °C was added propylmagnesium bromide (51  $\mu$ L, 0.063 mmol, 1.25 M in diethyl ether). The resulting solution was stirred for 1 h at 0 °C, then quenched by addition of H<sub>2</sub>O (3 mL). The mixture was extracted with Et<sub>2</sub>O (3 × 5 mL) and the combined organic phases were dried over Na<sub>2</sub>SO<sub>4</sub>, then concentrated in vacuo to afford the crude alcohol.

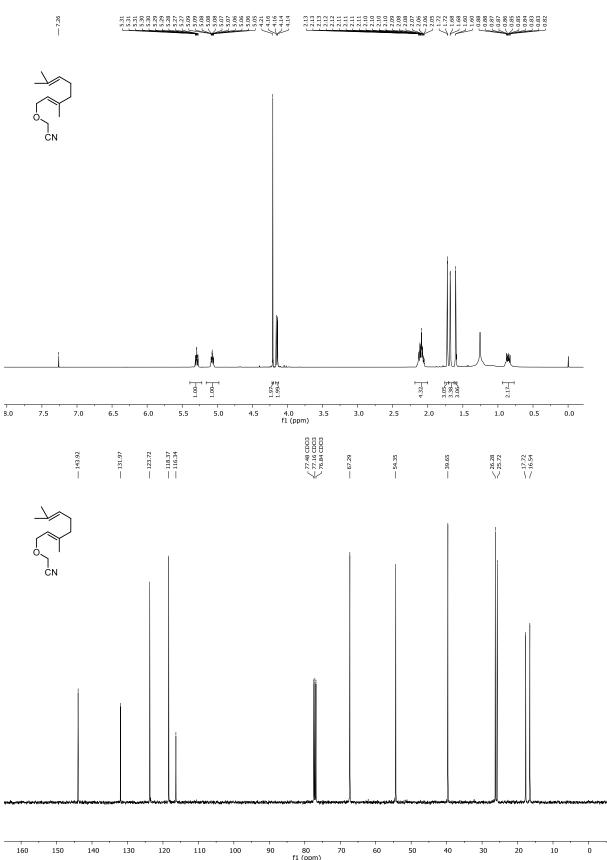
