All teachers in our school hold qualified teacher status and have a range of experience in supporting pupils with special educational needs and disabilities in a mainstream setting. Below, you will find useful information about how our school supports pupils with SEND and their families and the procedures we implement. ### A. PEOPLE WHO SUPPORT CHILDREN WITH SPECIAL EDUCATIONAL NEEDS/ AND OR DISABILITIES IN THIS SCHOOL:

And how can I talk to them about my child if I need to?</b></p>	<p style="text-align: center;"><b>Class/subject teacher</b></p>	<p><b>They are responsible for:</b></p> <ul style="list-style-type: none"> <li>• Ensuring that all children have access to good/outstanding teaching and that the curriculum is adapted to meet your child's individual needs (also known as differentiation).</li> <li>• Checking on the progress of your child and identifying, planning and delivering any additional help your child may need (this could be things like targeted work, additional support, adapting resources etc.) and discussing amendments with the SEN Coordinator as necessary.</li> <li>• Writing Provision Maps, also sometimes called Individual or Group Education Plans (IEP/GEP), and reviewing these at least once each term and planning for the next term.</li> <li>• Ensuring that all members of staff working with your child in school are aware of your child's individual needs and/or conditions and what specific adjustments need to be made to enable them to be included and make</li> </ul>

		<p>progress.</p> <ul style="list-style-type: none"> <li>• Ensuring that all staff working with your child in school are supported in delivering the planned work/programme for your child, so they can achieve the best possible progress. This may involve the use of additional adults, outside specialist help and specially planned work and resources.</li> <li>• Ensuring that the school's SEND Policy is followed in their classroom and for all the pupils they teach with any SEND. 	<p><b>The SENCo (Special Educational Needs Coordinator)</b></p>	<p><b>They are responsible for:</b></p> <ul style="list-style-type: none"> <li>• Coordinating all the support for children with special educational needs (SEN) and or disabilities, and developing the school's SEND Policy to make sure all children get a consistent, high quality response to meeting their needs in school.</li> <li>• Ensuring that you are: <ul style="list-style-type: none"> <li>• involved in supporting your child's learning</li> <li>• kept informed about the support your child is getting</li> <li>• involved in reviewing how they are doing</li> </ul> </li> <li>• Liaising with all the other people who may be coming into school to help support your child's learning e.g. Speech and Language Therapy, Educational Psychology etc...</li> <li>• Updating the school's SEND register, (a system for ensuring all the special educational, physical and sensory needs of pupils in this school are known and understood) and making sure that there are excellent records of your child's progress and needs.</li> <li>• To provide specialist support for teachers and support staff in the school so they can help your child (and other pupils with SEN and/or disabilities in the school) to achieve their potential.</li> <li>• Supporting your child's class teacher to write Provision Maps that specify the targets set for your child to achieve.</li> <li>• Organising training for staff so they are aware and confident about how to meet the needs of your child and others within our school.</li> </ul> <p>Contacted by : Telephoning or visiting the school to arrange an appointment.</p>

	<p><b>Teaching Assistants (TAs) may be allocated to some pupils with SEN and or disabilities.</b></p>	<p>A Teaching Assistant (TA) may be allocated to a pupil or number of pupils with exceptional special educational needs and/or disabilities and whilst they take a very valuable role in your child's education we would prefer that questions regarding your child's learning and progress are directed to the staff members named above.</p> <p>Of course, as a school we welcome daily dialogue between parents and TAs on how a child's day has been and we do actively encourage this continued feedback!</p>
	<p><b>Headteacher</b></p>	<p><b>Mr Newton is responsible for:</b></p> <ul style="list-style-type: none"> <li>• The day to day management of all aspects of the school, this includes the support for children with SEN and/or disabilities. He will give responsibility to the class teachers but is still responsible for ensuring that your child's needs are met.</li> <li>• He must make sure that the Governing Body is kept up to date about any issues in the school relating to SEND.</li> </ul> <p>Contacted by : Telephoning or visiting school to arrange an appointment.</p>

	<b>SEND Governor</b>	<p><b>Mrs Victoria Mantle is responsible for:</b></p> <ul style="list-style-type: none"> <li>• Making sure that the school has an up to date SEND Policy</li> <li>• Making sure that the school has appropriate provision and has made necessary adaptations to meet the needs of all children in the school</li> <li>• Making sure that the necessary support is made for any child who attends the school who has SEN and/or disabilities.</li> <li>• Making visits to understand and monitor the support given to children with SEND in the school and being part of the process to ensure your child achieves his/her potential in school.</li> </ul> <p style="text-align: center;">Contacted by: Telephoning or visiting school to arrange an appointment.</p>

**B. HOW COULD MY CHILD GET HELP IN SCHOOL? :**

Children in school will get support that is specific to their individual needs. This may all be provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the ASD Outreach Team or Sensory Service ( for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language therapy (SALT) Service.

	<p><b>Specific small group work. This may be from:</i></b></p> <ul style="list-style-type: none"> <li>• <b>Local Authority central services such as the ASD Outreach Team or Sensory Service (for students with a hearing or visual need)</b></li> <li>• <b>Outside agencies such as the Speech and Language therapy (SALT) Service.</b></li> </ul>	<p>groups, referrals will be made to outside agencies to advise and support the school in enabling your child to make progress.</p> <ul style="list-style-type: none"> <li>• Before referrals are made you will be asked to discuss your child's progress and help plan possible ways forward.</li> <li>• If it is agreed that the support of an outside agency is a way forward, you will be asked to give your permission for the school to refer your child to a specialist professional e.g. a Speech and Language Therapist or Educational Psychologist. This will help the school and yourself understand your child's particular needs better.</li> <li>• The specialist professional will work with your child to understand their needs and make recommendations, which may include: <ul style="list-style-type: none"> <li>○ Making changes to the way your child is supported in class e.g. some individual support or changing some aspects of teaching to support them better</li> <li>○ Support to set targets which will include their specific professional expertise</li> <li>○ Your child's involvement in a group run by school staff under the guidance of the outside professional e.g. a social skills group</li> <li>○ A group or individual work with outside professional</li> </ul> </li> <li>• The school may suggest that your child needs some agreed individual support or group support in school. 	<p><b>Specified Individual support for your child of more than 15 hours in school.</b></p>	<ul style="list-style-type: none"> <li>• The school (or you) can request that the Local Authority carry out a statutory assessment of your child's needs. This is a legal process and you can find more details about this in the Local</li> </ul>	<p>Children whose learning needs are:</p> <ul style="list-style-type: none"> <li>• Severe, complex</li> </ul>

	<p><b><i>This is usually provided via a Statement of Special Educational Needs or an Education, Health and Care Plan (EHCP). This means your child will have been identified by the class teacher/SENCo as needing a particularly high level of individual and small group teaching (more than 15 hours a week), which cannot be provided from the resources already delegated to the school.</i></b></p> <p><b>Usually, if your child requires this high level of support they may also need specialist support in school from a professional outside the school. This may be from:</b></p> <ul style="list-style-type: none"> <li>• <b>Local Authority central services such as the ASD Outreach Team or Sensory Service ( for students with a hearing or visual need)</b></li> <li>• <b>Outside agencies such as the Speech and Language therapy (SALT) Service, Occupational therapy service, Physiotherapy and/or CAMHS</b></li> </ul>	<p>Authority (LA) based Local Offer, by contact Shropshire Council.</p> <ul style="list-style-type: none"> <li>• After the school have sent in the request to the Local Authority (with a lot of information about your child, including some from you), they will decide whether they think your child’s needs (as described in the paperwork provided), seem complex enough to need a statutory assessment. If this is the case they will ask you and all professionals involved with your child to write a report outlining your child’s needs. If they do not think your child needs this, they will ask the school to continue with the support at School Action Plus.</li> <li>• After the reports have all been sent in the Local Authority will decide if your child’s needs are severe, complex and lifelong and that they need more than 15 hours of support in school to make good progress. If this is the case they will write a Statement of Special Educational Needs or an EHC Plan. If this is not the case, they will ask the school to continue with the support at School Action Plus and also set up a meeting in school to ensure a plan is in place to ensure your child makes as much progress as possible.</li> <li>• The Statement or EHC Plan will outline the number of hours of individual/small group support your child will receive from the LA and how the support should be used and what strategies must be put in place. It will also have long and short term goals for your child.</li> <li>• The additional adult may be used to support your child with whole class learning, run individual programmes or run small groups including your child.</li> </ul>	<p>and lifelong</p> <ul style="list-style-type: none"> <li>• Need more than 15 hours of support in school</li> </ul>

<p><b>How will we support your child with identified special needs starting at school?</b></p>	<ul style="list-style-type: none"> <li>• We will invite you to visit the school with your child to have a look around and speak to staff.</li> <li>• If other professionals are involved, a team around the Child (TAC) meeting will be held to discuss your child's needs, share strategies used, and ensure provision is put in place before your child starts</li> <li>• We may suggest adaptations to the settling in period to help your child to settle more easily</li> </ul>
<p><b>How can I let the school know I am concerned about my child's progress in school?</b></p>	<ul style="list-style-type: none"> <li>• If you have concerns about your child's progress you should speak to your child's class teacher initially.</li> <li>• If you are not happy that the concerns are being managed and that your child is still not making progress you should speak to the Headteacher, who is also the school's SENCo.</li> <li>• If you are still not happy you can speak to the school SEN Governor.</li> </ul>
<p><b>How will the school let me know if they have any concerns about my child's learning in school?</b></p>	<ul style="list-style-type: none"> <li>• When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher will raise this with the SENCo.</li> <li>• We also have meetings every term between each class teacher and the Headteacher to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as expected.</li> <li>• If your child is then identified as not making progress the school will make a decision about whether to monitor this or set up an intervention group and will inform you.</li> <li>• If your child is still not making expected progress the school will discuss with you: <ul style="list-style-type: none"> <li>○ Any concerns you may have</li> <li>○ Any further interventions or referrals to outside professionals to support your child's learning</li> <li>○ How we can work together, to support your child at home and at school.</li> </ul> </li> </ul>
<p><b>How is extra support allocated to children and how do they move between the different levels?</b></p>	<ul style="list-style-type: none"> <li>• The school's SEN budget, received from Shropshire LA, includes money for supporting children with SEN.</li> <li>• The Headteacher and Governors decide on the budget for Special Educational Needs, on the basis of the needs of the children currently in the school.</li> <li>• The Headteacher and class teachers discuss all the information they have about SEN in the school, including <ul style="list-style-type: none"> <li>○ the children getting extra support already</li> <li>○ the children needing extra support</li> <li>○ the children who have been identified as not making as much progress as would be expected.</li> </ul> And decide what resources/training and support is needed. </li> <li>• All resources/training and support are reviewed regularly and changes made as needed.</li> </ul>



<p><b>Who are the other people providing services to children with SEN in this school?</b></p>	<p><b>A. Directly funded by the school</b></p>	<ul style="list-style-type: none"> <li>• Attendance/Family Liaison officer</li> <li>• Additional Speech and Language Therapy input to provide a higher level of service to the school</li> <li>• Additional Educational Psychology input to provide a higher level of service to the school</li> <li>• Learning Support Advisory Teachers who conduct initial assessments and reviews to provide expert advice about how best to meet the educational needs of your child.</li> <li>• Teaching Assistants dedicated to delivering intervention daily to pupils without Statements of SEN.</li> <li>• Speech and Language therapy intervention delivered by teaching assistants.</li> <li>• Teacher delivering 1:1 support primarily for pupils with specific learning difficulties.</li> </ul>

<p><b>What training or help is given to staff to help them support children with SEND?</b></p>	<ul style="list-style-type: none"> <li>• The SENCo's job is to support the class teacher in planning for children with SEN and provide in house training where possible and necessary.</li> <li>• The school has a school development plan, including identified training needs for all staff to improve the teaching and learning of all children including those with SEND. This may include whole school training on SEND issues or to support identified groups of learners in school, such as ASD, dyslexia etc.</li> <li>• Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with an SEND.</li> <li>• Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g. from the ASD Outreach service and Sensory service or medical /health training to support staff in implementing care plans.</li> </ul> <p>Training takes place on a regular basis. If you would like to hear about the training which is currently taking place or has taken place by the staff members in the school, please speak to the Headteacher.</p>
<p><b>How will the teaching be adapted for my child with learning needs (SEN/ and or disabilities)</b></p>	<ul style="list-style-type: none"> <li>• Class Teachers plan lessons according to the specific needs of all groups of children in their class, and will ensure and that learning tasks are adjusted in order to enable your child to access their learning as independently as possible.</li> <li>• Specially trained support staff can implement the teachers' modified/adapted planning to support the needs of your child where necessary.</li> <li>• Specific resources and strategies will be used to support your child individually and in groups.</li> <li>• Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs and increase your child's access to what is on offer.</li> </ul>
<p><b>How will we measure the progress of your child in school? And how will I know about this?</b></p>	<ul style="list-style-type: none"> <li>• Your child's progress is continually monitored by his/her class teacher.</li> <li>• His/her progress is reviewed formally every term and a National Curriculum level given in reading, writing, numeracy and science as well as progress in other areas, as appropriate, such as attendance, engagement in learning and behaviour.</li> <li>• If your child is in Year 1 and above, but is not yet at National Curriculum levels, a more sensitive assessment tool is used which shows their level in more detail and will also show smaller but significant steps of progress. The levels are called 'P levels'.</li> <li>• At the end of each key stage (i.e. at the end of year 2 and year 6) all children are required to be formally assessed using Standard Assessment Tests (SATs). This is something the government requires all schools to do and are the results that are published nationally.</li> <li>• Children at School Action and School Action Plus will be included on a class provision map, which will be reviewed every term and the plan for the next term made.</li> </ul>

	<ul style="list-style-type: none"> <li>• The progress of children with a statement of SEN/ EHC Plan is formally reviewed at an Annual Review with all adults involved with the child’s education.</li> <li>• The SENCo will also check that your child is making good progress within any individual work and in any group that they take part in.</li> <li>• A range of ways will be used to keep you informed, which may include: <ul style="list-style-type: none"> <li>○ Home/school book</li> <li>○ Letters/certificates sent home</li> <li>○ Additional meetings as required</li> <li>○ Reports</li> <li>○ Appointment parent consultation evenings</li> </ul> </li> </ul>
<p><b>What support do we have for you as a parent of child with an SEN/and or disabilities?</b></p>	<ul style="list-style-type: none"> <li>• We would like you to talk to your child’s class teacher regularly so we know what they are doing at home and we can tell you about what we are doing in school. This is to ensure that we are doing similar things to support them both at home and school and can share what is working in both places.</li> <li>• The SENCo, who is also the Headteacher, is available to meet with you to discuss your child’s progress or any concerns/worries you may have.</li> <li>• All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report. The SENCo will also arrange to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child.</li> <li>• Homework will be adjusted as needed to your child’s individual needs.</li> <li>• A home/school contact book may be used to support communication with you, when this has been agreed to be useful for you and your child.</li> <li>• You may be invited to meet and discuss strategies with outside agencies that the school has engaged the services of.</li> </ul> <p><b>In addition:</b> If you child is undergoing statutory assessment you will also be supported by the Children’s Services SEN Team. They will ensure that you fully understand the process.</p>

<p><b>How have we made this school physically accessible to children with SEND?</b></p>	<ul style="list-style-type: none"> <li>• The school is accessible to children with physical disability via ramps.</li> <li>• We ensure that equipment used is accessible to all children regardless of their needs.</li> <li>• The school has accessible hygiene facilities.</li> </ul>
<p><b>How will we support your child when they are leaving this school? OR moving on to another class?</b></p>	<p>We recognise that ‘moving on’ can be difficult for a child with SEN/and or disabilities and take steps to ensure that any transition is as smooth as possible.</p> <ul style="list-style-type: none"> <li>• If your child is moving to another school: <ul style="list-style-type: none"> <li>○ We will contact the new school’s SENCo and ensure he/she knows about any special arrangements or support that need to be made for your child.</li> <li>○ We will make sure that all records about your child are passed on as soon as possible.</li> </ul> </li> <li>• When moving classes in school: <ul style="list-style-type: none"> <li>○ Information will be passed on to the new class teacher IN ADVANCE and in most cases, a planning meeting will take place with the new teacher. All Provision Maps will be shared with the new teacher. Pupil Progress meetings will be held in July to facilitate this.</li> <li>○ If your child would be helped by a book to support them understand moving on then it will be made for them.</li> </ul> </li> <li>• In Year 6 <ul style="list-style-type: none"> <li>○ The SENCo will liaise directly with the SENCo of their secondary school, as appropriate.</li> <li>○ Your child will attend a small group in school, to support their understanding of the changes ahead. This may include creating a ‘Personal Passport’ which includes information about themselves for their new school.</li> <li>○ Where possible your child will visit their new school on several occasions and in some cases staff from the new school will visit your child in this school.</li> </ul> </li> </ul>
