### **AIMS STATEMENT**

In order to meet the general duties listed above, the law requires us to demonstrate how we meet the general duties by:

- Publishing equality information, to demonstrate compliance with the general duty across its functions
- Publishing no information that can specifically identify any individual child or adult
- Preparing and publishing equality objectives

To do this, data related to the protected characteristics above will be collected and analysed in order to determine focus for equality objectives. The data will be assessed across our core provisions as a school in order to ensure that equality is applied to the services listed below:

- Admissions
- Attendance
- Attainment
- Exclusions
- Prejudice related incidents

### **UNLAWFUL BEHAVIOUR**

The Act defines four kinds of unlawful behaviour:

- *Direct discrimination* – less favourable treatment because of a protected characteristic.
- *Indirect discrimination* – a provision, criterion or practice that is applied generally but has the effect of putting people with a particular characteristic at a disadvantage when compared to people without that characteristic.
- *Harassment* – unwanted conduct related to a relevant protected characteristic, which has the purpose or effect of violating a person's dignity or creating an intimidating, hostile, degrading, humiliating or offensive environment for that person.

- *Victimisation* – Treating a person less favourably than they otherwise would have been because of something they have done in connection with The Act.

### **Addressing Prejudice Related Incidents**

Alveston School is opposed to all forms of prejudice and recognises that children who experience any form of prejudice related discrimination may fare less well in the education system. Both pupils and staff are provided with an awareness of the impact of prejudice in order to prevent any incidents. If incidents occur they are addressed immediately. If incidents continue to occur, they will be reported to the Local Authority using their guidance material. The Local Authority may provide some support.

### **CORE STATEMENTS**

In fulfilling legal obligations, the school will be guided by seven core statements:

- 1: All learners are of equal value
- 2: Diversity is recognised, welcomed and respected
- 3: Positive attitudes and relationships are fostered, together with a shared sense of belonging
