



Pupil Premium Action Plan 2017-18

At Holtsmere End Infant and Nursery School

Our Pupil Premium aims are:

- **To raise aspirations and broaden experiences**
- **To remove barriers and labels**
- **To diminish the difference**

The level of Pupil premium for 2015-2016 is £1320 per pupil for pupils eligible for free school meals, £302 for children eligible for Early Years Pupil Premium and £300 for children with parents in the armed services.

In 2016-2017 we will continue to use Pupil Premium Funding to raise attainment and progress for our disadvantaged children and diminish the difference between them and our non-disadvantaged pupils. Alongside this, we aim to develop pupil confidence and support parents.
