### Nature of support to close gaps in performance 2016-2017

Our rationale for use of PPG is to offset the empirically proven links between deprivation and educational achievement (attainment and progress). It links directly to our school mantra of aiming for Happiness and High Standards for all. We have high expectations for all pupils whatever their backgrounds.

Our monitoring of all aspects of school life has led to a school action plan based on the acronym SWERVE.

<b>S</b>	Stamina
<b>W</b>	Writing
<b>E</b>	Explaining
<b>R</b>	Recalling
<b>V</b>	Vocabulary
<b>E</b>	Extending

Each aspect of this reflects our high expectations for and policy for closing the attainment gap for PPG pupils. Essentially we are closing the life experience gap, the vocabulary gap, the aspiration gap and the opportunity gap. In using the grant funding we may provide interventions to make up for lack of practice in core skills such as reading, learning of spellings and tables etc or we may provide life experiences which we feel will benefit PPG pupils in the longer term by extending horizons which will eventually, for example be reflected in the content of writing or the development of resilience in tackling new tasks.

Some pupils will benefit more from quality first teaching than from an intervention, others may need the focus provided by a targeted intervention. Some use of funding may just

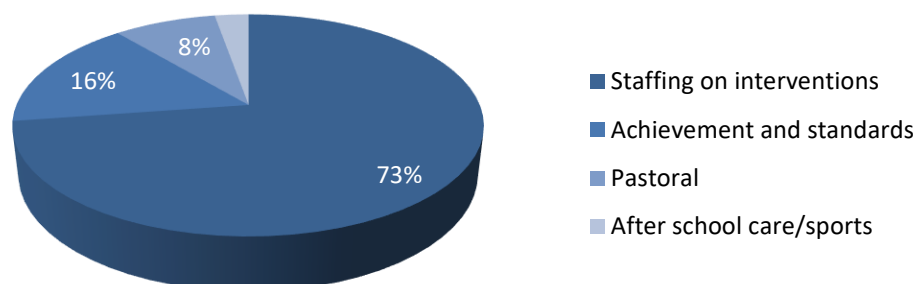
make school a more positive place e.g provision of violin lessons or payment for a school trip. We know that pupils who enjoy school perform better. Positive attitudes also improve our vital relationship with the home where we acknowledge the vital role of parents and carers as children's first teachers.

In recent years, the demographic of the school has shifted further towards deprivation as the children of a stable more affluent section of the community have left and their places were taken from the publicly owned housing estates of east Bury. Like many schools in similar areas we are finding that children come to school with far lower levels of language, social skills and life experiences and are far harder to engage as learners than had been the case prior to 2010. This is a generalisation but there is no doubt that we now serve a community within which there is a higher proportion of families for whom education is a low priority. **The Intervention Policy aims to provide a cohesive structure for "Closing the Gap".**

#### AIMS of our use of PPG

- To meet the aims of our mission statement.
- To ensure that **all** children make progress in line with their potential.
- To ensure that children are set SMART learning Intentions in order make progress.
- To ensure the efficient use of skilled and dedicated team of support staff
- To develop children's skills so that following an intervention they become independent learners.
- To ensure that interventions have high impact and that success ensures progress being maintained within the mainstream classroom.
- To develop staff skills in specialist teaching methods.
- To foster a "team" approach to child development throughout the school.
- To ensure that low levels of progress are quickly identified and strategy put in place to rectify issues.
- To ensure that parents are partners in work programmes and intervention plans.
- To measure the effectiveness of PPG in terms of finance and progress.
- To "Close the Gap".

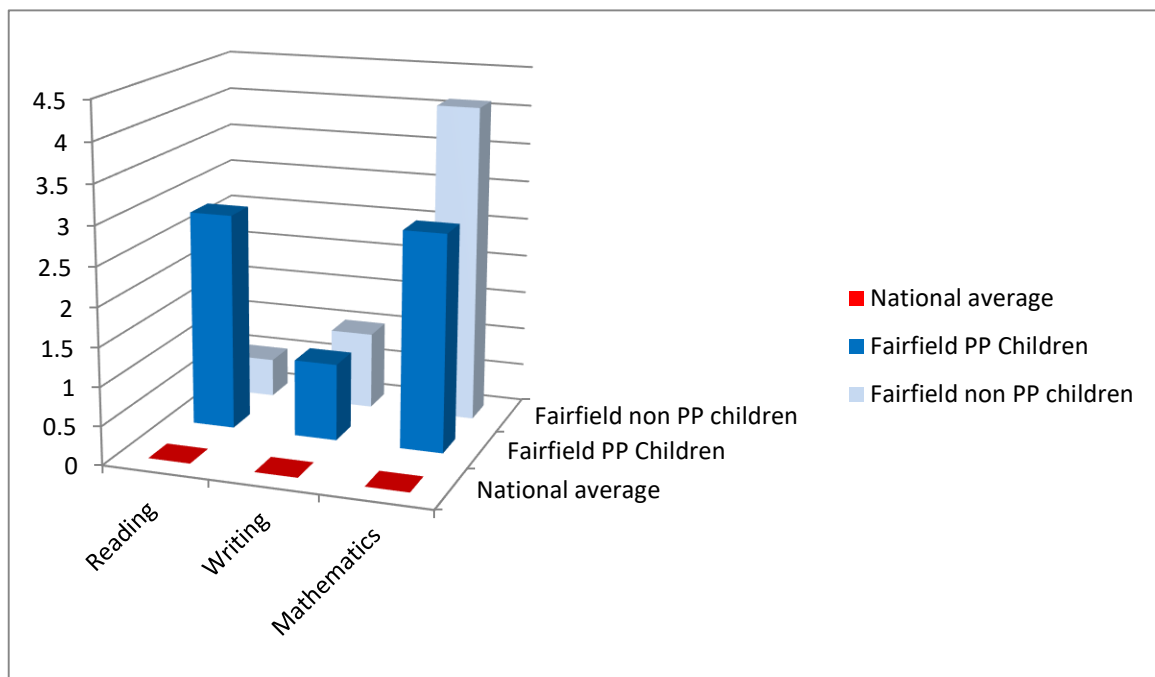
At the end of Key Stage 2 (Year 6), a progress measure of zero means that children have on average made as much progress as other children nationally who had the same Key Stage 1 attainment. A positive number means more than average progress.

The average progress (KS1-KS2) for **Pupil Premium children at Fairfield** is **above zero (more than average progress)** in all subjects.

In reading, the gap has been closed. 2.3 higher than non PPG.

In writing, the gap has been closed.

In Mathematics, the gap has been reduced to 1.3 and progress is well above national.

## Focus of PPG spending 2017-2018

The school will receive a total of £122,320 from April 2017 to March 2018. This is based on 91 children receiving £1320 (FSM ever 6), one child receiving £1900 (post LAC) and one service child receiving £300.

In 2017-2018, we are continuing to use PPG to close the life experience gap, the vocabulary gap, the aspiration gap and the opportunity gap. In using the grant funding we may provide interventions to make up for lack of practice in core skills such as reading, learning of spellings and tables etc or we may provide life experiences which we feel will benefit PPG pupils in the longer term by extending horizons.
