All 3 and 4 year old children are entitled to a free part time place of 5 session of 3 hours per week (morning or afternoon place).

From September 2017, 30 hour funded places are available if you meet the criteria below and register/apply for the funding online through a government website.

If you are not eligible for 30 hour funding then you have the option to pay for additional sessions at a cost of £15 per session /£75 per week. This charge is still payable if the child is absent due to illness.

### 30 Hours Eligibility Criteria

- Both parents are working (or the sole parent is working in a lone parent family) and each parent earns on average:
  - A weekly minimum equivalent to 16 hours at National Minimum Wage (NMW) or National Living Wage (NLW) and
  - Less than £100,000 per year.
- One/both parent/s is away on leave (paternal, maternal, adoption leave etc.)
- One/both parent/s on Statutory sick
- One parent is employed and:
  - Other parent has either: substantial caring responsibilities and/or disability.

This means that the majority of working parents will be legally entitled to 30 hours' free childcare for their 3-4 year old over 38 weeks of the year. Please note the income cap of £100,000 is per parent. So potentially a household with an income of £199,999 (just under £100,000 per parent) will still be eligible for 30 hours' free childcare. Please note that all 3-4 year olds are entitled to 15 hours of free childcare and working parents who meet the eligibility criteria are entitled to an additional 15 hours.

Our session times are 8.45am until 3.00pm. The lunch time period is not covered by the 30 hour provision so there will be a notional cost of £3 per day (£15 per week to cover this period). This figure does not cover the cost of the child's lunch. Parents may opt to provide sandwiches or purchase a school dinner for £2.30 per day/£11.50 per week. Alternatively, you may collect your child for the lunch period and then return for the afternoon session. Dinner money and fees are due on a Monday morning.
