

## **Terms and Conditions for the Money Supermarket Cashback promotion February-March 2016**

1. The 'Money Supermarket Cashback Promotion February-March 2016' is valid for new customers who open a Landbay online account and deposit a minimum of £2,500 in said account for a minimum of 12 months. Customers who adhere to the terms and conditions stated below will be eligible for receipt of £100 cashback, paid into their Landbay online account 12 months after their initial £2,500 deposit.
2. The 'Money Supermarket Cashback Promotion February-March 2016' is valid from Monday 29<sup>th</sup> February 2016 until Monday 28<sup>th</sup> March 2016.
3. To be eligible, customers must commit funds to a minimum term of 12 months by 09:00 on 28/03/2016.
