

TERMS AND CONDITIONS

VIII INTERNATIONAL SCIENTIFIC SYMPOSIUM

"Human Health and Safety in the Face of 21st Century Threats"

§1 GENERAL PROVISIONS

1. These Terms and Conditions (hereafter: "Terms") define the rights and obligations of participants of the VIII International Scientific Symposium titled "Human Health and Safety in the Face of 21st Century Threats" (hereafter: "Event").
2. The Event is organized by the Upper Silesian Academy named after Wojciech Korfanty in Katowice, located at Harcerzy Września 1939 No. 3, 40-659 Katowice, registered in the Non-Public Universities Registry under number 36, VAT ID: 954-00-07-281, REGON: 272199522, hereafter referred to as "Organizer."
3. The Event is open to all interested parties.
4. The Event will take place on May 21, 2024, at the location specified in the offer, on the Event's webpage.

§2 REGISTRATION OF PARTICIPATION

1. The anticipated number of participants is limited to 150 persons. However, the Organizer reserves the right to close registrations at a smaller or larger number, considering the current organizational capabilities.
2. Participation in the Event is free of charge.
3. Participation in the Event requires providing information in the registration form by the deadline specified in the offer, available on the Event's webpage.
4. Equivalent methods of registration include filling out the registration card and sending the signed scan to katarzyna.wytyczak@akademiagornoslaska.pl by April 30, 2024, or completing the online form.
5. The Organizer is not responsible for incorrect or false information provided by the Participant during Event registration.
6. Submitting the registration form available on the Event's website signifies acceptance of these Terms, as well as compliance with legal regulations and all other agreements made between the Participant and the Organizer.

§3 ORGANIZER'S LIABILITY

1. The Organizer is not liable in case of force majeure, which includes natural disasters, fires, floods, earthquakes, war actions, strikes, blockades, restrictions on the University's operation, or closure of the Event venue for epidemiological reasons or other epidemic-related regulations that prevent contract fulfillment, interruptions in utility supplies, or any other circumstances or causes beyond control.
2. The Organizer is not responsible for technical or organizational problems of Participants related to their participation in the Event, resulting from causes beyond its control, in particular for the functioning of internet connections on the Participant's side.
3. The views and opinions expressed by speakers are those of the authors and the Organizer is not responsible for their content or form.
4. The Organizer is not responsible for Participants' personal belongings that may be lost, damaged, or stolen during the Event.
5. Participants bear full material responsibility for any damages they cause on the premises where any Event-related activities take place.

§4 PERSONAL DATA

In accordance with Article 13 of the General Data Protection Regulation of April 27, 2016, EU Official Journal L 119 of May 4, 2016, we inform you that:

1. The Administrator of your personal data is the Upper Silesian Academy named after Wojciech Korfanty in Katowice, located at Harcerzy Września 1939 No. 3, registered in the Non-Public Universities Registry under number 36, VAT ID: 954-00-07-281, REGON: 272199522.
2. Contact with the Data Protection Officer is available, in all matters related to the processing of personal data, via email: iod@akademiagornoslaska.pl or at the University's address, marked "DPO."
3. Your personal data is necessary for registration participation in the Event, communication for organizational purposes, and documentation of its course.
4. The basis for processing personal data is:
 - a) Article 6(1)(a), i.e., consent given for data processing;
 - b) Article 6(1)(b), i.e., processing is necessary for the performance of a contract with you;
 - c) Article 6(1)(c), i.e., processing is necessary for compliance with a legal obligation to issue and store documents and invoices for services provided or commissioned by the Administrator, realization of post-sales rights, including defense against and in connection with claim pursuits, and fulfilling other legal obligations before state offices.
5. Providing personal data is voluntary but necessary for the Organization to organize the Event.

6. The personal data we collect includes name, surname, email address, phone number, billing information provided in the form.
7. Personal data will not be processed in an automated way and will not be subject to profiling.
8. The recipients of the provided personal data will be:
 - a) persons authorized by the Administrator to process data within their official duties;
 - b) entities entitled to obtain personal data under the law;
 - c) entities providing services necessary for the Event's execution, based on appropriate personal data processing agreements;
 - d) partners of the Administrator, based on appropriate personal data processing agreements.
9. Your personal data will be stored until consent is withdrawn or for the period defined by legal provisions.
10. You have the right to access your data and rectify it, delete or limit processing, and the right to object, request the cessation of processing and transfer of data, as well as the right to withdraw consent (if given) at any time.
11. You have the right to lodge a complaint with the supervisory authority, i.e., the President of the Personal Data Protection Office.
12. The Administrator informs that registration and participation in the event are equivalent to expressing conscious and voluntary consent to the processing of personal data.

§5 CONSENT FOR THE USE OF IMAGE

1. During the Event, the Organizer may conduct photo sessions and film the proceedings for the purposes of documentation, promotion, and advertising of the Organizer.
2. Participation in the Event is equivalent to giving conscious, voluntary consent for the free, unlimited in quantity, time, and territory use, processing, duplication, and multiple dissemination of the Participant's image captured in photos and recordings made during the Event without the need for their approval each time, for informational, promotional, and advertising purposes.
3. The above consent means that photos and recordings made during the Event may be placed on the Internet, including primarily on the Organizer's website and social media platforms, among others, Facebook, Instagram, etc.

§6 FINAL PROVISIONS

1. The Event is private and does not constitute a mass event within the meaning of the Act of March 23, 2009, on the safety of mass events (Journal of Laws of 2022, item 1466, as amended).
2. Any disputes arising from participation in the Event shall be settled by the court competent for the Organizer's seat.

3. In matters not regulated by these Terms, the provisions of common law apply, in particular the provisions of the Civil Code.
4. The Organizer has the right to change the provisions of the Terms. Changes come into force within 7 days from the day they are posted on the Event's webpage.
5. The provisions of these Terms are an integral part of the participation application in the Event and are equivalent to their acceptance by the Participant.
6. These Terms come into effect on the day they are posted on the Event's webpage.
