Dear Churches and Praying Friends,

It is exciting to have progress that you can see, working on people and working on buildings are much the same. People don't usually walk into a church building and comment on how strong the beam you built in the attic must be or how well the nails and screws are holding, they see the finished walls, lighting, trim work and flooring. That which is external and beautiful is meaningless and frail without the ordinary internal strength of structural materials. "For we are his workmanship created in Christ Jesus unto good works which God hath before ordained that we should walk in them." We've made a lot of progress with removing all the interior walls to make the auditorium space, repairing and painting walls at relatively little cost. Now the greater expense will come in lighting and flooring which we estimate to cost \$3,500. Any contribution to this special project would be greatly appreciated and needed as we want to begin using this space as soon as possible.

Aside from working on the building we are getting the opportunity to work on several Navajo men both in and out of the jail. Rolyynn Garcia is helping a lot on the building work and growing in faith and knowledge in God's word. Ethan Jose like many other Navajo men has great potential but has wasted so much of life on vain things, pray for him to surrender fully to the Lord. Radux is in the Ramah jail, we have been mentoring him weekly, and his family has been coming to church. Pray for a transformation in their lives and for him to continue in Christ when he is released in April.

In January Chief Soland of the Ramah Navajo Police Dept. invited me to come to the department Christmas party, where I was able to meet and talk with most of the officers and staff and pray before the meal. The department has never officially had a chaplain, but the door is now open, pray for favor and opportunity.

Several weeks ago we visited an elderly Zuni woman named Rosenda Othole unknowingly for the last time, she did say that she believed in Jesus but sadly we don't know for sure if she was saved. Her daughter Harriet trusted Christ as Savior and went to heaven 3 years ago. Her son Greg had recently committed his life to Christ. Pray as we try to bring more of their family to Jesus.

The second week of December the Zuni jail notified us that all volunteer services would be suspended until they updated their security policies. Before the services resumed the inmates were writing letters to the administration requesting to have their church services back. In January we began having only one church service a week inside the housing area, with men one week and women the next. The shift in schedule has allowed us to focus more upon discipleship with the people and has yielded time to begin an addictions deliverance ministry at the church and in the future in Zuni as well. Pray as we prepare ourselves for this new outreach and for the potential to change people's lives.

With great joy we want to announce that we are expecting a new Herndon baby which is due to be born May 30th!
