

Tax Refund Me Autorisation Terms and Conditions

I acknowledge that any refund issued by the Revenue Commissioners to my appointed agent, Tax Refund Me, on my behalf is processed as though it were being refunded directly to me. I understand that once the refund is transferred into the bank account I have nominated, I no longer have any claim over it with the Revenue Commissioners. I recognize that Tax Refund Me is acting as my agent and holds sole responsibility to me regarding any refund they receive on my behalf. I am also aware that Tax Refund Me operates as an independent entity, and that the Revenue Commissioners do not endorse any agent, including Tax Refund Me, nor do they bear responsibility for any issues I might encounter while engaging their services. I understand and consent to Tax Refund Me inputting its own bank details into my Revenue record for the length of this mandate and removing them once the mandate ends. Additionally, I am informed about and agree to the fees charged by Tax Refund Me for their services, which will be deducted from any approved refund amount by the Revenue. The remainder of this amount after fee deduction will be paid to me.

1. Legal Information and Terms of Usage

I, the undersigned, hereby declare to the Revenue Commissioners of Ireland that I authorize Tax Refund Me, TAIN 80888E, located at 93 George's Street Upper, Dún Laoghaire, Dublin, A96 V1K8, to act as my agent for all matters pertaining to the filing of my Irish income tax return. This includes the submission of claims for refunds or credits, as well as any allowances or reliefs.

I also confirm that I will retain all necessary documentary evidence of entitlement to any credits/reliefs claimed and sources of taxable income. These documents will be kept for a period of 6 years starting from the end of the tax year to which the income return and/or claim pertains. I understand that this authorization will remain in effect until the Revenue Commissioners are formally notified of its termination by either myself or Tax Refund Me

2. Authorisation for Agent to receive refunds on behalf of client .

I hereby authorize the transfer of any refund or repayment of PAYE, Income Levy, or Universal Social Charge that I am entitled to from the Revenue Commissioners directly to the following bank account, which is held by Tax Refund Me:

I commit to providing all necessary documentation to Tax Refund Me to support any claims for refunds, credits, or allowances and reliefs made to the Revenue on my behalf. I also acknowledge that I will disclose all my income sources to Tax Refund Me. I understand that Tax Refund Me is obligated to keep all documentation related to any refunds, credits, allowances, or reliefs claimed on my behalf for a period of 6 years from the end of the tax year to which the income return and/or claim pertains. Furthermore, I am aware that Tax Refund Me must provide these documents to the Revenue upon request.
