§1 GENERAL PROVISIONS

§4 PERSONAL DATA

11. You have the right to lodge a complaint with the Polish Data Protection Authority (UODO).

12. Registration and participation in the Event implies consent to data processing.

§5 IMAGE USE CONSENT

1. The Organizer may conduct photography and video recordings during the Event for documentation and promotional purposes.

2. Participation implies consent for the free, unlimited in time and territory use of the participant's image.

§6 FINAL PROVISIONS

1. The Event is a closed event and does not constitute a mass event within the meaning of the Act on the Safety of Mass Events.

2. Any disputes shall be settled by the court competent for the Organizer's registered office.

3. Matters not covered by these Regulations shall be governed by the provisions of the Civil Code and applicable law.

4. The Organizer reserves the right to amend the Regulations. Changes come into effect 7 days after publication on the Event website.

5. These Regulations form an integral part of the Event registration.

6. The Regulations are effective from the date of publication on the Event website.
