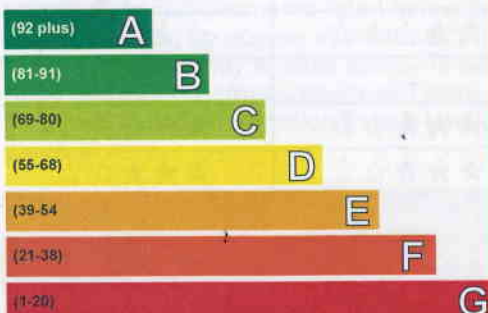

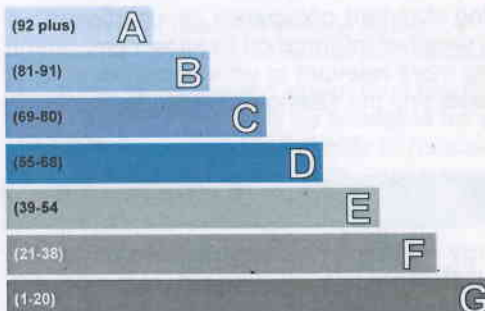
Energy Efficiency Rating
