Echiquier Agenor Mid Cap Europe is a bottom up stock-picking fund. It invests in European small and mid-cap growth stocks that are selected mainly for the quality of their Management.

Fund Manager comments

“ Echiquier Agenor Mid Cap Europe G turned in a -0.88% monthly performance and a 23.25% performance year to date.

September was a difficult month for the fund in what was an unfavourable market environment characterised by strong sector rotation from growth and quality stocks towards more cyclical assets. Our visible growth stocks, which had outperformed since the beginning of the year, were penalised. While the correction was violent, it did not cause any particular concern for the management team: the fundamentals of our companies remain solid, and the trend subsided significantly in the second half of the month. Similar episodes of sector rotation occurred in 2016 and 2018, and historically provided good opportunities to strengthen our positions. We took advantage of the decline in certain stocks to increase our positions based on the purchase signals from our weighting management tool. Our positioning remains unchanged for the end of the year: in an uncertain macroeconomic environment we will continue to favour independent growth stories that are independent of the cycle, maintaining a high liquidity level (15% to 20% of the fund) to seize opportunities on unsettled stocks.

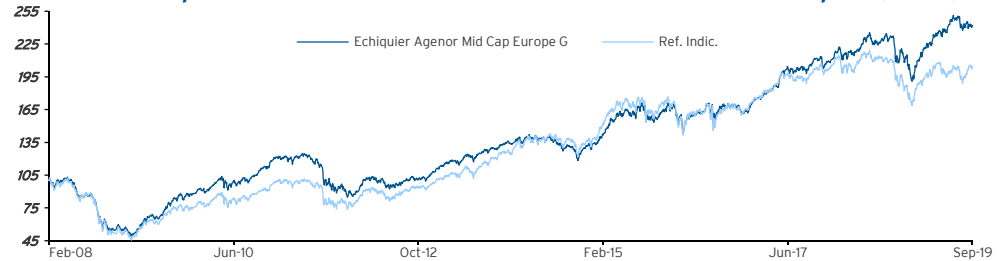

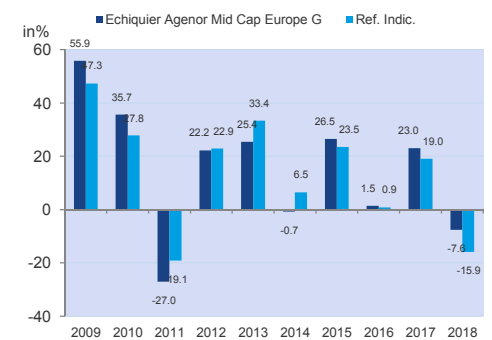

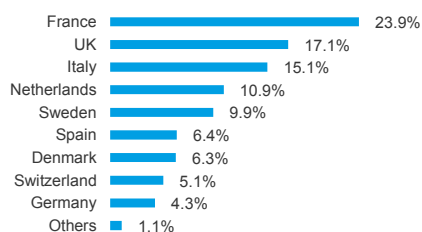

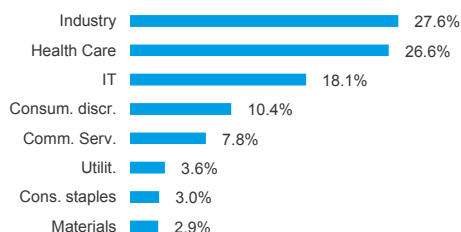

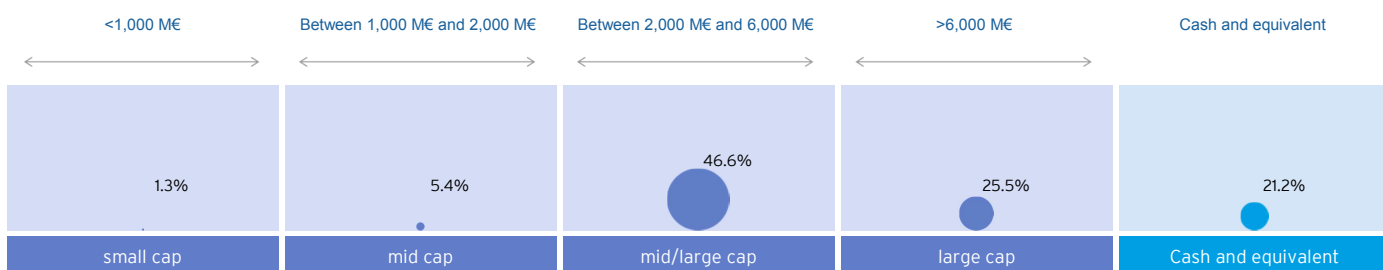
Geographic breakdown
