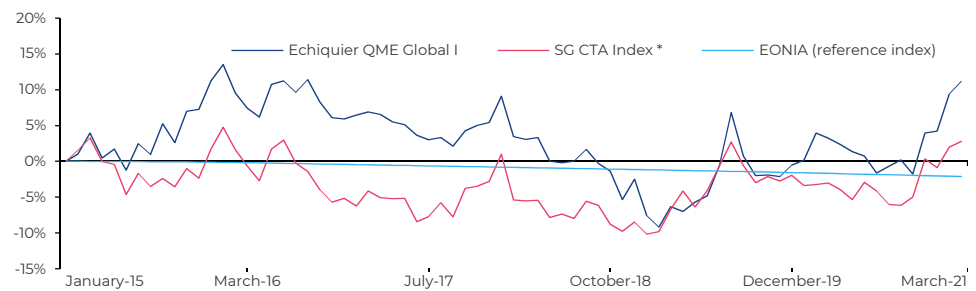

Fund Manager comments

Echiquier QME Global closed the month of March significantly up, with the fund continuing to benefit mainly from bullish positions on equity indices (+1.7%) in almost all geographical regions. The portfolio's beta remained moderately bullish in early April. Fixed income products had less impact on performance, whether government bonds (+0.2%) or short-term instruments (+0.1%). The composite signal is negative for government bonds and remains positioned for a continuation of the downward trend. The currency portfolio (-0.1%) was penalised by the strengthening of the dollar against other developed currencies, which led to a reduction in our bearish positions on the greenback during the month. Lastly, commodities (-0.1%) were almost unchanged at the end of a month marked by sharp movements in oil products and cereals.

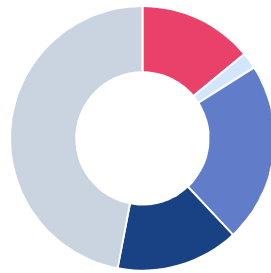
