Echiquier QME is a quantitative managed fund seeking the highest return possible over an investment horizon of three years with a limited correlation to financial market trends, and an average annual volatility below 10%.

Fund Manager comments



Echiquier QME lost 2.7% over the month and has gained +6.1% since the start of the year. Fixed income products, which had benefited from very marked trends in previous months, corrected significantly in September. Sovereign bonds (-1.5%) were most affected, but short-term rates (-0.6%) were also penalised. The equity allocation (-0.5%) saw its bearish position adversely impacted by the rebound in indices. Finally, currencies (-0.1%) ended virtually unchanged after a month without much directional movement. At the beginning of October, the portfolio's positioning remains significantly bullish on fixed income products, as the downward movement has so far had no impact on the very strong medium to long-term trends. Exposure to equities is close to zero, while the model remains bullish on the US dollar against almost all other currencies.

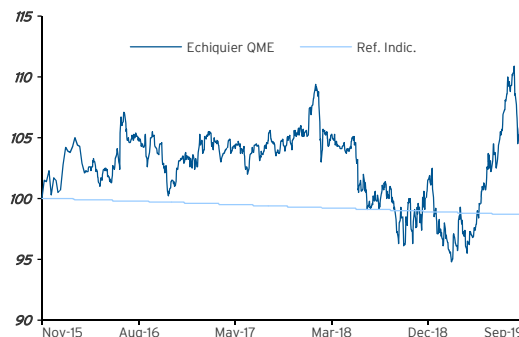
