**Fund Manager comments**

“ Echiquier Entrepreneurs G turned in a 2.10% monthly performance and a 19.71% performance year to date.

Echiquier Entrepreneurs had a good September in a market environment that was difficult for growth stocks. This was mainly due to the positive performance of two of your fund's important convictions: CAREL INDUSTRIES and VIRBAC. CAREL INDUSTRIES is an Italian company specialising in thermodynamic solutions to improve the performance of air conditioning and humidification systems. One year on from its IPO (in which we participated), CAREL continues to make promising progress despite a more challenging economic environment, with growth of +8% in the second quarter of 2019. Meanwhile, VIRBAC published excellent half-year results: the recovery of the French animal health laboratory is gathering pace in 2019 and the company's annual targets have been revised significantly upwards. We are maintaining our position in VIRBAC, initiated in March 2018. Its growth prospects are attractive and the *rerating* of the stock should continue given the excellent *momentum* and high valuations in the sector.

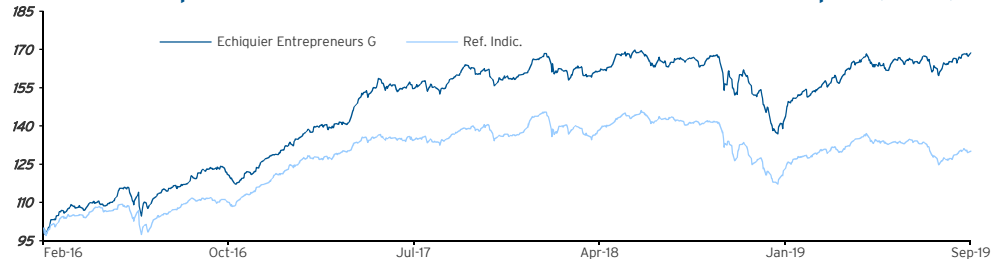

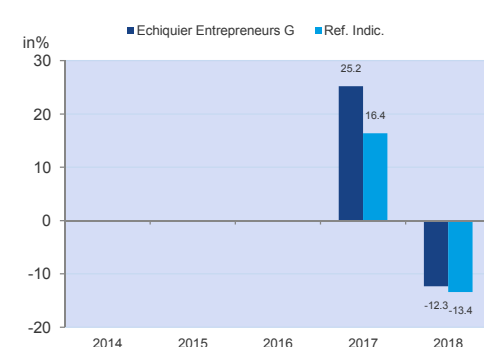

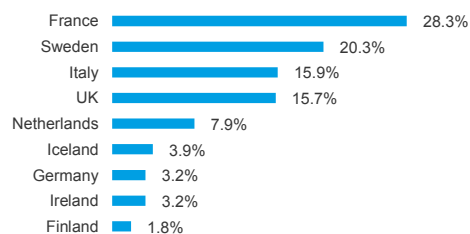

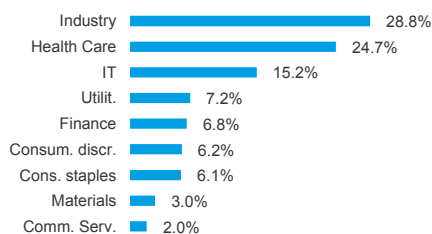

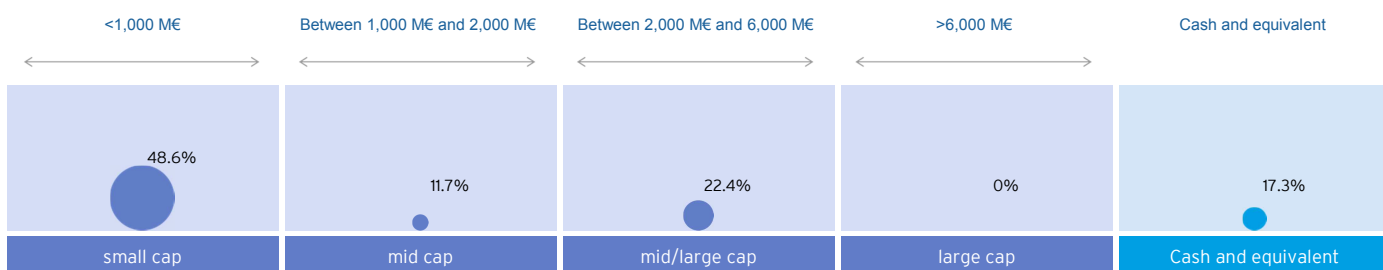
