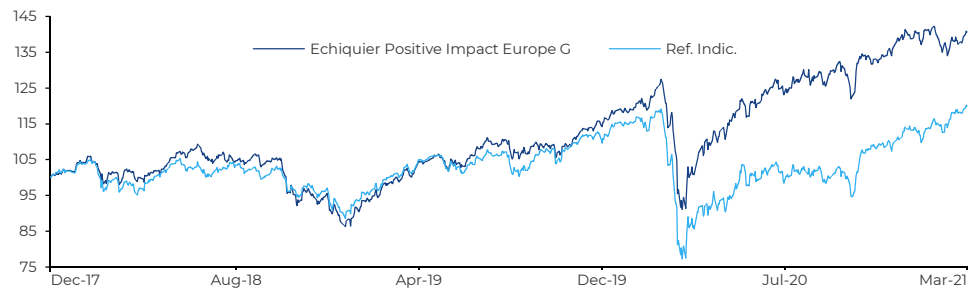
Fund Manager comments

Echiquier Positive Impact Europe G turned in a positive monthly performance of 4.16% and of 1.78% year-to-date.

The markets rose again in March, driven by the acceleration of vaccinations, the stimulus plans approved in the US and growth forecasts that continue to be revised upwards. The fund slightly underperformed its benchmark in this context, which remained favourable to cyclical and value companies. Despite the movements undertaken since last summer, these still make up a minority of the fund. ASML and RELX, stocks exposed to the cycle or the reopening of the economy, were among the top contributors, but also more defensive stocks such as AIR LIQUIDE and LEGRAND, showing that the rotation is calming down. Among the worst contributors was NEOEN, which announced a capital increase to finance the future growth of its 2025 plan. After their exceptional stock market performances, the fund sold SARTORIUS STEDIM BIOTECH and NIBE this month, which now offer fewer opportunities given their demanding valuations.

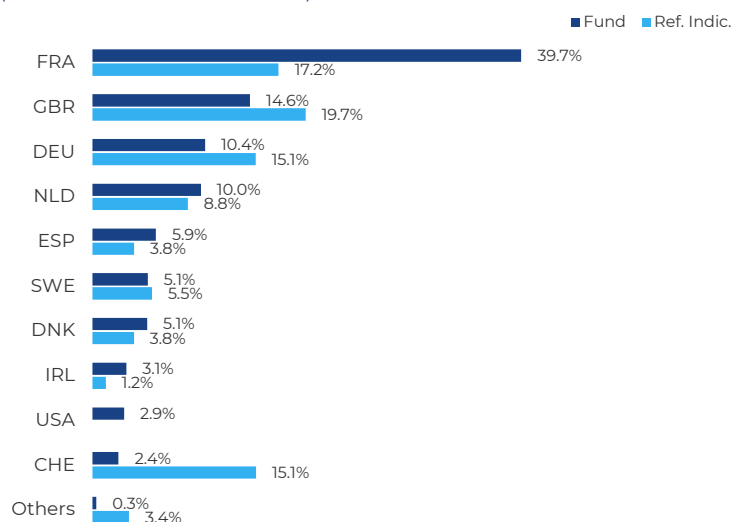

Geographic breakdown

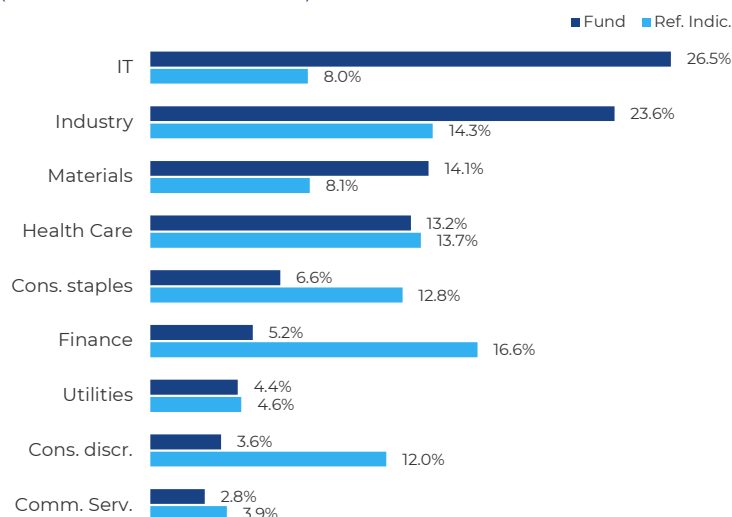
(% of the net assets without cash)

Sector breakdown (GICS)

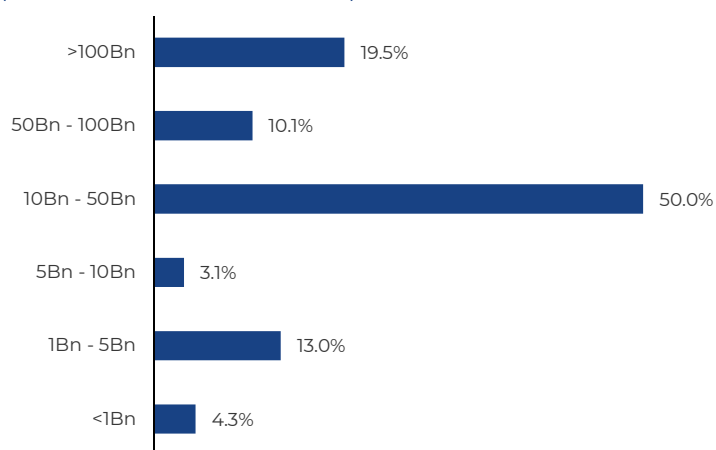

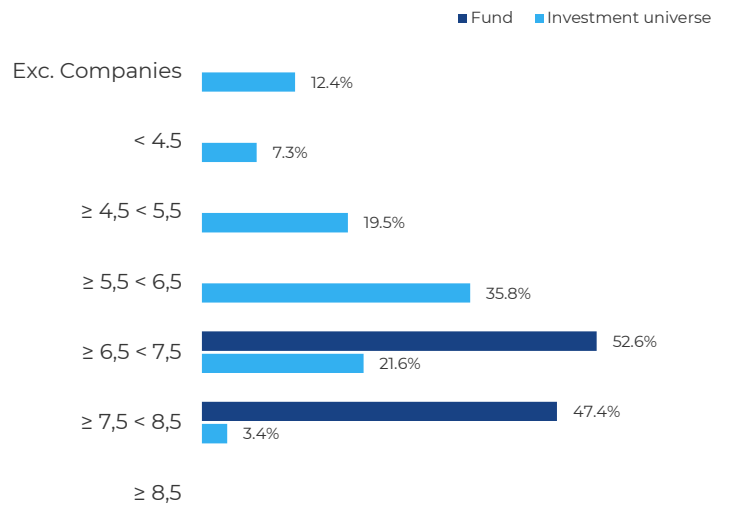

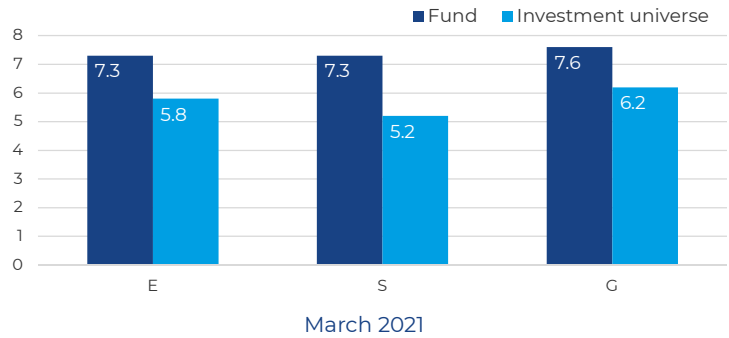
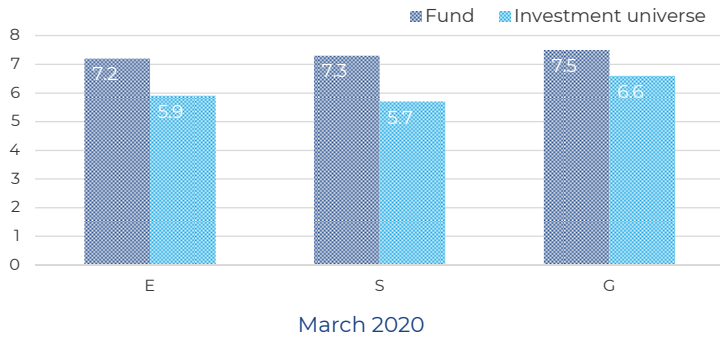

Distribution of ESG ratings of the fund and the investment universe*

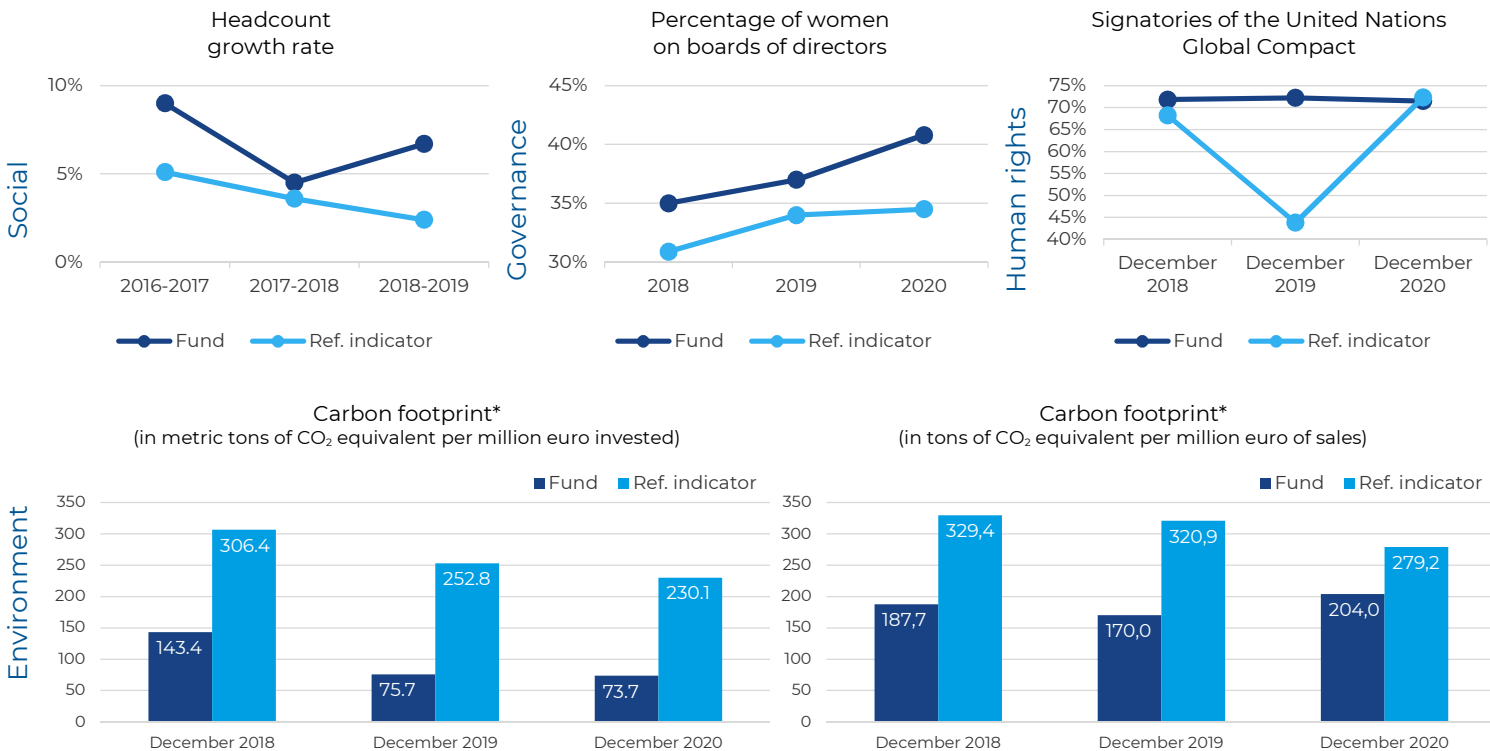


Average scores compared to the investment universe*

Comment

La Financière de l'Echiquier (LFDE) is adopting an ambitious climate strategy and adapting its climate governance. This strategy is broken down into nine commitments for clients and companies that go beyond the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD). LFDE, a pioneer in responsible investment in France, is deploying the pragmatic and transparent strategy in combination with an annual evaluation and review process in order to respond to the climate emergency. Designed in partnership with I Care & Consult, the ambitious plan includes training in climate-finance issues for LFDE's Board of Directors and Executive Committee, as well as for all of its teams, in order to integrate climate issues into its various businesses and decision-making processes. Its scope is identical to that of LFDE's approach for environmental, social and governance (ESG) integration. The strategy is available on the LFDE website under "Responsible Investment – To find out more".
