

Ensuring the quality of analytical data is a vital aspect of the work of an analytical scientist. The effective planning of experiments and evaluation of data requires an understanding of statistics. Knowledge of statistics is also needed to carry out method validation and evaluate measurement uncertainty. This course is aimed at analysts and covers the statistics most commonly applied to analytical data. Designing effective experiments principles of experimental design

Learn how to plan, execute and analyse efficient experiments

Modern analytical methods and production processes used in research and manufacturing are complex, with many different factors affecting the outcome. In order to be competitive, companies need to minimise resources expended on development and maximise process performance. Design of Experiments (DoE) enables these complex situations to be understood, reducing the cost of gaining an in-depth knowledge of the process which can be translated into competitive advantage. Whenever a measurement is made there will always be some uncertainty about the result due to unavoidable errors in the measurement process. Knowledge of the uncertainty associated with measurement results allows a judgement to be made as to whether the data are likely to be 'fit for purpose'. If comparisons of results are being made, for example when determining whether a limit has been exceeded, a meaningful interpretation of the results can only be achieved if the uncertainty is known. The evaluation of the uncertainty associated with measurement results is a requirement for testing laboratories accredited to ISO/IEC 17025. This course provides a practical approach to evaluating uncertainty in testing laboratories which is in line with the ISO principles for uncertainty estimation and current accreditation requirements. The course assumes no prior knowledge of uncertainty evaluation and includes laptop-based workshops using Excel.

Who should attend?

The course is aimed at analysts who have limited knowledge of measurement uncertainty but need to be able to evaluate the uncertainty associated with their results.

It is a requirement of the ISO/IEC 17025 laboratory accreditation standard and many other sectoral regulations and directives. Method validation should always be a planned activity. This course introduces the statistics required for interpreting validation data and provides the tools to plan and carry out effective validation studies. There is ample opportunity to practice the principles learned through laptop-based workshops using Excel.


