## The 2021 Toyota Dream Car Art Contest Entry Terms and Conditions

**Contest theme:** Your "Dream Car"

### Eligible Entrants:

This contest is open to all individuals aged 15 or under residing in the United Kingdom, Northern Ireland and the Channel Islands.

Age Categories (at time of signed entry form):

- (1) Category 1: Under 8 years old
- (2) Category 2: 8-11 years old
- (3) Category 3: 12-15 years old

### Entry period

5 October 2020 – 4 December 2020 (entries accepted no later than this date).

### Entry guidelines

Please submit you/your child's artwork according to the following guidelines:

- 1) Paper Size: A3 or A4
- 2) Artistic medium: you may use coloured pencils, markers, crayon, water paints or other similar drawing. All entries must be hand drawn. Works including, but not limited to, CG pictures made using a computer, collages, cut outs, etc. will not be accepted as entries. Any "collaborative works" completed by multiple individuals on a single piece of paper will not be accepted. All artwork must be in colour and please draw a background.
- 3) Entry Form: download the entry form from the following website: [www.toyota.co.uk/dreamcar](http://www.toyota.co.uk/dreamcar). All entries must be accompanied by a fully completed entry form. Any entry received without an entry form will not be accepted. Please fill in all the necessary items on the entry form, and securely attach it to the back of your artwork. Permission of the parent or legal guardian is necessary when entering the contest.

### Judging

Judging will be strictly conducted in two stages:

#### Stage 1

Submitted artworks will first be judged at the "UK Contest", with the top three artworks being selected from each age category.

#### Stage 2

In the World Contest, the Toyota Dream Car Art Contest judges will choose the outstanding artworks submitted from each country and select the Gold, Silver, and Bronze award winners, as well as the finalists. The results of the World Contest will be announced in June 2021 and posted on the global website for the Toyota Dream Car Art Contest: <https://www.toyota-dreamcarart.com/top/>

Grand prize winners in each category (a total of three winners) and special award winners in all categories (two winners in total) shall receive an award certificate and prize money (intended for educational purposes). The school or college by which the winners attended at the time of entry shall also receive a "Supplementary Prize" consisting of \$5,000 to each individual winner and \$10,000 to each winner's school or college.

In light of the 2020 World Contest being cancelled, the winners of the 2019-2020 national contest will also be entered into the 2021 World Contest.

### Announcement of UK Contest winners

The results of the UK Contest shall be announced in February 2021 and will be posted on [www.toyota.co.uk/dreamcar](http://www.toyota.co.uk/dreamcar).

If the winner(s) cannot be traced after reasonable efforts have been made by Toyota (GB) plc, that winner will forego the right to claim the prize and Toyota (GB) plc will arrange for a replacement winning entry to be selected.

### Prizes for UK Contest

Prizes consist of:

- Gold winners: an Apple iPad
- Silver and Bronze winners: a Samsung Tablet
- All winners will receive a Toyota goody bag

Subject to government COVID-19 guidelines, the winners will be invited to an award ceremony at Toyota (GB) plc, Burgh Heath, Surrey, on the 5<sup>th</sup> February 2021 to receive their prizes.

- Multiple submissions are allowed from the same person. However, only one prize will be awarded per person.
- Family members of employees of Toyota Motor Corporation or companies affiliated to or associated with Toyota Motor Corporation are also eligible to participate.

- We will be unable to return any of the artworks submitted for the contest.
