1. Welcome and Apologies

2. Matters Arising

Minutes accepted by Andy Wagstaff, seconded by Margaret Clarke.

3. Declarations of Interest:

Andy Wagstaff on the board of Trigolion. Item 6 Adeilad Yr Efail.

4. Planning Applications

- 21C50Q/1/LB Plas Newydd. No objections.

Planning decisions

- 21C50P/1/AD/LV New signs at Plas Newydd. Granted.

5. Letters to discuss

- **National Grid** Have put in an application to put in a new line of pylons. Need to register to comment. Shared over email today. Public meeting on 28 September, Canolfan Gaerwen.

6. Adeilad yr Efail

Reopening officially on the weekend. Meetings held for free in Tan y Capel, but have been asked whether we're returning. If so need to contribute to the costs – approx. £5 per hour. But that is the cost for general bookings. Should we fix a sum rather than be charged the usual fee?

AW – try there for the next meeting. BF – it is the community room so a responsibility to meet there and support them?

AW – also need to acknowledge that they received the biggest contribution we have ever given. But they do need to maintain the building.

MR – suggests a year to take us to the Precept time so that we can budget for using the room.

Clerk's filing cabinet. This is taking the space for a vacuum. Sarah Grawe suggested putting the filing cabinet in the toilet, or in SER's house, or Martin's. GDPR state that

papers need to be in a locked cabinet. MC – how safe is a public building? BF – if somewhere like this it needs to be behind a locked door, but it is a question. AW to have a word with them.

7. Road Safety

Agreed to look at the village and draw a report, also using Highways' report to get the full picture. MC has sent notes. MR – form a sub-committee to discuss this. Figures from Arrive Alive – very difficult to get. Also difficult to get a response from Highways.

Worth asking someone from Highways to attend a meeting? Best done after having the points first. Cllr. EJ to put pressure on them?

Joint-venture – emails, and Eric, and include Eric in discussions.

Street lamp – this has been discussed and a costing has been sent. Need to see if the money is there. BF – new development in Parc Deiniol Sant – ask the contractors there? Who would install a street lamp? Agenda next month.

8. Report of any meetings

BF – met with Steve, MacVenture. Quote for new mats, £5-6.5k, to cover all the playground.

Complaint about the mats already installed – meeting arranged to discuss this. Contractors to look at it. Report back next meeting.

9. Report from County Councillors

4th March meeting with project managers at National Grid. Not much wiser after the meeting.

Planning – the Gypsy site has been rejected, on a health and safety basis. The Council was against it.

Latest news – intention to close 17 schools on the island, under 120 children.
