2. Matters Arising

Playground Grant. Not giving 10%, but up to 70%. We have asked for 10k, but will only get 7k. This was not clear from the start. Question – do we carry on with this and try to find the extra money. Finding the additional amount could be a problem. Look at contributions and funding options. Public Works Fund.

ALL AGREED – carry on with the bid, and if it is successful then a year to find the additional funds.

Letter about the dog mess in the last meeting – this morning, there was a problem with the playground bin – had been emptied. Cans and things around. Need to look again at fencing.
