Storio'r bagiau, cyflenwi. Fyddai'r warden cŵn yn stocio? Holi'r contractwyr? Tebygol o godi am hyn. Opsiwn o wneud rhai â llaw. Rhai fel tai adar. Ond eto y broblem o gyflenwi'r rhain. 2. Matters Arising

Minutes of the last meeting accepted by Dafydd Roberts, seconded by Huw Williams.

Cllr. Roberts has met with Adam May regarding speeding. No money at Ynys Môn at the moment but looking into this. A working party in the Council – the Assembly wants all urban areas to be 20mph. Council considering how to do this. Main problem is enforcement.

Worth getting figures from Arrive Alive.

Everything sent through. No questions or enquiries.

Two small matters:

Clerk's expenses put in the wrong box.

Did not record receiving the report. This had been done, but perhaps not sent in.

ACCEPT the report. Approved. All in favour.

Playground – have got a grant of £7k, and committed to give another £3k. The next step is to decide how to spend the money. No closing date. Asked the community – a fence popular. Look at the equipment in the corner.

Arrange a meeting of the Playground Committee. Consider the Community Grant too.

6. Letters to discuss

- **Llanedwen Church** Asking for a contribution. Letter to be kept until the charitable donations are being considered.
- **Lis Pleming** Complaining about the Cemetery, and the lack of water. Decided in the past that it is too expensive to install a tap. Some clearing does need to be done – consider getting a ‘rake and cake’ team to do this.
- **Sŵ Môn Môn.** Advertising in the bus stop. Using the back. Siôn Jones Councillor in Bethel was asked: Greenwood madae a contribution to a new bus stop and got the advertising as a result. But a chance to make a profit? Annual donation. Planning? Probably needed. What if another company asked? Review it annually. Year’s contract. Rent the space, and they would be responsible for the advert and maintenance. Need to keep a close eye on it. Ensure bilingual signage.
Ymateb – angen iddyn nhw wneud ymholiadau cynllunio. Ystyried cyfraniad blynyddol os ydi hyn am weithio. Holi UnLlais hefyd ynghylch hyn.
- **Dog Bags Letter** Areas of Natural Beauty offering a dog bag dispenser. They pay 75% of the costs, and the remaining 25% divided between Ynys Môn and the Community Council. Storing the bags, refilling. Would the dog warden stock them? Ask the contractors? One option is handmade ones. Some like bird houses. Try this first? A specific area for dogs to foul? But there would need to be someone to clear up.
- **Dŵr Cymru** Discussing the cuts in water supply since 2017 on the road to Bryn Celli Ddu. A meeting between Ynys Môn and Chris Onions from Dŵr Cymru. A chance to make comments.

7. Staffing Policy Documents

Following discussions no staffing policies in place. We now have some – encouraged to accept these. ACCEPTED.

Clerk’s contract to be adapted to refer to these documents.

8. Reports of Any Meetings

Governors. Annual meeting – organising the year’s work, membership of committees, welcoming new members. General matters.

9. Report by the County Councillor

Not much has happened. Budget time again. Cuts again. Trying to defend education, and children and adult services. But the Assembly has not stated yet, so have to model the worst and the best case scenario. Finding £1m in cuts. But if more then services will be cut.
