

BASES FOR LVP CONTEST “WIN THE THREE NEW POOL-PARTY SKINS”

FANDROID ENTERTAINMENT, S.L. (hereinafter, “**FANDROID**”), company with registered offices in Avda. Diagonal, 177-183, Edificio Imagina, 08018, Barcelona and with Tax Identity Number B-64910292, registered in the Mercantile Register of Barcelona in Volume 43.090, Folio 156, Sheet B-369917, organizes the contest called “**WIN THE THREE NEW POOL-PARTY SKINS**” (hereinafter, the “**Contest**”), which will be held in accordance with the following legal bases (hereinafter, the “**Bases**”).

1.- SUBJECT OF THE CONTEST

1.1.- The objective of the Contest is to promote the #4 Qualifying Tournament of Forge of Champions that the Liga de Videojuegos Profesional (hereinafter, “**the Tournament**” and the “**LVP**”, respectively), in their website <http://www.forgeofchampions.com/> that begins on August 3rd and ends on August 16th 2018, as well as to promote the @LVPuk twitter account.

1.2.- The Contest will take place exclusively through the LVP @LVPuk Twitter account (<https://twitter.com/LVPuk>) a, for information, on the website www.lvp.es/concursos

2.- PARTICIPATION PERIOD

2.1.- The period to participate in the Contest will begin on July 31st 2018 at 18:00 hours and will end on August 5th 2018 at 20:00 hours (hereinafter, “**Participation Period**”).

2.2.- No account will be taken of any entries that may be received before or after the Contest Participation Period, even if Access to participate was available.

3.- PARTICIPATION REQUIREMENTS

3.1.- The Contest is open to all individuals, aged 16 or over, living in the European Union, who follow the LVP @LVPuk Twitter account, who are registered and play in the Tournament, and who answer the following question: “*Which Pool Party champion would be the most useful companion on a desert island and why?*”.

3.2.- Participation in the Contest is free of charge, so that no purchase of any kind of product will be necessary, nor the payment of a fee nor any other amount for participation, nor to secure the prize intended for the Contest.

3.3.- Twitter accounts created exclusively for the purpose of participating in contests and/or sweepstakes and which therefore do not have their own activity may not participate in the Contest.

3.4.- Employees at FANDROID or that collaborate in the development of the Contest, as well as their families up to the first degree, are also not eligible to participate in the Contest.

3.5.- FANDROID reserves the right to automatically cancel and expel any participant it deems to be misusing or abusing the contest, with the corresponding cancellation of their participation. It is understood as misuse, including but not limited to:

- When registering with false information or there are indications that reasonably could lead to believe that the information is false. For this purpose, participants may be required to verify their information if it is considered appropriate.
- When, in any fraudulent or artificial way, participation in the Contest is manipulated.
- When a breach of any condition of participation included in these Bases takes place.

3.6.- Each entrant may only enter the Contest once during the Contest Participation Period.

4.- CONTEST MECHANICS

4.1.- Anyone who wishes to enter the Contest must follow the LVP @LVPuk, be registered and participate in the Tournament and answer the question: *“Which Pool Party champion would be the most useful companion on a desert island and why?”*.

4.2.- Among all the participants of the Contest, a jury composed of the FANDROID and RIOT community managers (hereinafter, the **“Jury”**) will select the three (3) most original answers and the three (3) winners will each be awarded a pack of the three (3) new Pool Party skins.

4.3.- If the information provided is uncertain, incomplete or illegible, FANDROID reserves the right to invalidate said participation.

4.4.- It is the participant's own responsibility to provide, if required, a valid and active e-mail address and a telephone number through which to contact him/her.

5.- PRIZE

5.1.- The three (3) Contest winners will each be awarded a pack of the 3 new Pool Party skins.

5.2.- The prize is non-transferable and, in no case, may it be changed, altered or compensated in cash at the request of the winners, the winners (and their designated companions) being the persons who benefit from it, unless expressly authorised by FANDROID. In the event that, for any reason, the winners or, where applicable, their alternates, are unable or unwilling to accept the prize, or renounce it, FANDROID may declare it deserted (in whole or in part).

5.6.- The prize for this Contest will be subject to current legislation and other related provisions regarding taxes and fees.

6.- CHOOSING THE WINNERS AND SUBSTITUTES

6.1.- The three (3) Contest winners will be determined from among the entrants who meet all of the Contest entry requirements and answer the most original question: "*Which three champions with pool party skin would you take to a desert island to help you survive?*"

6.2.- At the end of the Contest Participation Period, three (3) winners and three (3) substitutes will be designated from among the participants, in the event that any or all of the winners renounce the prize awarded, have not been located within the period established in base 7.2 or do not comply with the requirements established in these Rules. The Jury's decision will be final and undisputable.

6.3.- In the event that any or all of the winners renounce the prize awarded, have not been located within the period established in base 7.2 or do not comply with the requirements established in these Rules, the first substitute will be used and so on until the three (3) available substitutes have been exhausted, in which case the prize will be totally or partially deserted.

7.- COMMUNICATING WINNERS AND SUBSTITUTES

7.1.- On August 8th 2018, FANDROID will publish the winners of the Contest during the streaming of the Tournament that will take place at <https://www.twitch.tv/lvpuk> and will contact them via Twitter to provide them with all the necessary information to enjoy the prize (they will be informed of their status as winners and of the documents to be submitted to benefit from the prize). FANDROID will also be able to publish the winners' names on the different social media on accounts owned by the LVP and/or FANDROID.

7.2.- Winners must indicate their acceptance or rejection of the prize at the time FANDROID contacts them via Twitter. FANDROID may also request that the winners' acceptance or resignation, as the case may be, be in writing and signed by them or, as the case may be, their alternates. If there is no reply from the winners within forty-eight (48) hours from the date on which they were notified of their status as winners, stating whether or not they accept the prize (and also providing, if necessary, their details and those of their companions), the first substitute will be contacted, and so on, until the three (3) available substitutes have been exhausted, in which case the prize will be totally or partially deserted.

7.3.- The effective delivery of the prize will be conditioned to the winners complying with the conditions specified in these Bases, and to the veracity of the information provided by them or, where applicable, by the alternates to FANDROID.

8.- FRAUDULENT PARTICIPATION

8.1.- In the event that FANDROID or any entity participating in the development of this Contest detects any anomaly or suspects that a participant is impeding the normal development of the Contest, illegally altering its registration or scores by any technical or computer procedure to falsify the results, they may unilaterally remove the registration of that participant and take any legal action they deem appropriate.

8.2.- FANDROID has provided the necessary technological support to detect any possible fraudulent, anomalous or fraudulent action that may alter the scores in order to obtain an illicit prize. Therefore, FANDROID reserves the right to remove from the register any participant and/or group that shows or is suspected of acting irregularly in the sense described above.

9.- LIABILITY DISCLAIMER

9.1.- FANDROID is not responsible for any loss, damage, delay or any other circumstance attributable to third parties that may affect postal or electronic mailings or telephone lines or Internet services that may be involved in the development of this Contest.

9.2.- In accordance with the aforementioned, FANDROID shall not be liable for any possible deficiencies or failures of the telecommunications lines, nor for the malfunctioning of the online platforms involved in this Contest, for reasons beyond FANDROID's control, as well as for the services or products provided or delivered to the winners as a result of the prize awarded. As a clarification, FANDROID shall not be liable for damages of any kind arising during the course of the Contest, unless such damages are caused by an action directly attributable to FANDROID.

9.3.- Neither Twitter, Facebook, Instagram nor any other social media involved in the celebration of this Contest, sponsor, endorse or administer in any way the present Contest or are associated with it, so they assume no responsibility in this regard. In this sense, the participants are obliged to keep the previous ones completely harmless against any claim that may arise from this Contest.

10.- DATA PROTECTION

10.1.- The personal information provided by the participants in the Contest will be incorporated into a file owned by FANDROID and will be processed to manage their participation in the Contest, select the winners and alternates and contact them for the delivery of the prize, as well as the communication, through the different social media with accounts owned by the LVP and/or FANDROID, of the personal information relating to the name and surnames of the participants and/or winners and, where appropriate, the image, photos or videos and tweets with which they may have participated in the Contest.

10.2.- The tweets published, including information, images and any content that may contain them will be kept in the profiles of FANDROID accounts, as long as the participant does not

request the withdrawal or removal of them through the tools made available for this purpose by Twitter.

10.3.- For the abovementioned purposes of processing, the participant acknowledges and consents to the transfer of the personal information referred to the other companies of the Mediapro Group to which FANDROID belongs <http://entidades.imagina-media.com/> and to Riot Games, Inc.

10.4.- FANDROID will contact the winners and, once the prize has been accepted, will request the necessary and pertinent information for the organization and delivery of the prize, and may, where appropriate, be communicated for such purposes to third parties such as courier companies, as well as to other entities involved in the management of the prize and its corresponding delivery.

10.5.- In the event that you provide FANDROID with the personal information of third parties (family members, partners, friends, etc.), by accepting these Bases, you guarantee that you have previously informed these parties of this fact and of the aspects contained in this Policy and that you have obtained their authorization to provide their information to FANDROID for the purposes indicated and that you are authorized to do so, under the same conditions and for the same purposes set forth in this document.

11.1.- For the purposes set forth in Ley Orgánica 1/1982, de 5 de May, 1982, de Protección Civil del Derecho al Honor y a la Intimidad Personal y Familiar y a la Propia Imagen, the participants authorize, without compensation for this, for everybody and for the maximum legal time allowed, FANDROID, as well as the companies that may collaborate in the performance of the Contest, to use his name and image in any advertising or advertisement made through any written or audio-visual means (including social media), as a participant or winner of the Contest, and agrees to subscribe to any documentation or authorization that may be necessary for the purposes of Article 2 of the aforementioned Law and others that may apply.

12.- ACCEPTANCE OF THE BASES

12.3.- FANDROID reserves the right to make any changes it deems necessary to these Bases at any time, including, but not limited to, the cancellation, repetition, extension, postponement or modification of the same, as well as the modification of the prize in exceptional moments. This situation will be conveniently communicated to the participants through the website www.lvp.es/concursos and through the different social media of the LVP and/or FANDROID, giving this modification the same degree of publicity as this Contest, so that all participants have access to this information.

12.4.- These Bases will be collected and made available to the public on the website www.lvp.es/concursos

13.- APPLICABLE LAW AND JURISDICTION

13.1.- These Bases are governed by Spanish law.

13.2.- The participants and FANDROID agree that any disputes that may arise in the interpretation or execution of these Bases shall be subject to the jurisdiction of the Courts and Tribunals of the city of Barcelona.
