# **Job Description**

# **Principal Purpose of Post**

Digital Media Technician is responsible to the Head of Technical Resources for technical services relating to digital media and related events in the Centre.

# **Principal Objectives**

- Provide IT support to the system and services installed in the media studio to facilitate the running
  of the digital courses, there will be opportunities to engage in network administration within a
  Microsoft and Apple Mac environment.
- The safe operation and maintenance of video, film, digital media and photography equipment and projection spaces in the department's control.
- To facilitate and support artist tutors and participants that reflects the talents, interests and interpretation skills of learners through appropriate media, techniques and skills.

# **Key Responsibilties**

- Managing and maintaining the media studio computer network (Windows and Mac), creating new course accounts, archiving old course data, troubleshooting, and installing software when required.
- To provide technical support to MAC's learning & participation activities both in the Media Studio and across MAC, liaising as appropriate with the Creative Learning Producer and Head of IT.
- To maintain Media Studio equipment and help with stock control.
- To assist, in conjunction with the Visual Arts teams, in the preparation of equipment, materials and digital content for MAC's Visual Arts activities.
- To assist as necessary and appropriate in the technical servicing of seminars, conferences and meetings within MAC.
- In liaison with MAC's Senior Cinema Coordinator/Projectionist to assist in DCP conversion for MAC's Cinema programme.
- The safe operation, maintenance and repair of digital media technical equipment and ability to recommend when external support is required.
- In conjunction with MAC's Communications Team the creation and editing of digital marketing materials. Occasionally duties will include operating Facebook Live, Podcasting and Video Blogging and preparation of venues for film and video presentations, ensuring effective operation of sound, screen and projection equipment.
- Building wide IT support as required.
- Alongside the Head of Technical Resources and Head of IT, to identify opportunities for income generation through provision of equipment and services.

### General

- To follow established safe working practices in the pursuance of duties and ensure that participants, tutors and visiting organisations adhere to mac's safety policy.
- Ensuring the careful use of mac's equipment, and securing good technical standards at all times.
- Liaise with and assist other technical departments at MAC as required.
- Cataloguing and managing loans of equipment.
- On occasions to provide liaison and technical assistance on behalf of mac to external agencies.
- Undertake any other duties which may be required from this post.
